1 AN ACT Relating to the educational publications of the state
2 historical societies; amending RCW 43.78.030; and adding a new section
3 to chapter 27.34 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 43.78.030 and 1993 c 379 s 104 are each amended to
6 read as follows:

7 The public printer shall print and bind the session laws, the
8 journals of the two houses of the legislature, all bills, resolutions,
9 documents, and other printing and binding of either the senate or
10 house, as the same may be ordered by the legislature; and such forms,
11 blanks, record books, and printing and binding of every description as
12 may be ordered by all state officers, boards, commissions, and
13 institutions, and the supreme court, and the court of appeals and
14 officers thereof, as the same may be ordered on requisition, from time
15 to time, by the proper authorities. This section shall not apply to
16 the printing of the supreme court and the court of appeals reports, to
17 the printing of bond certificates or bond offering disclosure
18 documents, to the printing of educational publications of the state
19 historical societies, or to any printing done or contracted for by

1 institutions of higher education: PROVIDED, That institutions of
2 higher education, in consultation with the public printer, develop
3 vendor selection procedures comparable to those used by the public
4 printer for contracted printing jobs. Where any institution or
5 institution of higher learning of the state is or may become equipped
6 with facilities for doing such work, it may do any printing: (1) For
7 itself, or (2) for any other state institution when such printing is
8 done as part of a course of study relative to the profession of
9 printer. Any printing and binding of whatever description as may be
10 needed by any institution or agency of the state department of social
11 and health services not at Olympia, or the supreme court or the court
12 of appeals or any officer thereof, the estimated cost of which shall
13 not exceed one thousand dollars, may be done by any private printing
14 company in the general vicinity within the state of Washington so
15 ordering, if in the judgment of the officer of the agency so ordering,
16 the saving in time and processing justifies the award to such local
17 private printing concern.

18 Beginning on July 1, 1989, and on July 1 of each succeeding odd-
19 numbered year, the dollar limit specified in this section shall be
20 adjusted as follows: The office of financial management shall
21 calculate such limit by adjusting the previous biennium's limit by an
22 appropriate federal inflationary index reflecting the rate of inflation
23 for the previous biennium. Such amounts shall be rounded to the
24 nearest fifty dollars.

25 NEW SECTION. **Sec. 2.** A new section is added to chapter 27.34 RCW
26 to read as follows:

27 The provisions of chapter 43.78 RCW shall not apply to the printing
28 of educational publications of the state historical societies.
