1 AN ACT Relating to bidding on public works; amending RCW 39.30.060;
2 and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 39.30.060 and 1993 c 378 s 1 are each amended to read
5 as follows:

6 Every invitation to bid on a contract that is expected to cost in
7 excess of one hundred thousand dollars for the construction,
8 alteration, or repair of any public building or public work of the
9 state or a state agency or municipality as defined under RCW 39.04.010,
10 an institution of higher education as defined under RCW 28B.10.016, or
11 a school district shall require each bidder to submit as part of the
12 bid, or within (~~twenty-four hours of the bid~~) one hour after the
13 published bid submittal time, the names of the subcontractors whose
14 subcontract amount is more than ten percent of the contract price with
15 whom the bidder, if awarded the contract, will subcontract for
16 performance of the categories of work designated on the list to be
17 submitted with the bid or to indicate by naming itself that a category
18 of work on the list shall not be subcontracted. Failure to name such

1 subcontractors or itself shall render the bidder's bid nonresponsive
2 and, therefore, void.

3 NEW SECTION. **Sec. 2.** This act applies prospectively only and not
4 retroactively. It applies only to invitations to bid issued on or
5 after the effective date of this act.
