1            AN ACT Relating to public contracts; adding a new section to  
2 chapter 39.04 RCW; creating a new section; and repealing RCW 43.82.015.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            NEW SECTION.    **Sec. 1.** A new section is added to chapter 39.04 RCW  
5 to read as follows:

6            Any work, construction, alteration, repair, or improvement, other  
7 than ordinary maintenance, that the state or a municipality causes to  
8 be performed by a private party through a contract to rent, lease, or  
9 purchase at least fifty percent of the project by one or more state  
10 agencies or municipalities shall comply with chapter 39.12 RCW.

11           NEW SECTION.    **Sec. 2.** Section 1 of this act shall not apply to any  
12 project for which a call for competitive bids was made before the  
13 effective date of this act.

14           NEW SECTION.    **Sec. 3.** RCW 43.82.015 and 1987 c 321 s 1 are each  
15 repealed.
