- 5 **Sec. 1.** RCW 62A.9-409 and 1987 c 189 s 6 are each amended to read 6 as follows:
- 7 In relation to Article 62A.9 RCW:
- 8 (1) The department of licensing may by rule prescribe standard
- 9 filing forms, fees, and uniform procedures for filing with, and
- 10 obtaining information from, filing officers. The director shall set
- 11 fees at a sufficient level to defray the costs of administering the
- 12 program. All receipts from fees collected under this title, except
- 13 fees for services covered under RCW 62A.9-401(1)(a), shall be
- 14 deposited, beginning July 1, 1993, to the uniform commercial code fund,
- 15 <u>hereby created in the state treasury. Moneys in the fund may be spent</u>

- 18 (2) Unless a filing officer has filed with the secretary of state

- 2 <u>her</u> for filing on and after June 12, 1967, such filing officer shall

- 7 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
