- 1 AN ACT Relating to licenses to sell liquor in motels; and adding a
- 2 new section to chapter 66.24 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 66.24 RCW 5 to read as follows:
- 6 There shall be a retailer's license to be designated as class M.
- 7 The class M license may be issued to a motel that holds no other class
- 8 of license under this title. No license may be issued to a motel
- 9 offering rooms to its guests on an hourly basis. The license
- 10 authorizes the licensee to sell, at retail, in locked honor bars,
- 11 spirits in individual bottles not to exceed fifty milliliters, beer in
- 12 individual cans or bottles not to exceed twelve ounces, and wine in
- 13 individual bottles not to exceed one hundred eighty-seven milliliters,
- 14 to registered guests of the motel for consumption in guest rooms. Each
- 15 honor bar must also contain snack foods. No more than one-half of the
- 16 quest rooms may have honor bars. The board shall charge a reasonable
- 17 fee for this license. All spirits to be sold under the license must be
- 18 purchased from the board. The licensee shall require proof of age from
- 19 the guest renting a guest room and requesting the use of an honor bar.

- 1 The guest shall also execute an affidavit verifying that no one under
- 2 twenty-one years of age shall have access to the spirits, beer, and
- 3 wine in the honor bar. "Motel" as used in this section means a
- 4 facility or place offering three or more self-contained units
- 5 designated by number, letter, or some other method of identification to
- 6 travelers and transient guests. As used in this section, "spirits,"
- 7 "beer," and "wine" have the meanings defined in RCW 66.04.010.
