1 AN ACT Relating to the department of services for the blind; and
2 amending RCW 74.18.230.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 74.18.230 and 1991 sp.s. c 13 ss 19, 116 are each
5 amended to read as follows:

6 (1) There is established in the state treasury an account known as
7 the business enterprises revolving account.

8 (2) The net proceeds from any vending machine operation in a public
9 building, other than an operation managed by a licensee, shall be made
10 payable to the business enterprises revolving fund. Net proceeds, for
11 purposes of this section, means the gross amount received less the
12 costs of the operation, including a fair minimum return to the vending
13 machine owner, which return shall not exceed a reasonable amount to be
14 determined by the department.

15 (3) All federal moneys in the business enterprises revolving
16 (~~fund~~) account shall be expended only for development and expansion
17 of locations, equipment, management services, and payments to licensees
18 in the business enterprises program.

1 (4) The business enterprises program shall be supported by the
2 business enterprises revolving ((fund)) account and by income which may
3 accrue to the department pursuant to the federal Randolph-Sheppard Act.

4 (~~(5) Vocational rehabilitation funds may be spent in connection~~
5 ~~with the business enterprises program for training persons to become~~
6 ~~licensees and for other services that are required to complete an~~
7 ~~individual written rehabilitation program.))~~
