- 9 (1) All recipients of the Washington award for excellence in

- 11 superintendent of public instruction, or their designated
- 12 representatives, at a public ceremony or ceremonies in appropriate
- 13 locations.
- 14 (2) In addition to certificates under subsection (1) of this

- 29 <u>NEW SECTION.</u> **Sec. 7.** If any provision of this act or its
- 30 application to any person or circumstance is held invalid, the
- 31 remainder of the act or the application of the provision to other
- 32 persons or circumstances is not affected.
