EFFECT: Makes the following changes to the capital budget:

- 1. Increases the Housing Assistance program by \$2 million and requires the \$2 million to be used for no interest loans for low income housing,
- 2. Increases the appropriation for the Spokane Joint Center for Higher Education to \$3,310,000,
- 3. Authorizes DSHS to enter into a financing contract for the loan to local governments for the conversion of Martin Hall to a juvenile detention facility and deletes the \$4 million appropriation in bonds for the conversion of Martin Hall,
- 4. Reduces WSU minor works appropriation by \$748,000,
- 5. Reduces EWU minor works reappropriation by \$562,000.
