

1 **SHB 2164 - H AMD 092 WITHDRAWN 2-9-96**

3 On page 2, after line 3, insert the following:

4 "NEW SECTION. **Sec. 2.** (1) By December 1, 1996, the criminal
5 justice training commission shall set the following standards and
6 requirements for implementing this act. The commission shall
7 determine the types of firearms that community corrections officers
8 shall be permitted to carry and the permissible types of
9 ammunition. The commission shall also set standards determining
10 what constitutes necessary training. In so doing, the commission
11 shall specify the nature of training that community corrections
12 officers must complete and/or the level of competency community
13 corrections officers must demonstrate in order to carry firearms
14 pursuant to section 1 of this act. This may include periodic
15 refresher training courses or competency reviews.

16 (2)(a) Prior to determining the standards and requirements in
17 subsection 1 of this section, and no later than May 1, 1996, the
18 criminal justice training commission shall convene an advisory
19 board to make recommendations for developing these standards and
20 requirements. The advisory board shall have the following members:

21 (i) Two individuals who have been certified and approved by
22 the Commission to provide firearms instruction;

23 (ii) Two individuals who are employed by the department of
24 corrections as community corrections officers; and

25 (iii) One representative from the department of corrections
26 designated by the secretary of the department of corrections.

27 (b) The recommendations of the advisory board shall be
28 delivered to the criminal justice training commission no later than
29 September 1, 1996.

30 (3) The department of corrections shall implement the policy
31 contained in this act allowing community corrections officers to

1 carry firearms no later than February 1, 1997 but not before the
2 criminal justice training commission has determined standards and
3 requirements pursuant to this section 2.

5 NEW SECTION. **Sec. 3.** This act is necessary for the immediate
6 preservation of the public peace, health or safety, or support of
7 the state government and its existing public institutions and shall
8 take effect immediately."

10 Correct the title accordingly.

EFFECT: The amendment: 1) Directs the Criminal Justice
Training Commission to determine the types of firearms and
ammunition permissible under the act. Directs the Commission
to set standards determining the training community
corrections officers must have in order to carry firearms
under the act. These standards and requirements must be
established by December 1, 1996 and must be in place before
the Department of Corrections (DOC) implements the new policy.
2) Directs the Commission to convene an advisory board to
make recommendations for developing these standards and
requirements. Specifies the types and number of members of
which the board must consist. The board must be convened by
May 1, 1996 and its recommendations must be delivered by
September 1, 1996. 3) Directs DOC to implement the new
policy no later than February 1, 1997. 4) Inserts an
emergency clause stipulating that the act shall take effect
immediately.
