- 6 "Sec. 2. RCW 41.40.270 and 1995 c 144 s 5 are each amended to read 7 as follows:
- 8 (1) Should a member die before the date of retirement the amount of 9 the accumulated contributions standing to the member's credit in the 10 employees' savings fund, less any amount identified as owing to an 11 obligee upon withdrawal of accumulated contributions pursuant to a 12 court order filed under RCW 41.50.670, at the time of death:
- 13 (a) Shall be paid to the member's estate, or such person or 14 persons, trust, or organization as the member shall have nominated by 15 written designation duly executed and filed with the department; or
- 16 (b) If there be no such designated person or persons still living at the time of the member's death, or if a member fails to file a new 17 18 beneficiary designation subsequent to marriage, remarriage, dissolution 19 of marriage, divorce, or reestablishment of membership following 20 termination by withdrawal or retirement, such 21 contributions, less any amount identified as owing to an obligee upon 22 withdrawal of accumulated contributions pursuant to a court order filed 23 under RCW 41.50.670, shall be paid to the surviving spouse as if in 24 fact such spouse had been nominated by written designation as 25 aforesaid, or if there be no such surviving spouse, then to the 26 member's legal representatives.
- 27 (2) Upon the death in service, or while on authorized leave of absence for a period not to exceed one hundred and twenty days from the 28 date of payroll separation, of any member who is qualified but has not 29 30 applied for a service retirement allowance or has completed ten years of service at the time of death, the designated beneficiary, or the 31 surviving spouse as provided in subsection (1) of this section, may 32 33 elect to waive the payment provided by subsection (1) of this section. Upon such an election, a joint and one hundred percent survivor option 34 35 under RCW 41.40.188, calculated under the retirement allowance described in RCW 41.40.185 or 41.40.190, whichever is greater, 36 37 actuarially reduced by the amount of any lump sum benefit identified as

owing to an obligee upon withdrawal of accumulated contributions 1 pursuant to a court order filed under RCW 41.50.670 shall automatically 2 be given effect as if selected for the benefit of the designated 3 4 beneficiary. If the member is not then qualified for a service retirement allowance, such benefit shall be based upon the actuarial 5 equivalent of the sum necessary to pay the accrued regular retirement 6 7 allowance commencing when the deceased member would have first 8 qualified for a service retirement allowance.

(3) Subsection (1) of this section, unless elected, shall not apply to any member who has applied for service retirement in RCW 41.40.180, as now or hereafter amended, and thereafter dies between the date of separation from service and the member's effective retirement date, where the member has selected a survivorship option under RCW 41.40.188. In those cases the beneficiary named in the member's final application for service retirement may elect to receive either a cash refund, less any amount identified as owing to an obligee upon withdrawal of accumulated contributions pursuant to a court order filed under RCW 41.50.670, or monthly payments according to the option selected by the member.

(4) For deaths occurring between July 1, 1995, and June 30, 1997, 20 if a member who: (a) Has applied for nonduty disability under RCW 21 41.40.230; (b) has submitted adequate evidence to support a disability 22 determination; and (c) has selected a retirement under RCW 41.40.188, 23 24 dies before receiving the first retirement payment, the beneficiary named in the member's final application for disability retirement may 25 elect to receive either a cash refund, less any amount identified as 26 owing to an obligee upon withdrawal of accumulated contributions 27 pursuant to a court order filed under RCW 41.50.670, or monthly 28 29 payments according to the option selected by the member."
