- 7 "NEW SECTION. Sec. 1. A new section is added to chapter 41.50 RCW 8 to read as follows:
- 9 (1) The governing body of an employer under chapter 41.32 or 41.40 10 RCW shall comply with the provisions of subsection (2) of this section 11 prior to executing a contract or collective bargaining agreement with 12 members under chapter 41.32 or 41.40 RCW which provides for:
- 13 (a) A cash out of unused annual leave in excess of two hundred 14 forty hours of such leave. "Cash out" for purposes of this subsection 15 means any payment in lieu of an accrual of annual leave or any payment 16 added to regular salary, concurrent with a reduction of annual leave;
- 17 (b) A cash out of any other form of leave;
- 18 (c) A payment for, or in lieu of, any personal expense or 19 transportation allowance;
- 20 (d) The portion of any payment that exceeds twice the regular rate 21 of pay; or
- 22 (e) Any other termination or severance payment.
- 23 (2) Any governing body entering into a contract or collective bargaining agreement that includes a compensation provision listed in 24 25 subsection (1) of this section shall do so only after public notice in compliance with the open public meetings act, chapter 42.30 RCW. 26 27 notification requirement may be accomplished as part of the approval process for adopting a contract or collective bargaining agreement in 28 29 whole, and does not require separate or additional open public 30 meetings. At the meetings, full disclosure shall be made of the nature of the proposed compensation provision, and the employer's estimate of 31 32 the excess compensation billings under RCW 41.50.150 that the employing entity would have to pay as a result of the proposed compensation 33 provision. The employer shall notify the department of its compliance 34 with this section at the time the department bills the employer under 35 36 RCW 41.40.150 for the pension impact of compensation provisions listed
