15 material through "2000" on line 35, and insert "four hundred percent of
16 the lowest rate for all age groups on January 1, 1996, through January
17 1, 1998, three hundred percent January 1, 1998, through January 1,
18 2000, and two hundred fifty percent on January 1, 2000"

19 EFFECT: The maximum allowable age related variations in health
20 insurance premiums in the individual and small employer markets for
21 hmos, health care service contractors and disability insurers is
22 reduced to 400% in 1996 and 1997, 300% from 1998 to January 1, 2000,
23 and 250% thereafter.
