5 On page 1, beginning on line 20 of the amendment, strike all of  
6 sections 2 and 3 and insert the following:

7 "NEW SECTION. **Sec. 2.** A new section is added to chapter 35.63 RCW  
8 to read as follows:

9 Every municipality, including municipalities planning under a  
10 charter, in which there is located a general aviation airport that is  
11 not served by a scheduled airline, but is operated for the benefit of  
12 the general public, whether publicly owned or privately owned public-  
13 use, shall, through its comprehensive plan and development regulations,  
14 discourage the siting of incompatible uses adjacent to such general  
15 aviation airport. Such plans and regulations may only be adopted or  
16 amended after formal consultation with: Airport owners and managers,  
17 private airport operators, general aviation pilots, ports, and the  
18 aviation division of the department of transportation.

19 Any additions or amendments to comprehensive plans or development  
20 regulations required by this section may be adopted during the normal  
21 course of land use proceedings.

22 NEW SECTION. **Sec. 3.** A new section is added to chapter 35A.63 RCW  
23 to read as follows:

24 Every city in which there is located a general aviation airport  
25 that is not served by a scheduled airline, but is operated for the  
26 benefit of the general public, whether publicly owned or privately  
27 owned public-use, shall, through its comprehensive plan and development  
28 regulations, discourage the siting of incompatible uses adjacent to  
29 such general aviation airport. Such plans and regulations may only be  
30 adopted or amended after formal consultation with: Airport owners and  
31 managers, private airport operators, general aviation pilots, ports,  
32 and the aviation division of the department of transportation.

33 Any additions or amendments to comprehensive plans or development  
34 regulations required by this section may be adopted during the normal  
35 course of land use proceedings.

1        NEW SECTION.    **Sec. 4.**    A new section is added to chapter 36.70 RCW  
2 to read as follows:

3        Every county in which there is located a general aviation airport  
4 that is not served by a scheduled airline, but is operated for the  
5 benefit of the general public, whether publicly owned or privately  
6 owned public-use, shall, through its comprehensive plan and development  
7 regulations, discourage the siting of incompatible uses adjacent to  
8 such general aviation airport. Such plans and regulations may only be  
9 adopted or amended after formal consultation with: Airport owners and  
10 managers, private airport operators, general aviation pilots, ports,  
11 and the aviation division of the department of transportation.

12        Any additions or amendments to comprehensive plans or development

15        NEW SECTION.    **Sec. 5.**    A new section is added to chapter 36.70A RCW  
16 to read as follows:

17        Every county or city in which there is located a general aviation  
18 airport that is not served by a scheduled airline, but is operated for  
19 the benefit of the general public, whether publicly owned or privately  
20 owned public-use, shall, through its comprehensive plan and development  
21 regulations, discourage the siting of incompatible uses adjacent to  
22 such general aviation airport. Such plans and regulations may only be  
23 adopted or amended after formal consultation with: Airport owners and  
24 managers, private airport operators, general aviation pilots, ports,  
25 and the aviation division of the department of transportation.

26        Any additions or amendments to comprehensive plans or development  
27 regulations required by this section may be adopted during the normal  
28 course of land use proceedings."
