- 7 "NEW SECTION. Sec. 1. A new section is added to chapter 43.43 RCW 8 to read as follows:
- 9 Any member of the retirement system who, on or after January 1,
- 10 1995, is on an unpaid leave of absence from the state patrol for the
- 11 purpose of serving as a state legislator, may elect to continue to be
- 12 a member of this retirement system. The member shall continue to
- 13 receive service credit subject to the following:
- 14 (1) The member will not receive more than one month's service 15 credit in a calendar month;
- 16 (2) Employer contributions shall be paid by the legislature;
- 17 (3) Employee contributions shall be paid by the employee;
- 18 (4) Contributions shall be based on the basic salary that the
- 19 member would have received from the state patrol had such a member not
- 20 served in the legislature;
- 21 (5) The service and compensation credit under this section shall be
- 22 granted only for periods during which the legislature is in session;
- 23 and
- 24 (6) No service credit for service as a legislator will be allowed
- 25 under this section after a member separates from employment with the
- 26 Washington state patrol.
- NEW SECTION. Sec. 2. A new section is added to chapter 28B.10 RCW
- 28 to read as follows:
- 29 (1) Any employee who is on leave of absence from an institution in
- 30 order to serve as a state legislator may elect to continue to
- 31 participate in any annuity or retirement plan authorized under RCW
- 32 28B.10.400 during the period of such leave.
- 33 (2) The institution shall pay the employee's salary attributable to
- 34 legislative service and shall pay employer contributions based on the
- 35 salary for the leave period. The state legislature shall reimburse the

- 1 institution for the salary and employer contributions covering the
- 2 leave period.
- 3 (3) "Institution" for purposes of this section shall mean any
- 4 institution or entity authorized to provide retirement benefits under
- 5 RCW 28B.10.400.
- NEW SECTION. Sec. 3. A new section is added to chapter 41.40 RCW under the subchapter heading "Plan II" to read as follows:
- 8 Notwithstanding RCW 41.40.023 and 41.40.010(9)(b), and any other
- 9 provision of law, a plan II member may elect to purchase service credit
- 10 for prior periods of employment in the department of transportation if
- 11 the employee worked at least one thousand two hundred total hours in at
- 12 least four calendar years between June 1, 1965, and September 30, 1973,
- 13 by paying the employee contributions which would have been required had
- 14 the position been an eligible position, plus interest as determined by
- 15 the department. The employee shall be responsible for providing
- 16 positive documentation of the compensation earned in the ineligible
- 17 position. A member who establishes service credit pursuant to this
- 18 section shall become a member of plan I. Upon payment by a member of
- 19 the required contributions the department shall bill the department of
- 20 transportation for the required employer contributions, plus interest
- 21 as determined by the department."
