The direct index shall be divided into ((seven)) eight 14 15 columns, and with heads to the respective columns, as follows: Date of 16 reception, grantor, grantee, nature of instrument, volume and page where recorded <u>and/or the auditor's file number</u>, remarks, description 17 18 of property, assessor's property tax parcel or account number. 19 auditor or recording officer shall correctly enter in such index every instrument concerning or affecting real estate which by law is required 20 to be recorded, the names of grantors being in alphabetical order. The 21 inverted index shall also be divided into ((seven)) eight columns, 22 23 precisely similar, except that "grantee" shall occupy the second column and "grantor" the third, the names of grantees being in alphabetical 24 The auditor or recording officer may combine the direct and 25 26 indirect indexes into a single index if it contains all the information required to be contained in the separate direct and indirect indexes 27 and the names of all grantors and grantees can be found by a person 28 searching the combined index.
