- 7 "Sec. 1. RCW 46.61.100 and 1986 c 93 s 2 are each amended to read 8 as follows:
- 9 (1) Upon all roadways of sufficient width a vehicle shall be driven 10 upon the right half of the roadway, except as follows:
- 11 (a) When overtaking and passing another vehicle proceeding in the 12 same direction under the rules governing such movement;
- 13 (b) When an obstruction exists making it necessary to drive to the 14 left of the center of the highway; provided, any person so doing shall 15 yield the right of way to all vehicles traveling in the proper 16 direction upon the unobstructed portion of the highway within such 17 distance as to constitute an immediate hazard;
- 18 (c) Upon a roadway divided into three marked lanes and providing 19 for two-way movement traffic under the rules applicable thereon; or
- 20 (d) Upon a street or highway restricted to one-way traffic.
- (2) Upon all roadways having two or more lanes for traffic moving 21 in the same direction, all vehicles shall be driven in the right-hand 22 23 lane then available for traffic, except (a) when overtaking and passing 24 another vehicle proceeding in the same direction, (b) when traveling at 25 a speed greater than the traffic flow, (c) when moving left to allow traffic to merge, or (d) when preparing for a left turn at an 26 intersection, exit, or into a private road or driveway when such left 27 turn is legally permitted. On any such roadway, a ((motor truck)) 28 29 vehicle or combination over ten thousand pounds shall be driven only in the right-hand lane except under the conditions enumerated in (a) 30 through (d) of this subsection. 31
- 32 (3) No vehicle or combination over ten thousand pounds may be 33 driven in the left-hand lane of a roadway having three or more lanes 34 for traffic moving in the same direction except when (a) preparing for 35 a left turn at an intersection, exit, or into a private road or 36 driveway when a left turn is legally permitted, or (b) directed to use

- the left lane through the use of traffic control devices. This subsection does not apply to a vehicle using a high-occupancy vehicle lane, an emergency vehicle, or a tow truck responding to a law enforcement call. A high-occupancy vehicle lane is not considered the left-hand lane of a roadway.
- (4) It is a traffic infraction to drive continuously in the left 6 lane of a multilane roadway when it impedes the flow of other traffic. 7 8 $((\frac{4}{1}))$ Upon any roadway having four or more lanes for moving 9 traffic and providing for two-way movement of traffic, a vehicle shall 10 not be driven to the left of the center line of the roadway except when authorized by official traffic control devices designating certain 11 lanes to the left side of the center of the roadway for use by traffic 12 13 not otherwise permitted to use such lanes, or except as permitted under subsection (1)(b) of this section. However, this subsection shall not 14 15 be construed as prohibiting the crossing of the center line in making

a left turn into or from an alley, private road or driveway."
