- (2) To perform this study, the department shall form an advisory 1 2 study committee with balanced representation from different segments of government and the business community. The advisory committee shall 3 4 include, but need not be limited to, two members from the house of representatives, two members from the senate, representatives of both 5 small and large businesses, representatives of cities, counties, and 6 other taxing districts, a representative of the county assessors, a 7 8 representative of the appraisal industry, a representative of the 9 department of revenue, and tax policy experts from the academic, legal, 10 and business communities.
- 11 (3) The department of revenue shall provide staff for the purpose 12 of the study.
- 13 (4) The department of revenue shall present a final report of the 14 findings of the study to the committees of the legislature that deal 15 with revenue matters no later than December 31, 1996.
