5 Strike everything after the enacting clause and insert the
6 following:

7 "NEW SECTION. **Sec. 1.** It is the intent of the legislature to
8 address higher education funding through a cooperative bipartisan
9 effort that includes the legislative and executive branches of
10 government, parents, students, educators, and concerned citizens. This
11 effort will begin in 1995, with the results providing the basis for
12 discussion during the 1996 legislative session for future decisions and
13 final legislative action in 1997.

14 The purpose of this act is to provide tuition increases for public
15 institutions of higher education as a transition measure until final
16 action is taken in 1997.

17 **Sec. 2.** RCW 28B.15.031 and 1993 sp.s. c 18 s 6 and 1993 c 379 s
18 201 are each reenacted and amended to read as follows:

19 The term "operating fees" as used in this chapter shall include the
20 fees, other than building fees, charged all students registering at the
21 state's colleges and universities but shall not include fees for short
22 courses, self-supporting degree credit programs and courses, marine
23 station work, experimental station work, correspondence or extension
24 courses, and individual instruction and student deposits or rentals,
25 disciplinary and library fines, which colleges and universities shall
26 have the right to impose, laboratory, gymnasium, health, and student
27 activity fees, or fees, charges, rentals, and other income derived from
28 any or all revenue producing lands, buildings and facilities of the
29 colleges or universities heretofore or hereafter acquired, constructed
30 or installed, including but not limited to income from rooms,
31 dormitories, dining rooms, hospitals, infirmaries, housing or student
32 activity buildings, vehicular parking facilities, land, or the
33 appurtenances thereon, or such other special fees as may be established
34 by any college or university board of trustees or regents from time to
35 time. All moneys received as operating fees at any institution of

1 higher education shall be deposited in a local account containing only
2 operating fees revenue and related interest: PROVIDED, That ~~((two))~~ a
3 minimum of three and one-half percent of operating fees shall be
4 retained by the institutions, except the technical colleges, for the
5 purposes of RCW 28B.15.820. Local operating fee accounts shall not be
6 subject to appropriation by the legislature or allotment procedures
7 under chapter 43.88 RCW.

8 **Sec. 3.** RCW 28B.15.066 and 1993 c 379 s 205 are each amended to
9 read as follows:

10 It is the intent of the legislature that:

11 In making appropriations from the state's general fund to
12 institutions of higher education, each appropriation shall conform to
13 the following:

14 (1) The appropriation shall not be reduced by the amount of
15 operating fees revenue estimated to be collected from students enrolled
16 at the state-funded enrollment level specified in the omnibus biennial
17 operating appropriations act ~~((and the estimated interest on operating
18 fees revenue, minus obligations under RCW 28B.15.820 and 43.99I.040 and
19 minus the amount of waived operating fees authorized under RCW
20 28B.15.910))~~);

21 (2) The appropriation shall not be reduced by the amount of
22 operating fees revenue collected from students enrolled above the
23 state-funded level, but within the over-enrollment limitations,
24 specified in the omnibus biennial operating appropriations act; and

25 (3) The general fund state appropriation shall not be reduced by
26 the amount of operating fees revenue collected as a result of waiving
27 less operating fees revenue than the amounts authorized under RCW
28 28B.15.910.

29 **Sec. 4.** RCW 28B.15.067 and 1992 c 231 s 4 are each amended to read
30 as follows:

31 (1) Tuition fees shall be established ~~((and adjusted annually))~~
32 under the provisions of this chapter ~~((beginning with the 1987-88
33 academic year. Such fees shall be identical, subject to other
34 provisions of this chapter, for students enrolled at either state
35 university, for students enrolled at the regional universities and The
36 Evergreen State College and for students enrolled at any community
37 college. Tuition fees shall reflect the undergraduate and graduate~~

2 ~~and the community colleges, respectively, in the amounts prescribed in~~

4 (2) Academic year tuition for full-time students at the state's
5 institutions of higher education for the 1995-96 academic year, other
6 than the summer term, shall be as provided in this subsection.

7 (a) At the University of Washington and Washington State
8 University:

9 (i) For resident undergraduate students and other resident students
10 not in graduate study programs or enrolled in programs leading to the
11 degrees of doctor of medicine, doctor of dental surgery, and doctor of
12 veterinary medicine, two thousand seven hundred sixty-four dollars;

13 (ii) For nonresident undergraduate students and other nonresident
14 students not in graduate study programs or enrolled in programs leading
15 to the degrees of doctor of medicine, doctor of dental surgery, and
16 doctor of veterinary medicine, eight thousand two hundred sixty-eight
17 dollars;

18 (iii) For resident graduate and law students not enrolled in
19 programs leading to the degrees of doctor of medicine, doctor of dental
20 surgery, and doctor of veterinary medicine, four thousand four hundred
21 ninety dollars;

22 (iv) For nonresident graduate and law students not enrolled in
23 programs leading to the degrees of doctor of medicine, doctor of dental
24 surgery, and doctor of veterinary medicine, eleven thousand six hundred
25 thirty-four dollars;

26 (v) For resident students enrolled in programs leading to the
27 degrees of doctor of medicine, doctor of dental surgery, and doctor of
28 veterinary medicine, seven thousand four hundred ninety-seven dollars;
29 and

30 (vi) For nonresident students enrolled in programs leading to the
31 degrees of doctor of medicine, doctor of dental surgery, and doctor of
32 veterinary medicine, nineteen thousand four hundred thirty-one dollars.

33 (b) At the regional universities and The Evergreen State College:

34 (i) For resident undergraduate and all other resident students not
35 in graduate study programs, two thousand forty-five dollars;

36 (ii) For nonresident undergraduate and all other nonresident
37 students not in graduate study programs, seven thousand nine hundred
38 ninety-two dollars;

1 (iii) For resident graduate students, three thousand four hundred
2 forty-three dollars; and

3 (iv) For nonresident graduate students, eleven thousand seventy-one
4 dollars.

5 (c) At the community colleges:

6 (i) For resident students, one thousand two hundred twelve dollars;
7 and

8 (ii) For nonresident students, five thousand one hundred sixty-two
9 dollars and fifty cents.

10 (3) Academic year tuition for full-time students at the state's
11 institutions of higher education beginning with the 1996-97 academic
12 year, other than the summer term, shall be as provided in this
13 subsection.

14 (a) At the University of Washington and Washington State
15 University:

16 (i) For resident undergraduate students and other resident students
17 not in graduate study programs or enrolled in programs leading to the
18 degrees of doctor of medicine, doctor of dental surgery, and doctor of
19 veterinary medicine, two thousand eight hundred seventy-five dollars;

20 (ii) For nonresident undergraduate students and other nonresident
21 students not in graduate study programs or enrolled in programs leading
22 to the degrees of doctor of medicine, doctor of dental surgery, and
23 doctor of veterinary medicine, eight thousand five hundred ninety-nine
24 dollars;

25 (iii) For resident graduate and law students not enrolled in
26 programs leading to the degrees of doctor of medicine, doctor of dental
27 surgery, and doctor of veterinary medicine, four thousand six hundred
28 sixty-nine dollars;

29 (iv) For nonresident graduate and law students not enrolled in
30 programs leading to the degrees of doctor of medicine, doctor of dental
31 surgery, and doctor of veterinary medicine, twelve thousand one hundred
32 dollars;

33 (v) For resident students enrolled in programs leading to the
34 degrees of doctor of medicine, doctor of dental surgery, and doctor of
35 veterinary medicine, seven thousand seven hundred ninety-seven dollars;
36 and

37 (vi) For nonresident students enrolled in programs leading to the
38 degrees of doctor of medicine, doctor of dental surgery, and doctor of
39 veterinary medicine, twenty thousand two hundred nine dollars.

1 (b) At the regional universities and The Evergreen State College:

2 (i) For resident undergraduate and all other resident students not
3 in graduate study programs, two thousand one hundred twenty-seven
4 dollars;

5 (ii) For nonresident undergraduate and all other nonresident
6 students not in graduate study programs, eight thousand three hundred
7 twelve dollars;

8 (iii) For resident graduate students, three thousand five hundred
9 eighty-one dollars; and

10 (iv) For nonresident graduate students, eleven thousand five
11 hundred fourteen dollars.

12 (c) At the community colleges:

13 (i) For resident students, one thousand two hundred sixty-one
14 dollars; and

15 (ii) For nonresident students, five thousand three hundred sixty-
16 nine dollars and fifty cents.

17 (4) The tuition fees established under this chapter shall not apply
18 to high school students enrolling in community colleges under RCW
19 28A.600.300 through 28A.600.395.

20 NEW SECTION. Sec. 5. A new section is added to chapter 28B.15 RCW
21 to read as follows:

22 (1) As used in this section, each of the following subsections is
23 a separate tuition category:

24 (a) Resident undergraduate students and all other resident students
25 not in first professional, graduate, or law programs;

26 (b) Nonresident undergraduate students and all other nonresident
27 students not in graduate or law programs;

28 (c) Resident graduate and law students;

29 (d) Nonresident graduate and law students;

30 (e) Resident first professional students; and

31 (f) Nonresident students in first professional programs.

32 (2) Unless the context clearly requires otherwise, as used in this
33 section "first professional programs" means programs leading to one of
34 the following degrees: Doctor of medicine, doctor of dental surgery,
35 or doctor of veterinary medicine.

36 (3) For the 1995-96 and 1996-97 academic years, the building fee
37 for each academic year shall be a percentage of total tuition fees.
38 This percentage shall be calculated by the higher education

1 coordinating board and be based on the actual percentage the building
2 fee is of total tuition for each tuition category in the 1994-95
3 academic year, rounded up to the nearest half percent.

4 (4) The governing boards of each institution of higher education,
5 except for the technical colleges, shall charge to and collect from
6 each student a services and activities fee. A governing board may
7 increase the existing fee annually, consistent with budgeting
8 procedures set forth in RCW 28B.15.045, by a percentage not to exceed
9 the annual percentage increase in student tuition fees for the
10 applicable tuition category: PROVIDED, That such percentage increase
11 shall not apply to that portion of the services and activities fee
12 previously committed to the repayment of bonded debt. The services and
13 activities fee committee provided for in RCW 28B.15.045 may initiate a
14 request to the governing board for a fee increase.

15 (5) Tuition and services and activities fees consistent with
16 subsection (4) of this section shall be set by the state board for
17 community and technical colleges for community college summer school
18 students unless the community college charges fees in accordance with
19 RCW 28B.15.515.

20 (6) Subject to the limitations of RCW 28B.15.910, each governing
21 board of a community college may charge such fees for ungraded courses,
22 noncredit courses, community services courses, and self-supporting
23 courses as it, in its discretion, may determine, consistent with the
24 rules of the state board for community and technical colleges.

25 **Sec. 6.** RCW 28B.15.076 and 1989 c 245 s 4 are each amended to read
26 as follows:

27 The higher education coordinating board shall determine and
28 transmit amounts constituting approved undergraduate and graduate
29 educational costs to the several boards of regents and trustees of the
30 state institutions of higher education by November 10 of each even-
31 numbered year except the year 1990 for which the transmittal shall be
32 made by December 17. (~~Tuition fees shall be based on such costs in~~
33 ~~accordance with the provisions of this chapter.~~)

34 **Sec. 7.** RCW 28B.15.070 and 1992 c 231 s 5 are each amended to read
35 as follows:

36 (1) The higher education coordinating board, in consultation with
37 the house of representatives and senate committees responsible for

1 higher education, the respective fiscal committees of the house of
2 representatives and senate, the office of financial management, and the
3 state institutions of higher education, shall develop by December of
4 every fourth year beginning in 1989, definitions, criteria, and
5 procedures for determining the undergraduate and graduate educational
6 costs for the state universities, regional universities, and community
7 colleges (~~upon which tuition fees will be based~~)).

8 (2) Every four years, the state institutions of higher education in
9 cooperation with the higher education coordinating board shall perform
10 an educational cost study pursuant to subsection (1) of this section.
11 The study shall be conducted based on every fourth academic year
12 beginning with 1989-90. Institutions shall complete the studies within
13 one year of the end of the study year and report the results to the
14 higher education coordinating board for consolidation, review, and
15 distribution.

16 (3) In order to conduct the study required by subsection (2) of
17 this section, the higher education coordinating board, in cooperation
18 with the institutions of higher education, shall develop a methodology
19 that requires the collection of comparable educational cost data, which
20 utilizes a faculty activity analysis or similar instrument.

21 **Sec. 8.** RCW 28B.15.100 and 1993 sp.s. c 18 s 7 are each amended to
22 read as follows:

23 (1) The governing boards of the state universities, the regional
24 universities, The Evergreen State College, and the community colleges
25 shall charge to and collect from each of the students registering at
26 the particular institution for any quarter or semester such tuition
27 fees and services and activities fees, and other fees as such board
28 shall in its discretion determine. The total of all fees shall be
29 rounded to the nearest whole dollar amount: PROVIDED, That such
30 tuition fees for other than the summer term shall be in the amounts for
31 the respective institutions as otherwise set forth in (~~this chapter~~)
32 RCW 28B.15.067.

33 (2) Part-time students shall be charged tuition and services and
34 activities fees proportionate to full-time student rates established
35 for residents and nonresidents: PROVIDED, That students registered for
36 fewer than two credit hours shall be charged tuition and services and
37 activities fees at the rate established for two credit hours: PROVIDED
38 FURTHER, That, subject to the limitations of RCW 28B.15.910, residents

1 of Idaho or Oregon who are enrolled in community college district
2 number twenty for six or fewer credits during any quarter or semester
3 may be exempted from payment of all or a portion of the nonresident
4 tuition fees differential upon a declaration by the higher education
5 coordinating board that it finds Washington residents from the
6 community college district are afforded substantially equivalent
7 treatment by such other states.

8 (3) Full-time students registered for more than eighteen credit
9 hours shall be charged an additional operating fee for each credit hour
10 in excess of eighteen hours at the applicable established per credit
11 hour tuition fee rate for part-time students: PROVIDED, That, subject
12 to the limitations of RCW 28B.15.910, the governing boards of the state
13 universities and the community colleges may exempt all or a portion of
14 the additional charge, for students who are registered exclusively in
15 first professional programs in medicine, dental medicine, veterinary
16 medicine, or law, or who are registered exclusively in required courses
17 in vocational preparatory programs.

18 **Sec. 9.** RCW 28B.15.740 and 1993 sp.s. c 18 s 28 are each amended
19 to read as follows:

20 (1) Subject to the limitations of RCW 28B.15.910, the governing
21 boards of the state universities, the regional universities, The
22 Evergreen State College, and the community colleges may waive all or a
23 portion of tuition and fees (~~subject to the following restrictions:~~

24 ~~(1) Except as provided in subsection (2) of this section, the total~~
25 ~~dollar amount of tuition and fee waivers awarded by the governing~~
26 ~~boards shall not exceed four percent, except for the community colleges~~
27 ~~considered as a whole, such amount shall not exceed three percent of an~~

2 of the governing boards, except on the basis of participation in
3 intercollegiate athletic programs~~((:—PROVIDED FURTHER, That the~~
4 ~~waivers for undergraduate and graduate students of foreign nations~~
5 ~~under RCW 28B.15.556 are not subject to the limitation under this~~
6 ~~section))~~, not to exceed three-fourths of one percent of gross
7 authorized operating fees revenue under RCW 28B.15.910 for the
8 community colleges considered as a whole and not to exceed one percent
9 of gross authorized operating fees revenue for the other institutions
10 of higher education.

11 (2) In addition to the tuition and fee waivers provided in
12 subsection (1) of this section and subject to the provisions of RCW
13 28B.15.455 ~~((and))~~, 28B.15.460, and 28B.15.910, a total dollar amount
14 of tuition and fee waivers awarded by any state university, regional
15 university, or state college under this chapter, not to exceed one
16 percent, as calculated in subsection (1) of this section, may be used
17 for the purpose of achieving or maintaining gender equity in
18 intercollegiate athletic programs. At any institution that has an
19 underrepresented gender class in intercollegiate athletics, any such
20 waivers shall be awarded:

21 (a) First, to members of the underrepresented gender class who
22 participate in intercollegiate athletics, where such waivers result in
23 saved or displaced money that can be used for athletic programs for the
24 underrepresented gender class. Such saved or displaced money shall be
25 used for programs for the underrepresented gender class; and

26 (b) Second, (i) to nonmembers of the underrepresented gender class
27 who participate in intercollegiate athletics, where such waivers result
28 in saved or displaced money that can be used for athletic programs for
29 members of the underrepresented gender class. Such saved or displaced
30 money shall be used for programs for the underrepresented gender class;
31 or (ii) to members of the underrepresented gender class who participate
32 in intercollegiate athletics, where such waivers do not result in any
33 saved or displaced money that can be used for athletic programs for
34 members of the underrepresented gender class.

35 **Sec. 10.** RCW 28B.15.820 and 1993 c 385 s 1 and 1993 c 173 s 1 are
36 each reenacted and amended to read as follows:

37 (1) Each institution of higher education, ~~((except))~~ including
38 technical colleges, shall deposit ~~((two))~~ a minimum of three and one-

1 half percent of revenues collected from tuition and services and
2 activities fees in an institutional financial aid fund that is hereby
3 created and which shall be held locally. Moneys in the fund shall be
4 used only for the following purposes: (a) To make guaranteed long-term
5 loans to eligible students as provided in subsections (3) through (8)
6 of this section; (b) to make short-term loans as provided in subsection
7 (9) of this section; or (c) to provide financial aid to needy students
8 as provided in subsection (10) of this section.

9 (2) An "eligible student" for the purposes of subsections (3)
10 through (8) and (10) of this section is a student registered for at
11 least six credit hours or the equivalent, who is eligible for resident
12 tuition and fee rates as defined in RCW 28B.15.012 through 28B.15.013,
13 and who is a "needy student" as defined in RCW 28B.10.802.

14 (3) The amount of the guaranteed long-term loans made under this
15 section shall not exceed the demonstrated financial need of the
16 student. Each institution shall establish loan terms and conditions
17 which shall be consistent with the terms of the guaranteed loan program
18 established by 20 U.S. Code Section 1071 et seq., as now or hereafter
19 amended. All loans made shall be guaranteed by the Washington student
20 loan guaranty association or its successor agency. Institutions are
21 hereby granted full authority to operate as an eligible lender under
22 the guaranteed loan program.

23 (4) Before approving a guaranteed long-term loan, each institution
24 shall analyze the ability of the student to repay the loan based on
25 factors which include, but are not limited to, the student's
26 accumulated total education loan burdens and the employment
27 opportunities and average starting salary characteristics of the
28 student's chosen fields of study. The institution shall counsel the
29 student on the advisability of acquiring additional debt, and on the
30 availability of other forms of financial aid.

31 (5) Each institution is responsible for collection of guaranteed
32 long-term loans made under this section and shall exercise due
33 diligence in such collection, maintaining all necessary records to
34 insure that maximum repayments are made. Institutions shall cooperate
35 with other lenders and the Washington student loan guaranty
36 association, or its successor agency, in the coordinated collection of
37 guaranteed loans, and shall assure that the guarantability of the loans
38 is not violated. Collection and servicing of guaranteed long-term
39 loans under this section shall be performed by entities approved for

1 such servicing by the Washington student loan guaranty association or
2 its successor agency: PROVIDED, That institutions be permitted to
3 perform such servicing if specifically recognized to do so by the
4 Washington student loan guaranty association or its successor agency.
5 Collection and servicing of guaranteed long-term loans made by
6 community colleges under subsection (1) of this section shall be
7 coordinated by the state board for community and technical colleges and
8 shall be conducted under procedures adopted by the state board.

9 (6) Receipts from payment of interest or principal or any other
10 subsidies to which institutions as lenders are entitled, that are paid
11 by or on behalf of borrowers of funds under subsections (3) through (8)
12 of this section, shall be deposited in each institution's financial aid
13 fund and shall be used to cover the costs of making the guaranteed
14 long-term loans under this section and maintaining necessary records
15 and making collections under subsection (5) of this section: PROVIDED,
16 That such costs shall not exceed five percent of aggregate outstanding
17 loan principal. Institutions shall maintain accurate records of such
18 costs, and all receipts beyond those necessary to pay such costs, shall
19 be deposited in the institution's financial aid fund.

20 (7) The governing boards of the state universities, the regional
21 universities, and The Evergreen State College, and the state board for
22 community and technical colleges, on behalf of the community colleges
23 and technical colleges, shall each adopt necessary rules and
24 regulations to implement this section.

25 (8) First priority for any guaranteed long-term loans made under
26 this section shall be directed toward students who would not normally
27 have access to educational loans from private financial institutions in
28 Washington state, and maximum use shall be made of secondary markets in
29 the support of loan consolidation.

30 (9) Short-term loans, not to exceed one year, may be made from the
31 institutional financial aid fund to students enrolled in the
32 institution. No such loan shall be made to any student who is known by
33 the institution to be in default or delinquent in the payment of any
34 outstanding student loan. A short-term loan may be made only if the
35 institution has ample evidence that the student has the capability of
36 repaying the loan within the time frame specified by the institution
37 for repayment.

38 (10) Any moneys deposited in the institutional financial aid fund
39 that are not used in making long-term or short-term loans may be used

1 by the institution for locally-administered financial aid programs for
2 needy students, such as need-based institutional employment programs or
3 need-based tuition and fee scholarship or grant programs. These funds
4 shall be used in addition to and not to replace institutional funds
5 that would otherwise support these locally-administered financial aid
6 programs. First priority in the use of these funds shall be given to
7 needy students who have accumulated excessive educational loan burdens.
8 An excessive educational loan burden is a burden that will be difficult
9 to repay given employment opportunities and average starting salaries
10 in the student's chosen fields of study. Second priority in the use of
11 these funds shall be given to needy single parents, to assist these
12 students with their educational expenses, including expenses associated
13 with child care and transportation.

14 **Sec. 11.** RCW 28B.50.095 and 1991 c 238 s 36 are each amended to
15 read as follows:

16 In addition to other powers and duties, the college board may issue
17 rules and regulations permitting a student to register at more than one
18 community and technical college, provided that such student shall pay
19 tuition and fees as if the student were registered at a single college,
20 but not to exceed tuition and fees charged a full-time student as
21 established (~~by RCW 28B.15.502~~) under chapter 28B.15 RCW.

22 **Sec. 12.** RCW 28B.80.360 and 1990 c 33 s 561 are each amended to
23 read as follows:

24 The board shall perform the following administrative
25 responsibilities:

26 (1) Administer the programs set forth in the following statutes:
27 RCW 28A.600.100 through 28A.600.150 (Washington scholars); chapter
28 28B.04 RCW (displaced homemakers); chapter 28B.85 RCW (degree-granting
29 institutions); RCW 28B.10.210 through 28B.10.220 (blind students
