- 2 (a) A project that involves less than ten miles of streamreach, in 3 which less than twenty-five cubic yards of sand, gravel, or soil is 4 removed, imported, disturbed, or discharged, and in which no existing 5 vegetation is removed except as minimally necessary to facilitate 6 additional plantings;
- 7 (b) A project for the restoration of an eroded or unstable stream 8 bank that employs the principles of bioengineering, including limited 9 use of rock as a stabilization only at the toe of the bank, and with 10 primary emphasis on using native vegetation to control the erosive 11 forces of flowing water; or
- (c) A project primarily designed to improve fish and wildlife habitat, remove or reduce impediments to migration of fish, or enhance the fishery resource available for use by all of the citizens of the state, provided that any structure other than a bridge or culvert or instream habitat enhancement structure associated with the project is less than two hundred square feet in floor area and is located above the ordinary high water mark of the stream.

By January 1, 1996, the Washington conservation commission shall develop, in consultation with other state 20 agencies, tribes, and local governments, a consolidated application 21 22 process for permits for a watershed restoration project to be obtained 23 by a sponsoring agency for a project developed by the agency or 24 sponsored by the agency on behalf of a volunteer organization. 25 consolidated process shall include a single permit application form for use by all responsible state and local agencies. The commission shall 26 encourage use of the consolidated permit application process by any 27 28 federal agency responsible for issuance of related permits.
