4 On page 6, after line 2, insert the following:

5 NEW SECTION. **Sec. 17.** A new section is added to chapter 82.08  
6 RCW to read as follows:

7 The tax levied by RCW 82.08.020 shall not apply to charges made for  
8 labor and services rendered in respect to repairing residential  
9 buildings damaged by flooding or constructing new residential buildings  
10 to replace residential buildings destroyed by flooding, if the  
11 buildings are located in a county that the governor has declared after  
12 June 30, 1995, to be in a disaster area as a result of flooding, or to  
13 sales of tangible personal property which becomes an ingredient or  
14 component of such residential buildings during the course of such  
15 repair or construction, but only if the buyer provides the seller with  
16 an exemption certificate in a form and manner prescribed by the  
17 department by rule.

18 NEW SECTION. **Sec. 18.** A new section is added to chapter 82.08 RCW  
19 to read as follows:

20 The tax levied by RCW 82.08.020 shall not apply to sales of  
21 tangible personal property to a resident of a county that the governor  
22 has declared after June 30, 1995, to be in a disaster area as a result  
23 of flooding, if the property replaces household goods, personal  
24 effects, or private automobiles, lost or destroyed in the flooding, but  
25 only if the buyer provides the seller with an exemption certificate in  
26 a form and manner prescribed by the department by rule.

27 NEW SECTION. **Sec. 19.** A new section is added to chapter 82.12 RCW  
28 to read as follows:

29 The provisions of this chapter shall not apply in respect to the  
30 use of tangible personal property which becomes an ingredient or  
31 component of residential buildings during the course of repairing  
32 residential buildings damaged by flooding or constructing new  
33 residential buildings to replace residential buildings destroyed by  
34 flooding, if the buildings are located in a county that the governor

1 has declared after June 30, 1995, to be in a disaster area as a result  
2 of flooding.

3 NEW SECTION. **Sec. 20.** A new section is added to chapter 82.12 RCW  
4 to read as follows:

5 The provisions of this chapter shall not apply in respect to the  
6 use of tangible personal property by a resident of a county that the  
7 governor has declared after June 30, 1995, to be in a disaster area as  
8 a result of flooding, if the property replaces household goods,  
9 personal effects, or private automobiles, lost or destroyed in the  
10 flooding.

11 NEW SECTION. **Sec. 21.** Sections 17 and 19 of this act shall expire  
12 March 31, 1997. Sections 18 and 20 of this act shall expire September  
13 31, 1996."
