- AN ACT Relating to a study of airport noise; creating new sections;
- 2 and making an appropriation.

State of Washington

- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. (1) The legislature desires to be fully NEW SECTION. 5 informed of the potential costs and impacts of its decisions prior to 6 enacting public policies. Fiscal notes, which describe the financial impacts of specific policies, are typically requested from government agencies in order to assess the fiscal impacts to government. 8 Currently, no formal mechanism exists for legislators to evaluate the 9 10 financial impacts their policies might have upon private persons and businesses of the state. By enacting this measure, the legislature 11
- intends to evaluate the impact of governmental policies, particularly airport policies and decisions that financially impact the state's
- 13 airport policies and decisions, that financially impact the state's
- 14 citizens living near airport facilities.
- 15 (2) The legislature does not expressly or impliedly acquiesce to,
- 16 or agree with, any general or specific proposal having the effect of
- 17 increasing air traffic at Seattle-Tacoma international airport. This
- 18 act is not intended to establish mitigation payments that might be
- 19 required if proposals for additional runways at Seattle-Tacoma

- 1 international airport are adopted. The legislature intends only to
- 2 measure the potential financial impact such policies might have upon
- 3 residents in the airport vicinity, to enable better public policy
- 4 decisions by state, regional, and local governmental entities.
- 5 <u>NEW SECTION.</u> **Sec. 2.** (1) The legislative transportation committee
- 6 shall conduct a study analyzing the impacts of airport impacts, such as
- 7 air quality, water quality, street traffic, and noise, upon residential
- 8 housing values near Seattle-Tacoma international airport. The
- 9 committee may retain consultants as necessary to conduct or assist in
- 10 the analysis.
- 11 (2) At a minimum, the study shall (a) establish the study area,
- 12 including all residential properties located within 55 LDN contour of
- 13 Seattle-Tacoma international airport as well as the cities of Burien,
- 14 Des Moines, Normandy Park, Sea-Tac, and Tukwila; (b) conduct the study
- 15 according to accepted methodology such as the "neighborhood pair"
- 16 model, comparing at least two comparable neighborhoods, one of which is
- 17 exposed to a higher level of airport traffic than the other; and (c)
- 18 make use of local realtors and appraisers who are familiar with the
- 19 study area.
- NEW SECTION. Sec. 3. The sum of seventy-five thousand dollars, or
- 21 as much thereof as may be necessary, is appropriated for the biennium
- 22 ending June 30, 1997, from the transportation fund created under RCW
- 23 82.44.180, to the legislative transportation committee for the purposes
- 24 of conducting the study required under section 2 of this act.
- 25 <u>NEW SECTION.</u> **Sec. 4.** The legislative transportation committee
- 26 shall submit a final report on the results of the study to the
- 27 appropriate legislative committees by December 15, 1996.
