- 1 AN ACT Relating to local public health governance and financing;
- 2 reenacting and amending RCW 82.44.110; adding a new section to chapter
- 3 70.05 RCW; and providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 70.05 RCW 6 to read as follows:
- 7 (1) The county public health account is created in the state
- 8 treasury. Funds deposited in the county public health account shall be
- 9 distributed by the state treasurer to each local public health
- 10 jurisdiction based upon amounts certified to it by the department of
- 11 community, trade, and economic development in consultation with the
- 12 Washington state association of counties. The account shall include
- 13 funds distributed under RCW 82.44.110 and such funds as are
- 14 appropriated to the account from the health services account under RCW
- 15 43.72.900, the public health services account under RCW 43.72.902, and
- 16 such other funds as the legislature may appropriate to it.
- 17 (2) The director of the department of community, trade, and
- 18 economic development shall certify the amounts to be distributed to
- 19 each local public health jurisdiction using 1995 as the base year of

- 1 actual city contributions to local public health. The county treasurer
- 2 shall certify the actual 1995 city contribution to the department.
- 3 Funds in excess of the base shall be distributed proportionately among
- 4 the health jurisdictions based on incorporated population figures as
- 5 last determined by the office of financial management.
- 6 (3) Moneys distributed under this section shall be expended
- 7 exclusively for local public health purposes.
- 8 **Sec. 2.** RCW 82.44.110 and 1993 sp.s. c 21 s 7 and 1993 c 492 s 253 9 are each reenacted and amended to read as follows:
- 10 The county auditor shall regularly, when remitting license fee
- 11 receipts, pay over and account to the director of licensing for the
- 12 excise taxes collected under the provisions of this chapter. The
- 13 director shall forthwith transmit the excise taxes to the state
- 14 treasurer.
- 15 (1) The state treasurer shall deposit the excise taxes collected
- 16 under RCW 82.44.020(1) as follows:
- 17 (a) 1.60 percent into the motor vehicle fund to defray
- 18 administrative and other expenses incurred by the department in the
- 19 collection of the excise tax.
- 20 (b) 8.15 percent into the Puget Sound capital construction account
- 21 in the motor vehicle fund.
- 22 (c) 4.07 percent into the Puget Sound ferry operations account in
- 23 the motor vehicle fund.
- 24 (d) 5.88 percent into the general fund to be distributed under RCW
- 25 82.44.155.
- 26 (e) 4.75 percent into the municipal sales and use tax equalization
- 27 account in the general fund created in RCW 82.14.210.
- 28 (f) 1.60 percent into the county sales and use tax equalization
- 29 account in the general fund created in RCW 82.14.200.
- 30 (g) 62.6440 percent into the general fund through June 30, 1995,
- 31 and 57.6440 percent into the general fund beginning July 1, 1995.
- 32 (h) 5 percent into the transportation fund created in RCW 82.44.180
- 33 beginning July 1, 1995.
- 34 (i) 5.9686 percent into the county criminal justice assistance
- 35 account created in RCW 82.14.310.
- 36 (j) 1.1937 percent into the municipal criminal justice assistance
- 37 account for distribution under RCW 82.14.320.

- 1 (k) 1.1937 percent into the municipal criminal justice assistance 2 account for distribution under RCW 82.14.330.
- (1) 2.95 percent into the ((general fund to be distributed by the state treasurer to county health departments to be used exclusively for public health. The state treasurer shall distribute these funds proportionately among the counties based on population as determined by the most recent United States census)) county public health account created in section 1 of this act.
- 9 Notwithstanding (i) through (k) of this subsection, no more than 10 sixty million dollars shall be deposited into the accounts specified in (i) through (k) of this subsection for the period January 1, 1994, 11 through June 30, 1995. For the fiscal year ending June 30, 1998, and 12 for each fiscal year thereafter, the amounts deposited into the 13 accounts specified in (i) through (k) of this subsection shall not 14 15 increase by more than the amounts deposited into those accounts in the previous fiscal year increased by the implicit price deflator for the 16 previous fiscal year. Any revenues in excess of this amount shall be 17 deposited into the general fund. 18
- 19 (2) The state treasurer shall deposit the excise taxes collected 20 under RCW 82.44.020(2) into the transportation fund.
- 21 (3) The state treasurer shall deposit the excise tax imposed by RCW 22 82.44.020(3) into the air pollution control account created by RCW 23 70.94.015.
- NEW SECTION. Sec. 3. This act shall take effect January 1, 1996.
