- 1 AN ACT Relating to altering the Washington citizens' commission on
- 2 salaries for elected officials by increasing the number of commission
- 3 members selected by lot from registered voters, providing attendance
- 4 requirements, and clarifying procedures; amending RCW 43.03.305 and
- 5 43.03.310; and declaring an emergency.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 **Sec. 1.** RCW 43.03.305 and 1993 c 281 s 46 are each amended to read
- 8 as follows:
- 9 There is created a commission to be known as the Washington
- 10 citizens' commission on salaries for elected officials, to consist of
- 11 ((fifteen)) sixteen members appointed by the governor as provided in
- 12 this section.
- 13 (1) ((<del>Eight</del>)) <u>Nine</u> of the ((<del>fifteen</del>)) <u>sixteen</u> commission members
- 14 shall be selected by lot by the secretary of state from among those
- 15 registered voters eligible to vote at the ((general election held in
- 16 November, 1986, and thereafter from among those registered voters
- 17 eligible to vote at the)) time ((of the selection)) persons are
- 18 selected for appointment to full terms on the commission under
- 19 subsection (3) of this section. One member shall be selected from each

- congressional district. The secretary shall establish policies and 1 procedures for conducting the selection by lot. The policies and 2 procedures shall include, but not be limited to, those for notifying 3 4 persons selected and for providing a new selection from a congressional 5 district if a person selected from the district declines appointment to the commission or if, following the person's appointment, the person's 6 7 position on the commission becomes vacant before the end of the 8 person's term of office.
- 9 (2) The remaining seven of the ((fifteen)) sixteen commission members, all residents of this state, shall be selected jointly by the 10 speaker of the house of representatives and the president of the 11 The persons selected under this subsection shall have had 12 senate. 13 experience in the field of personnel management. Of these seven members, one shall be selected from each of the following five sectors 14 15 in this state: Private institutions of higher education; business; professional personnel management; legal profession; and organized 16 labor. Of the two remaining members, one shall be a person recommended 17 to the speaker and the president by the chair of the Washington 18 19 personnel resources board and one shall be a person recommended by 20 majority vote of the presidents of the state's four-year institutions of higher education. 21
  - (3) The secretary of state shall forward the names of persons selected under subsection (1) of this section and the speaker of the house of representatives and president of the senate shall forward the names of persons selected under subsection (2) of this section to the governor who shall appoint these persons to the commission. Except as provided in subsection (6) of this section, the names of persons selected for appointment to the commission shall be forwarded to the governor not later than February 15, 1987, and not later than the fifteenth day of February every four years thereafter.
  - (4) Members shall hold office for terms of four years, and no person may be appointed to more than two such terms. No member of the commission may be removed by the governor during his or her term of office unless for cause of incapacity, incompetence, neglect of duty, or malfeasance in office or for a disqualifying change of residence.
- The unexcused absence of any person who is a member of the commission from two consecutive meetings of the commission shall constitute the relinquishment of that person's membership on the commission. Such a relinquishment creates a vacancy in that person's

- 2 chair of the commission upon the member's written request if the chair

- 6 be excused during the meeting for which the member is absent by the

- 9 (5) No state official, public employee, or lobbyist, or immediate
- 10 family member of the official, employee, or lobbyist, subject to the

- 13 As used in this subsection the phrase "immediate family" means the
- 14 parents, spouse, siblings, children, or dependent relative of the
- 15 official, employee, or lobbyist whether or not living in the household
- 16 of the official, employee, or lobbyist.
- 17 (6) Upon a vacancy in any position on the commission, a successor
- 18 shall be selected and appointed to fill the unexpired term. The
- 19 selection and appointment shall be concluded within thirty days of the
- 20 date the position becomes vacant and shall be conducted in the same
- 21 manner as originally provided.
- 22 **Sec. 2.** RCW 43.03.310 and 1986 c 155 s 3 are each amended to read
- 23 as follows:
- 24 (1) The citizens' commission on salaries for elected officials
- 25 shall study the relationship of salaries to the duties of members of
- 26 the legislature, all elected officials of the executive branch of state
- 27 government, and all judges of the supreme court, court of appeals,
- 28 superior courts, and district courts, and shall fix the salary for each
- 29 respective position.
- 30 (2) Except as provided otherwise in <u>RCW 43.03.305 and</u> this section,
- 31 the commission shall be solely responsible for its own organization,
- 32 operation, and action and shall enjoy the fullest cooperation of all
- 33 state officials, departments, and agencies.
- 34 (3) Members of the commission shall receive no compensation for
- 35 their services, but shall be eligible to receive a subsistence
- 36 allowance and travel expenses pursuant to RCW 43.03.050 and 43.03.060.
- 37 (4) The members of the commission shall elect a ((chairperson))
- 38 <u>chair</u> from among their number. The commission shall set a schedule of

- (7) All meetings, actions, hearings, and business of the commission shall be subject in full to the open public meetings act, chapter 42.30 RCW.
- 25 (8) Salaries of the officials referred to in subsection (1) of this 26 section that are in effect on January 12, 1987, shall continue until 27 modified by the commission under this section.
- NEW SECTION. Sec. 3. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and shall take effect immediately.
