- 4 87.80.130, 87.80.140, 87.80.160, 87.80.190, 87.80.200, 87.03.440,
- 5 90.03.380, 43.83B.050, and 43.99E.030; adding new sections to chapter
- 6 87.80 RCW; and repealing RCW 87.80.170, 87.80.180, and 87.80.210.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 Sec. 1. RCW 87.80.010 and 1949 c 56 s 1 are each amended to read 9 as follows:
- 10 A board of joint control <u>may be created as provided in this chapter</u>
- 11 to administer: (1) The construction, operation, maintenance,
- 12 betterments, and regulations of the ((water works, main, and branch
- 13 canals, if any, and water lines and other water facilities)) joint use
- 14 <u>facilities</u>, <u>including reservoirs</u>, <u>canals</u>, <u>hydroelectric facilities</u>
- 15 within the works of the irrigation water supply system, pumping
- 16 stations, drainage works, reserved works, and system interconnections,
- 17 of two or more irrigation ((districts and others)) entities which are
- 18 the owners of, have an ownership interest in, or are trustees for
- 19 <u>owners of</u> water rights having the same ((natural)) source ((and)) <u>or</u>

- 1 which use ((the same)) common works for the diversion and either
- 2 transportation, or drainage, or both, of all or any part of their
- 3 respective irrigation water supplies((, may be created as hereinafter
- 4 provided)); and (2) activities and programs that promote more effective
- 5 and efficient water management for the benefit of member entities of a
- 6 board of joint control.
- 7 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 87.80 RCW
- 8 to read as follows:
- 9 Unless the context clearly requires otherwise, the definitions in
- 10 this section apply throughout this chapter.
- 11 (1) "Area of jurisdiction" means all lands within the exterior
- 12 boundary of the composite area served by the irrigation entities that
- 13 comprise the board of joint control as the boundary is represented on
- 14 the map filed under RCW 87.80.030.
- 15 (2) "Irrigation entity" means an irrigation district or an
- 16 operating entity for a division within a federal reclamation project.
- 17 (3) "Joint use facilities" means those works, including reservoirs,
- 18 canals, hydroelectric facilities, pumping stations, drainage works,
- 19 reserved works as may be transferred by contracts with the United
- 20 States, and system interties that are determined by the board of joint
- 21 control to provide common benefit to its members.
- 22 (4) "Ownership interest" means the irrigation entity holds water
- 23 rights in its name for the benefit of its water users or, in federal
- 24 reclamation projects, the irrigation entity has a contractual
- 25 responsibility for delivery of water to its individual water users.
- 26 (5) "Source of water" means a hydrological distinct river or
- 27 aquifer system from which board of joint control member entities
- 28 appropriate water.
- 29 **Sec. 3.** RCW 87.80.020 and 1949 c 56 s 2 are each amended to read
- 30 as follows:
- 31 (1) For the purpose of creating ((such)) <u>a</u> board of joint control
- 32 a petition signed by ((three)) two or more ((owners of)) entities that
- 33 are owners of or hold an ownership interest in water rights having the
- 34 same ((natural)) source of water ((and which owners)) or use common
- 35 works for the diversion ((and)), transportation, or drainage of all or
- 36 any part of their respective irrigation water supplies, ((as aforesaid,
- 37 shall)) must be filed with the board of county commissioners of the

- 1 county in which the greater part of the land irrigated from ((said))
- 2 the source of water supply is situated. ((No irrigation district shall
- 3 be represented on said petition without the signatures of the entire
- 4 membership of its board of directors.))
- 5 (2) The petition shall also be filed with the board of
- 6 commissioners of each county containing lands irrigated from the source
- 7 of water supply of the entities signing the petition. The board of
- 8 county commissioners making the review under RCW 87.80.090 shall
- 9 consider any comments of other boards of county commissioners provided
- 10 within the public hearing and comment period on the petition.
- 11 **Sec. 4.** RCW 87.80.030 and 1949 c 56 s 3 are each amended to read
- 12 as follows:
- The petition for the creation of a board of joint control shall be
- 14 addressed to the board of county commissioners, shall describe
- 15 generally the ((water works, main, and branch canals, if any, and water
- 16 lines and other water facilities involved)) relationship, if any, of
- 17 the irrigation entities to an established federal reclamation project,
- 18 the primary water works of the entities including reservoirs, main
- 19 canals, hydroelectric facilities, pumping stations, and drainage
- 20 <u>facilities</u>, giving them their local names, if any they have, and shall
- 21 show generally the physical relationship of the lands being watered
- 22 from the ((common use of said water works, canals, lines and other))
- 23 water facilities((: PROVIDED, That)). However, lands included in any
- 24 irrigation ((district)) entity involved need not be described
- 25 individually but shall be included by stating the name of the
- 26 irrigation (($\frac{district}{dist}$)) $\frac{entity}{dist}$ and all the irrigable lands in the
- 27 irrigation ((district)) entity named shall by that method be deemed to
- 28 be involved unless otherwise specifically stated in the petition.
- 29 Further, the petition must propose the formula for board of joint
- 30 control apportionment of costs among its members, and may propose the
- 31 composition of the board of joint control as to membership, chair, and
- 32 <u>voting structure.</u> The petition shall also state generally the reasons
- 33 for the creation of a board of joint control and any other matter the
- 34 petitioners deem material, and shall allege that it is in the public
- 35 interest and to the benefit of all the owners of the lands receiving
- 36 water ((from said common source)) within the area of jurisdiction, that
- 37 ((said)) the board of joint control be created and ((pray)) request
- 38 that the board of county commissioners consider ((said)) the petition

- l and take the necessary steps provided by law for the creation of a
- 2 board of joint control. The petition shall be accompanied by a map
- 3 showing the <u>area of jurisdiction and the</u> general location of the water
- 4 ((works, main, and branch canals, if any, and water lines and other
- 5 water)) supply and distribution facilities.
- 6 **Sec. 5.** RCW 87.80.050 and 1988 c 127 s 66 are each amended to read 7 as follows:
- 8 Notice of the hearing on ((said)) the petition shall be given by
- 9 the clerk of the board of county commissioners by publishing the same,
- 10 at the cost of the board of control, if created, otherwise at the cost
- 11 of the petitioners, in the official newspaper of ((the)) each county
- 12 containing lands irrigated from the source of supply of the entities
- 13 signing the petition. The notice shall be published in at least three
- 14 weekly issues thereof((: PROVIDED, That)). However, the time of the
- 15 hearing shall not be less than thirty days from the date of the first
- 16 publication of ((said)) the notice. A copy of ((said)) the notice
- 17 shall be posted at the regular meeting place of the board of directors
- 18 of each irrigation ((district)) entity concerned in the granting or
- 19 denial of ((said)) the petition and a copy of the notice shall be
- 20 mailed to the department of ecology at Olympia at least thirty days
- 21 prior to the day of ((said)) the hearing.
- 22 **Sec. 6.** RCW 87.80.060 and 1949 c 56 s 6 are each amended to read 23 as follows:
- 24 The notice of the hearing on ((said)) the petition shall state that
- 25 a petition ((praying for)) requesting the creation of a board of joint
- 26 control to administer the ((operation, maintenance, betterments and
- 27 regulation of the water works, main, and branch canals, if any, and
- 28 water lines, naming them, if named in the petition, and other water
- 29 facilities involved)) facilities and activities, naming them if named

in the petition, has been filed with the board of county commissioners

- 31 of the county (((naming it))), naming the county; that ((said)) the
- 32 board of joint control, if it is created, will have authority to
- 33 provide for ((assessments)) apportionment of costs to carry out the

- 9 If the board of county commissioners determine that the creation of
- 10 a board of joint control is in the public interest ((and is)), of
- 11 benefit to the ((lands)) <u>irrigation entities and individual water uses</u>
- 12 <u>within those entities</u> concerned, ((it)) <u>and will not be detrimental to</u>
- 13 water right interests outside the proposed board of joint control area
- 14 of jurisdiction: Then the county board shall so find and adopt a
- 15 resolution creating the board of joint control, designating it (((give
- 16 [giving] the)) name of county) County Joint Control Board No. (specify
- 17 number), and the county board at the same time shall appoint ((the
- 18 president of the board of directors of each irrigation district
- 19 involved and the resident owner of each individual tract of land
- 20 involved or such other person as any said landowner shall designate in
- 21 writing, as)) the first members of ((said)) the board of joint control
- 22 <u>based on the board composition proposed in the petition</u> and ((said))
- 23 the board of joint control shall consist of ((said)) this membership.
- 24 A copy of ((said)) the resolution creating the board of joint control
- 25 certified by the clerk of the county board shall be filed with the
- 26 county assessor of the county in which the board of joint control was
- 27 created and with the county assessor in any other county in the state
- 28 in which any lands involved are situated, within five days after
- 29 ((said)) the resolution is adopted.
- 30 **Sec. 8.** RCW 87.80.100 and 1949 c 56 s 9 are each amended to read
- 31 as follows:
- 32 The principal office and place of business of the board of joint
- 33 control shall be at a place to be designated by the board in the county
- 34 in which the board was created. Each member of the board before
- 35 entering on the duties of his or her office shall subscribe a written
- 36 oath for the faithful discharge of his or her duties as ((such)) a
- 37 member and file the ((same)) oath with the county clerk of ((said)) the

county. The filing of ((such)) the oath shall be without clerk's fee. 1 The term of office of members of the board ((shall be)) is for one year 2 or a fraction thereof ending on the first Monday in March next 3 4 following their selection and until their respective successors are selected as ((herein)) provided in this section. The term of the first 5 members of the board shall also be as above stated. In January of each 6 7 year the board of directors of each irrigation ((district)) entity 8 concerned shall designate in writing and deliver to the board of joint 9 control, the name or names of the person or persons who constitute the 10 entity's membership and who shall represent the ((district)) entity on the board of joint control for the ensuing year. ((Likewise, the 11 owners of land concerned but not in the irrigation district, shall each 12 13 designate in writing a person to represent their respective lands and 14 file the same with the board of joint control and that board shall 15 select from the list of persons so filed, one person to represent the 16 lands outside any irrigation district on the board of joint control for 17 the ensuing year.)) The persons ((so selected as aforesaid shall)) designated under this section constitute the board of joint control for 18 19 ((such)) the year and until their respective successors are selected 20 and have qualified. Any irrigation ((district or owner of land not in a district as the case may be, which)) entity that fails to designate 21 its ((or his)) representative and to file the same as ((above)) 22 provided ((shall)) in this section is not ((be)) entitled to 23 24 representation on the board unless and until ((such)) the requirements 25 are complied with.

26 **Sec. 9.** RCW 87.80.110 and 1949 c 56 s 10 are each amended to read 27 as follows:

In the month of March, or another time as determined by the board of joint control, in each year the members of the board of joint control shall meet and organize as a board for the ensuing year and shall select a ((chairman)) chair from their number and appoint a secretary who may, but need not, be a member of the board, and who shall keep a record of their proceedings, and perform ((such)) other duties as the board ((shall)) prescribes. Business of the board shall be transacted at meetings thereof and a majority of the qualified membership of the board ((shall)) constitutes a quorum for the transaction of business and in all matters requiring action by the board there shall be a concurrence of at least a majority of the

- 1 members present. However, if an alternative voting structure was
- 2 proposed in the petition and adopted in the board of county

- 6 **Sec. 10.** RCW 87.80.120 and 1949 c 56 s 11 are each amended to read 7 as follows:
- 8 Each member of the board of joint control shall ((receive not to
- 9 exceed ten dollars per day in attending meetings of the board to be
- 10 determined by the board, and such compensation, not exceeding ten
- 11 dollars per day for other services previously authorized and rendered
- 12 the board, and in addition thereto, the members shall receive necessary
- 13 expenses in attending meetings or when otherwise engaged on the
- 14 business of the board)) be compensated for services in accordance with
- 15 the provisions of RCW 87.03.460. The amount must be fixed by
- 16 resolution and entered in the minutes of the proceedings of the board.
- 17 The board shall fix the compensation to be paid the secretary and all

- 19 **Sec. 11.** RCW 87.80.130 and 1949 c 56 s 12 are each amended to read 20 as follows:
- 21 (1) A board of joint control created under the provisions of this
- 22 chapter shall have full authority within its area of jurisdiction to
- 23 enter into and perform any and all necessary contracts((7)); to accept
- 24 grants and loans, including, but not limited to, those provided under
- 25 chapters 43.83B and 43.99E RCW, to appoint and employ and discharge the
- 26 necessary officers, agents, and employees $((-))_i$ to sue and be sued as
- 27 a board but without personal liability of the members thereof in any
- 28 and all matters in which all the irrigation ((districts and others))
- 29 entities represented on the board as a whole have a common interest
- 30 without making ((such districts and other parties)) the irrigation

- (2) A board of joint control is authorized and encouraged to pursue 6 7 conservation and system efficiency improvements to optimize the use of 8 appropriated waters and to either redistribute the saved water within its area of jurisdiction, or, transfer the water to others, or both. 9 A redistribution of saved water as an operational practice internal to 10 the board of joint control's area of jurisdiction, may be authorized if 11 it can be made without detriment or injury to rights existing outside 12 of the board of control's area of jurisdiction, including instream flow 13 14 water rights established under state or federal law. Prior to undertaking a water conservation or system efficiency improvement 15 project which will result in a redistribution of saved water, the board 16 of joint control must consult with the department of ecology and if the 17 board's jurisdiction is within a United States reclamation project the 18 19 board must obtain the approval of the bureau of reclamation. The purpose of such consultation is to assure that the proposal will not 20 impair the rights of other water holders or bureau of reclamation 21 contract water users. A board of control does not have the power to 22 23 authorize a change of any water right that would change the point or 24 points of diversion, purpose of use, or place of use outside the board's area of jurisdiction, without the approval of the department of 25 26 ecology pursuant to RCW 90.03.380 and if the board's jurisdiction is within a United States reclamation project, the approval of the bureau 27 28 of reclamation.
- 29 (3) A board of joint control is authorized to design, construct, 30 and operate either drainage projects, or water quality enhancement 31 projects, or both.
- 32 <u>(4) Where the board of joint control area of jurisdiction is</u> 33 <u>totally within a federal reclamation project, the board is authorized</u> 34 <u>to accept operational responsibility for federal reserved works.</u>
 - (5) Nothing contained in this chapter gives a board of joint control the authority to abridge the existing rights, responsibilities, and authorities of an individual irrigation entity or others within the area of jurisdiction; nor in a case where the board of joint control consists of representatives of two or more divisions of a federal

- 28 the charge to each irrigation ((district)) entity, to the secretary of
- 29 each irrigation ((district)) entity coming under the jurisdiction of
- 30 the board of joint control and it shall be the duty of each irrigation
- 31 ((district)) entity to include in its levy for the ensuing year, the
- 32 amount apportioned and charged to it in the budget.
- 33 **Sec. 14.** RCW 87.80.190 and 1949 c 56 s 18 are each amended to read

- There is ((hereby)) created in the county treasurer's office of the

- 20 contained in the resolution of the board of county commissioners filed
- 21 under RCW 87.80.090. Amendments may be proposed at any time by the

- NEW SECTION. Sec. 17. A new section is added to chapter 87.80 RCW
- 26 to read as follows:
- 27 An irrigation entity under contract with an agency of the federal

- 29 may not participate in a board of joint control under this chapter if
- 30 this action is in conflict with provisions of the subject contract. If
- 31 a responsible official of the federal agency notifies the board of
- 32 county commissioners in writing on or before the day of hearing

- 34 evidences the conflict, the board of county commissioners must deny the
- 35 irrigation entity's proposed participation. If subsequent to formation

3 **Sec. 18.** RCW 87.03.440 and 1993 c 449 s 12 are each amended to 4 read as follows:

5 The treasurer of the county in which is located the office of the district shall be ex officio treasurer of the district, and any county 6 7 treasurer handling district funds shall be liable upon his or her official bond and to criminal prosecution for malfeasance and 8 9 misfeasance, or failure to perform any duty as county or district treasurer. The treasurer of each county in which lands of the district 10 are located shall collect and receipt for all assessments levied on 11 lands within his or her county. There shall be deposited with the 12 district treasurer all funds of the district. The district treasurer 13 14 shall pay out such funds upon warrants issued by the county auditor 15 against the proper funds of the district, except the sums to be paid out of the bond fund for interest and principal payments on bonds: 16 PROVIDED, That in those districts which designate their own treasurer, 17 18 the treasurer may issue the warrants or any checks when the district is authorized to issue checks. All warrants shall be paid in the order of 19 their issuance. The district treasurer shall report, in writing, on 20 the first Monday in each month to the directors, the amount in each 21 22 fund, the receipts for the month preceding in each fund, and file the 23 report with the secretary of the board. The secretary shall report to 24 the board, in writing, at the regular meeting in each month, the amount 25 of receipts and expenditures during the preceding month, and file the report in the office of the board. 26

The preceding paragraph of this section notwithstanding, the board of directors or board of control of an irrigation district which lies in more than one county and which had assessments in each of two of the preceding three years equal to at least five hundred thousand dollars, or a board of joint control created under chapter 87.80 RCW, may designate some other person having experience in financial or fiscal matters as treasurer of the district. In addition, the board of directors of an irrigation district which lies entirely within one county may designate some other person having experience in financial or fiscal matters as treasurer of the district if the board has the approval of the county treasurer to designate some other person. If the board designates a treasurer, it shall require a bond with a surety

company authorized to do business in the state of Washington in an 1 amount and under the terms and conditions which it finds from time to 2 time will protect the district against loss. The premium on the bond 3 4 shall be paid by the district. The designated treasurer shall collect 5 and receipt for all irrigation district assessments on lands within the district and shall act with the same powers and duties and be under the 6 7 same restrictions as provided by law for county treasurers acting in 8 matters pertaining to irrigation districts, except the powers, duties, 9 and restrictions in RCW 87.56.110 and 87.56.210 which shall continue to 10 be those of county treasurers.

In those districts which have designated their own treasurers, the provisions of law pertaining to irrigation districts which require certain acts to be done and which refer to and involve a county treasurer or the office of a county treasurer or the county officers charged with the collection of irrigation district assessments, except RCW 87.56.110 and 87.56.210 shall be construed to refer to and involve the designated district treasurer or the office of the designated district treasurer.

19 Any claim against the district for which it is liable under 20 existing laws shall be presented to the board as provided in RCW 4.96.020 and upon allowance it shall be attached to a voucher and 21 approved by the chairman and signed by the secretary and directed to 22 23 the proper official for payment: PROVIDED, That in the event 24 claimant's claim is for crop damage, the claimant in addition to filing 25 his or her claim within the applicable period of limitations within which an action must be commenced and in the manner specified in RCW 26 4.96.020 must file with the secretary of the district, or in the 27 secretary's absence one of the directors, not less than three days 28 prior to the severance of the crop alleged to be damaged, a written 29 30 preliminary notice pertaining to the crop alleged to be damaged. Such preliminary notice, so far as claimant is able, shall advise the 31 district; that the claimant has filed a claim or intends to file a 32 claim against the district for alleged crop damage; shall give the name 33 34 and present residence of the claimant; shall state the cause of the 35 damage to the crop alleged to be damaged and the estimated amount of damage; and shall accurately locate and describe where the crop alleged 36 37 to be damaged is located. Such preliminary notice may be given by claimant or by anyone acting in his or her behalf and need not be 38 39 verified. No action may be commenced against an irrigation district

- for crop damages unless claimant has complied with the provisions of

The right to the use of water which has been applied to a 6 7 beneficial use in the state shall be and remain appurtenant to the land or place upon which the same is used: PROVIDED, HOWEVER, That said 8 9 right may be transferred to another or to others and become appurtenant to any other land or place of use without loss of priority of right 10 theretofore established if such change can be made without detriment or 11 12 injury to existing rights. The point of diversion of water for beneficial use or the purpose of use may be changed, if such change can 13 14 be made without detriment or injury to existing rights. Before any 15 transfer of such right to use water or change of the point of diversion of water or change of purpose of use can be made, any person having an 16 interest in the transfer or change, shall file a written application 17 18 therefor with the department, and said application shall not be granted 19 until notice of said application shall be published as provided in RCW 90.03.280. If it shall appear that such transfer or such change may be 20 made without injury or detriment to existing rights, the department 21 shall issue to the applicant a certificate in duplicate granting the 22 23 right for such transfer or for such change of point of diversion or of 24 The certificate so issued shall be filed and be made a record 25 with the department and the duplicate certificate issued to the applicant may be filed with the county auditor in like manner and with 26 the same effect as provided in the original certificate or permit to 27 28 divert water.

A change in place of use by an individual water user or users of water provided by an irrigation district need only receive approval for the change from the board of directors of the district if the use of 38 water continues within the irrigation district, and when water is
