- 1 AN ACT Relating to auctions and raffles authorized by the fish and
- 2 wildlife commission; amending RCW 9.46.010, 77.12.170, 77.32.050,
- 3 77.32.060, 77.32.090, 77.32.230, and 77.32.250; adding a new section to
- 4 chapter 9.46 RCW; adding a new section to chapter 77.08 RCW; adding new
- 5 sections to chapter 77.12 RCW; creating a new section; and repealing
- 6 RCW 77.12.700.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that it is in the best
- 9 interest of recreational hunters to provide them with the variety of
- 10 hunting opportunities provided by auctions and raffles. Raffles
- 11 provide an affordable opportunity for most hunters to participate in
- 12 special hunts for big game animals and wild turkeys. The legislature
- 13 also finds that wildlife management and recreation are not adequately
- 14 funded and that such auctions and raffles can increase revenues to
- 15 improve wildlife management and recreation.
- 16 Sec. 2. RCW 9.46.010 and 1994 c 218 s 2 are each amended to read
- 17 as follows:

The public policy of the state of Washington on gambling is to keep the criminal element out of gambling and to promote the social welfare of the people by limiting the nature and scope of gambling activities and by strict regulation and control.

5 It is hereby declared to be the policy of the legislature, recognizing the close relationship between professional gambling and 6 7 organized crime, to restrain all persons from seeking profit from 8 professional gambling activities in this state; to restrain all persons 9 from patronizing such professional gambling activities; to safeguard 10 the public against the evils induced by common gamblers and common gambling houses engaged in professional gambling; and at the same time, 11 both to preserve the freedom of the press and to avoid restricting 12 13 participation by individuals in activities and social pastimes, which activities and social pastimes are more for amusement rather than for 14 15 profit, do not maliciously affect the public, and do not breach the 16 peace.

The legislature further declares that the raising of funds for the promotion of bona fide charitable or nonprofit organizations is in the public interest as is participation in such activities and social pastimes as are hereinafter in this chapter authorized.

The legislature further declares that the conducting of bingo, raffles, and amusement games and the operation of punch boards, pulltabs, card games and other social pastimes, when conducted pursuant to the provisions of this chapter and any rules and regulations adopted pursuant thereto, are hereby authorized, as are only such lotteries for which no valuable consideration has been paid or agreed to be paid as hereinafter in this chapter provided.

The legislature further declares that fishing derbies shall not constitute any form of gambling and shall not be considered as a lottery, a raffle, or an amusement game and shall not be subject to the provisions of this chapter or any rules and regulations adopted hereunder.

The legislature further declares that raffles authorized by the fish and wildlife commission involving hunting big game animals or wild turkeys shall not be subject to the provisions of this chapter or any rules and regulations adopted hereunder, with the exception of this section and section 3 of this act.

- 1 All factors incident to the activities authorized in this chapter
- 2 shall be closely controlled, and the provisions of this chapter shall
- 3 be liberally construed to achieve such end.
- 4 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 9.46 RCW
- 5 to read as follows:
- 6 Any raffle authorized by the fish and wildlife commission involving
- 7 hunting big game animals or wild turkeys shall not be subject to any
- 8 provisions of this chapter other than RCW 9.46.010 and this section or
- 9 to any rules or regulations of the gambling commission.
- 10 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 77.08 RCW
- 11 to read as follows:
- "Raffle," as used in this title, means an activity in which tickets
- 13 bearing an individual number are sold for not more than twenty-five
- 14 dollars each and in which a permit or permits are awarded to hunt or
- 15 for access to hunt big game animals or wild turkeys on the basis of a
- 16 drawing from the tickets by the person or persons conducting the
- 17 raffle.
- 18 <u>NEW SECTION.</u> **Sec. 5.** A new section is added to chapter 77.12 RCW
- 19 to read as follows:
- 20 (1) The commission in consultation with the director may authorize
- 21 hunting of big game animals and wild turkeys through auction. The
- 22 department may conduct the auction for the hunt or contract with a
- 23 nonprofit wildlife conservation organization to conduct the auction for
- 24 the hunt.
- 25 (2) The commission in consultation with the director may authorize
- 26 hunting of up to a total of fifteen big game animals and wild turkeys
- 27 per year through raffle. The department may conduct raffles or
- 28 contract with a nonprofit wildlife conservation organization to conduct
- 29 raffles for hunting these animals. In consultation with the gambling
- 30 commission, the director may adopt rules for the implementation of
- 31 raffles involving hunting.
- 32 (3) The director shall establish the procedures for the hunts,
- 33 which shall require any participants to obtain any required license,
- 34 permit, or tag. Representatives of the department may participate in
- 35 the hunt upon the request of the commission to ensure that the animals
- 36 to be killed are properly identified.

- 1 (4) After deducting the expenses of conducting an auction or 2 raffle, any revenues retained by a nonprofit organization, as specified 3 under contract with the department, shall be devoted solely for 4 wildlife conservation, consistent with its qualification as a bona fide 5 nonprofit organization for wildlife conservation.
- 6 (5) The department's share of revenues from auctions and raffles
 7 shall be deposited in the state wildlife fund. The revenues shall be
 8 used to improve the habitat, health, and welfare of the species
 9 auctioned or raffled and shall supplement, rather than replace, other
 10 funds budgeted for management of that species. The commission may
 11 solicit input from groups or individuals with special interest in and
 12 expertise on a species in determining how to use these revenues.
- 13 (6) A nonprofit wildlife conservation organization may petition the 14 commission to authorize an auction or raffle for a special hunt for big 15 game animals and wild turkeys.
- NEW SECTION. Sec. 6. A new section is added to chapter 77.12 RCW to read as follows:
- 18 If a private entity has a private lands wildlife management area 19 agreement in effect with the department, the commission may authorize the private entity to conduct raffles for access to hunt for big game 20 animals and wild turkeys to meet the conditions of the agreement. The 21 22 private entity shall comply with all applicable rules adopted under 23 section 5 of this act for the implementation of raffles; however, 24 raffle hunts conducted pursuant to this section shall not be counted 25 toward the number of raffle hunts the commission may authorize under section 5 of this act. The director shall establish the procedures for 26 the hunts, which shall require any participants to obtain any required 27 license, permit, or tag. Representatives of the department may 28 29 participate in the hunt upon the request of the commission to ensure that the animals to be killed are properly identified. 30
- 31 **Sec. 7.** RCW 77.12.170 and 1989 c 314 s 4 are each amended to read 32 as follows:
- 33 (1) There is established in the state treasury the state wildlife 34 fund which consists of moneys received from:
 - (a) Rentals or concessions of the department;
- 36 (b) The sale of real or personal property held for department 37 purposes;

- 1 (c) The sale of licenses, permits, tags, stamps, and punchcards 2 required by this title;
 - (d) Fees for informational materials published by the department;
- 4 (e) Fees for personalized vehicle license plates as provided in 5 chapter 46.16 RCW;
- 6 (f) Articles or wildlife sold by the director under this title;
- 7 (g) Compensation for wildlife losses or gifts or grants received 8 under RCW 77.12.320;
- 9 (h) Excise tax on anadromous game fish collected under chapter 10 82.27 RCW; ((and))
- 11 (i) The sale of personal property seized by the department for 12 wildlife violations; and
- (j) The department's share of revenues from auctions and raffles
 authorized by the commission.
- 15 (2) State and county officers receiving any moneys listed in 16 subsection (1) of this section shall deposit them in the state treasury 17 to be credited to the state wildlife fund.
- 18 **Sec. 8.** RCW 77.32.050 and 1995 c 116 s 1 are each amended to read 19 as follows:
- 20 Licenses, permits, tags, and stamps required by this chapter and raffle tickets authorized under chapter 77.12 RCW shall be issued under 21 the authority of the commission. The director may authorize department 22 23 personnel, county auditors, or other reputable citizens to issue 24 licenses, permits, tags, ((and)) stamps, and raffle tickets, and 25 collect the appropriate fees. The authorized persons shall pay on demand or before the tenth day of the following month the fees 26 collected and shall make reports as required by the director. 27
- 28 director may adopt rules for issuing licenses, permits, tags, ((and))
- 29 stamps, and raffle tickets, collecting and paying fees, and making
- 30 reports.

- 31 **Sec. 9.** RCW 77.32.060 and 1995 c 116 s 2 are each amended to read 32 as follows:
- The director may adopt rules establishing the amount a license
- 34 dealer may charge and keep for each license, tag, permit, ((or)) stamp,
- 35 or raffle ticket issued. The director shall establish the amount to be
- 36 retained by dealers to be at least fifty cents for each license issued,
- 37 and twenty-five cents for each tag, permit, ((or)) stamp, or raffle

- 1 <u>ticket</u>, issued. The director shall report to the next regular session
- 2 of the legislature explaining any increase in the amount retained by
- 3 license dealers. Fees retained by dealers shall be uniform throughout
- 4 the state.
- 5 **Sec. 10.** RCW 77.32.090 and 1995 c 116 s 4 are each amended to read 6 as follows:
- 7 The director may adopt rules pertaining to the form, period of
- 8 validity, use, possession, and display of licenses, permits, tags, and
- 9 stamps required by this chapter and raffle tickets authorized under
- 10 <u>chapter 77.12 RCW</u>.
- 11 **Sec. 11.** RCW 77.32.230 and 1994 c 255 s 12 are each amended to 12 read as follows:
- 13 (1) A person sixty-five years of age or older who is an honorably
- 14 discharged veteran of the United States armed forces having a service-
- 15 connected disability and who is a resident may receive upon written
- 16 application a hunting and fishing license free of charge.
- 17 (2) Residents who are honorably discharged veterans of the United
- 18 States armed forces with a thirty percent or more service-connected
- 19 disability may receive upon written application a hunting and fishing
- 20 license free of charge.
- 21 (3) An honorably discharged veteran who is a resident and is
- 22 confined to a wheelchair shall receive upon application a hunting
- 23 license free of charge.
- 24 (4) A person who is blind, or a person with a developmental
- 25 disability as defined in RCW 71A.10.020 with documentation of the
- 26 disability from the department of social and health services, or a
- 27 physically handicapped person confined to a wheelchair may receive upon
- 28 written application a fishing license free of charge.
- 29 (5) A person who is blind or a physically handicapped person
- 30 confined to a wheelchair who has been issued a card for a permanent
- 31 disability under RCW 46.16.381 may use that card in place of a fishing
- 32 license.
- 33 (6) A fishing license is not required for residents under the age
- 34 of fifteen.
- 35 (7) Tags, permits, stamps, and steelhead licenses required by this
- 36 chapter and raffle tickets authorized under chapter 77.12 RCW shall be

- 1 purchased separately by persons receiving a free or reduced-fee
- 2 license.
- 3 (8) Licenses issued at no charge under this section shall be issued
- 4 from Olympia as provided by rule of the director, and are valid for
- 5 five years.
- 6 Sec. 12. RCW 77.32.250 and 1995 c 116 s 5 are each amended to read
- 7 as follows:
- 8 Licenses, permits, tags, and stamps required by this chapter and
- 9 raffle tickets authorized under chapter 77.12 RCW shall not be
- 10 transferred and, unless otherwise provided in this chapter, are void on
- 11 January 1st following the year for which the license, permit, tag,
- 12 ((or)) stamp, or raffle ticket was issued.
- 13 Upon request of a wildlife agent or ex officio wildlife agent,
- 14 persons licensed, operating under a permit, or possessing wildlife
- 15 under the authority of this chapter shall produce required licenses,
- 16 permits, tags, ((or)) stamps, or raffle tickets for inspection and
- 17 write their signatures for comparison and in addition display their
- 18 wildlife. Failure to comply with the request is prima facie evidence
- 19 that the person has no license or is not the person named.
- 20 <u>NEW SECTION.</u> **Sec. 13.** RCW 77.12.700 and 1987 c 506 s 56 are each
- 21 repealed.
