The fees set forth in RCW 14.20.050 shall be paid to the secretary.

The fee for any calendar year may be paid on and after the first day of

December of the preceding year. The secretary shall give appropriate

receipts therefor. The fees collected under this chapter shall be

credited to the ((general)) aeronautics account of the transportation

fund. The secretary may prescribe requirements for the possession and

exhibition of aircraft dealer's licenses and aircraft dealer's

certificates.
