1            AN ACT Relating to the supervision of municipal court probation  
2 services; and amending RCW 35.20.230.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            **Sec. 1.** RCW 35.20.230 and 1969 ex.s. c 147 s 6 are each amended to  
5 read as follows:

6            The judges of the municipal court shall appoint a director of  
7 probation services who shall, under the direction and supervision of  
8 the ((~~presiding judge~~)) court administrator of the municipal court,  
9 supervise the probation officers of the municipal court. The judges of  
10 the municipal court shall also appoint a bailiff for the court,  
11 together with such number of probation officers and additional bailiffs  
12 as may be authorized by the legislative body of the city. ((Said)) The  
13 director of probation services, probation officers, and bailiff or  
14 bailiffs shall be paid by the city treasurer in such amount as is  
15 deemed reasonable by the legislative body of the city: PROVIDED, That  
16 such additional probation officers and bailiffs of the court as may be  
17 authorized by the county commissioners shall be paid from the county  
18 treasury.
