- 2 cosmetology, barbering, esthetics, and manicuring advisory board; and
- 3 amending RCW 18.16.050.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 18.16.050 and 1997 c 179 s 1 are each amended to read 6 as follows:
- 7 (1) There is created a state cosmetology, barbering, esthetics, and
- 8 manicuring advisory board consisting of ((seven)) nine members
- 9 appointed by the director. These ((seven)) members of the board shall
- 10 include: A representative of a private cosmetology school ((and)); a
- 11 representative of a public vocational technical school involved in
- 12 cosmetology training((, with the balance made up of currently
- 13 practicing licensees who have been engaged in the practice of
- 14 manicuring, esthetics, barbering, or cosmetology for at least three
- 15 years. One member of the board shall be)); a consumer who is
- 16 unaffiliated with the cosmetology, barbering, esthetics, or manicuring
- 17 industry; and six members who are currently practicing licensees who
- 18 have been engaged in the practice of manicuring, esthetics, barbering,
- 19 or cosmetology for at least three years. ((On June 30, 1995, the

- 1 director shall appoint seven new members to the board. These new))
- 2 Members shall serve a term of three years. ((The director shall
- 3 appoint two new members including: (a) One representative with
- 4 employee supervisory experience from a chain salon having ten or more
- 5 salons; and (b) one representative from the industry at large who has
- 6 substantial salon and school experience. The board shall cease to
- 7 exist on June 30, 1998. Any members serving on the advisory board as
- 8 of July 1, 1995, or who are appointed after July 27, 1997, are eligible
- 9 to be reappointed, should the advisory board be extended beyond June
- 10 30, 1998.)) Any board member may be removed for just cause. The
- 11 director may appoint a new member to fill any vacancy on the board for
- 12 the remainder of the unexpired term.
- 13 (2) The board appointed on June 30, 1995, together with the
- 14 director or the director's designee, shall conduct a thorough review of
- 15 educational requirements, licensing requirements, and enforcement and
- 16 health standards for persons engaged in cosmetology, barbering,
- 17 esthetics, or manicuring and shall prepare a report to be delivered to
- 18 the governor, the director, and the chairpersons of the governmental
- 19 operations committees of the house of representatives and the senate.
- 20 The report must summarize their findings and make recommendations,
- 21 including, if appropriate, recommendations for legislation reforming
- 22 and restructuring the regulation of cosmetology, barbering, esthetics,
- 23 and manicuring.
- 24 (3) Board members shall be entitled to compensation pursuant to RCW
- 25 43.03.240 for each day spent conducting official business and to
- 26 reimbursement for travel expenses as provided by RCW 43.03.050 and
- 27 43.03.060.
- 28 (4) The board may seek the advice and input of officials from the
- 29 following state agencies: (a) The work force training and education
- 30 coordinating board; (b) the department of employment security; (c) the
- 31 department of labor and industries; (d) the department of health; (e)
- 32 the department of licensing; and (f) the department of revenue.
