- 1 AN ACT Relating to crimes related to mail; reenacting and amending
- 2 RCW 9.94A.320; adding a new chapter to Title 9A RCW; and prescribing
- 3 penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The definitions in this section apply 6 throughout this chapter unless the context clearly requires otherwise.
- 7 (1) "Authorized depository" means a mailbox, post office box, or
- 8 rural box used by postal customers to deposit outgoing mail or used by
- 9 the postal service to deliver incoming mail.
- 10 (2) "Letter box" means a receptacle intended or used for the 11 receipt or delivery of mail on a mail route.
- 12 (3)(a) "Mail" means a letter, card, parcel, or other material that:
- (i) Is sent or delivered by means of the postal service;
- 14 (ii) Has postage affixed by the postal customer or postal service;
- 15 and
- 16 (iii) Is placed in an authorized depository or mail receptacle.
- 17 (b) "Mail" includes articles contained in mail.
- 18 (4) "Mail receptacle" means a place used by the postal service or
- 19 postal customers to place outgoing mail or receive incoming mail.

- 1 (5) "Postage" means a postal service stamp, permit imprint, meter
- 2 strip, or other authorized indication of prepayment for service
- 3 provided by the postal service for collection and delivery of mail.
- 4 (6) "Postal service" means the United States postal service.
- 5 <u>NEW SECTION.</u> **Sec. 2.** (1) A person commits the crime of
- 6 obstruction of mails if the person intentionally obstructs or delays:
- 7 (a) The passage of the mail; or
- 8 (b) A carrier or conveyance carrying the mail.
- 9 (2) Obstruction of mails is a gross misdemeanor.
- 10 <u>NEW SECTION.</u> **Sec. 3.** (1) A person commits the crime of
- 11 destruction of letter boxes or mail if the person knowingly:
- 12 (a) Tears down or destroys a letter box belonging to another;
- 13 (b) Breaks open a letter box belonging to another; or
- 14 (c) Injures, destroys, or defaces mail, belonging to another, that
- 15 has been deposited in a letter box.
- 16 (2) Destruction of letter boxes or mail is a class C felony.
- 17 <u>NEW SECTION.</u> **Sec. 4.** (1) A person commits the crime of mail theft
- 18 or receipt of stolen mail if the person knowingly:
- 19 (a) Takes or, by fraud or deception, obtains mail from a mail
- 20 receptacle, authorized depository, or mail carrier;
- 21 (b) Secretes, embezzles, or destroys mail;
- 22 (c) Takes or, by fraud or deception, obtains mail that has been
- 23 left for collection on or adjacent to an authorized depository or mail
- 24 receptacle; or
- 25 (d) Buys, receives, conceals, or unlawfully possesses mail knowing
- 26 that the mail was taken, obtained, or embezzled as described in this
- 27 subsection.
- 28 (2) When a person has in his or her possession or control stolen
- 29 mail addressed to two or more different addresses, he or she is
- 30 presumed to know that the mail is stolen. This presumption may be
- 31 rebutted by evidence raising a reasonable inference that the possession
- 32 of such stolen mail was without knowledge that the mail was stolen.
- 33 <u>NEW SECTION.</u> **Sec. 5.** (1) A person is guilty of mail theft or
- 34 receipt of stolen mail in the first degree if he or she possesses mail
- 35 addressed to five or more different addresses.

- 1 (2) Mail theft or receipt of stolen mail in the first degree is a 2 class B felony.
- 3 <u>NEW SECTION.</u> **Sec. 6.** (1) A person is guilty of mail theft or
- 4 receipt of stolen mail in the second degree if he or she possesses mail
- 5 addressed to four or less different addresses.
- 6 (2) Mail theft or receipt of stolen mail in the second degree is a
- 7 class C felony.
- 8 <u>NEW SECTION.</u> **Sec. 7.** In a prosecution under this chapter, it is
- 9 a defense that the defendant acted under an honest claim of right in
- 10 that:
- 11 (1) The defendant was unaware that the property was that of another
- 12 person;
- 13 (2) The defendant reasonably believed that the defendant was
- 14 entitled to the property involved or had a right to acquire or dispose
- 15 of it as the defendant did; or
- 16 (3) The property involved was that of the defendant's minor child
- 17 or spouse, unless the parties were not living together as husband and
- 18 wife and were residing in, and intended to continually reside in,
- 19 separate abodes at the time of the alleged offense.
- 20 <u>NEW SECTION.</u> **Sec. 8.** Sections 1 through 7 of this act constitute
- 21 a new chapter in Title 9A RCW.
- 22 Sec. 9. RCW 9.94A.320 and 1998 c 290 s 4, 1998 c 219 s 4, 1998 c
- 23 82 s 1, and 1998 c 78 s 1 are each reenacted and amended to read as
