# Special land purchases and common school construction (98-2-015)

14 The appropriation in this section is subject to the following 15 conditions and limitations:

- (1) The appropriation is provided to the department of natural resources solely for the purposes of transferring from trust status certain trust lands of state-wide significance to state park, wildlife habitat, natural area preserve, natural resources conservation area, open space, or recreation purposes, acquiring replacement timber trust lands, and providing funding for common school construction.
- (2) The appropriation in this section is provided solely for the transfer of the following list of trust properties to the identified agency:
- 25 (a) Iron Horse/Bandera, King county, to the state parks and 26 recreation commission;
- (b) Kitsap Forest, Kitsap county, to the department of natural resources for natural area preserve purposes;
- 29 (c) Upper Sultan Basin, Snohomish county, to the department of 30 natural resources for natural resource conservation area purposes;
- 31 (d) West Tiger Mountain, King county, to the department of natural resources for natural resource conservation area purposes:
- (e) <u>Hendrickson Canyon</u>, <u>Wahkiakum county</u>, to the <u>department of</u> natural resources for natural area preserve purposes;
- 35 <u>(f) Klickitat Wildlife Area, Klickitat county, to the department of fish and wildlife;</u>

1 (g) Point Lawrence, San Juan county, to the state parks and 2 recreation commission.

The department shall transfer the ((first)) trust ((property and then allocate the remaining funds to the remaining)) properties ((in roughly equal shares)) in the order listed.

- (3) Land and timber transferred under this section shall be appraised and transferred at full market value. The department of natural resources shall attempt to maintain a minimum aggregate ratio of 85:15 timber-to-land value in these transactions. The value of the timber transferred shall be deposited by the department of natural resources in the same manner as timber revenues from other common school trust lands, except that no deduction shall be made for the resource management cost account. The value of the land transferred, not to exceed \$3,000,000, shall be deposited in the natural resources real property replacement account to be used for the acquisition of replacement timber lands solely to benefit the common school trust.
- 17 (4) All reasonable costs incurred by the department of natural 18 resources to implement this section may be paid out of this 19 appropriation, except that the costs of acquiring replacement timber 20 lands shall be paid out of appropriations from the natural resources 21 real property replacement account.
  - (5) The department shall use intergrant exchanges between common school and other trust lands of equal value to effect the purposes of this section if the exchange is in the interest of each trust, as determined by the board of natural resources.
  - (6) The department of natural resources and receiving agencies shall work in good faith to carry out the intent of this section. However, the board of natural resources or a receiving agency may reject a transfer of property if it is determined that the transfer is not in the interest of either the common school trust or the receiving agency.
- (7) ((On June 30, 1999)) Upon completion of these transfers, the state treasurer shall transfer all remaining uncommitted funds from this appropriation to the common school construction fund ((and the appropriation in this section shall be reduced by an equivalent amount)).

# Public school building construction (98-2-001)

- 9 The appropriations in this section are subject to the following 10 conditions and limitations:
- 11 (1) From the appropriation in this section the state board shall 12 fund one hundred percent of the cost for a required standard value 13 engineering study on all projects exceeding 50,000 gross square feet in 14 size. On an annual basis, the board shall report to the legislative 15 fiscal committees and the office of financial management the results of 16 these studies including but not limited to the amounts of each study 17 and the accepted savings achieved due to the studies.
- 18 (2) ((No more than \$138,000,000 of this appropriation, excluding 19 reappropriations, may be obligated in fiscal year 1998 for school 20 district project design and construction.
- 21 (3) Total cash disbursed from the common school construction fund 22 may not exceed the available cash balance.
- 23 (4))) The reappropriation from the state building construction 24 account shall serve as full compensation to the common school trust for 25 the transfer of land to the Washington State University Lind Dryland 26 Research Unit under Substitute House Bill No. 1016 or Senate Bill No. 27 5174.
- 28 (((5))) No more than \$7,110,000 of this appropriation may be allocated by the state board to provide up to ninety percent of the 29 30 total project cost for the renovation of facilities operating as 31 interdistrict cooperative centers providing vocational skill programs. The remaining portion of the project cost shall be a match from local 32 33 sources. As a condition to receiving an allocation from this 34 appropriation or any other appropriation for a vocational skill center provided after calendar year 1996, the recipient facility must maintain 35 36 a separate capital account, into which the participating districts make 37 deposits, to pay for all future minor repair and renovation costs for

Sec. 5. 1998 c 347 s 53 (uncodified) is amended to read as follows: ACQUISITION OF PROPERTIES AND FACILITIES THROUGH FINANCIAL CONTRACTS. The following agencies may enter into financial contracts, paid for from operating revenues, for the purposes indicated and in not more than the principal amounts indicated, plus financing expenses and required reserves pursuant to chapter 39.94 RCW. When securing properties under this section, agencies shall use the most economical financial contract option available, including long-term leases, leasepurchase agreements, lease-development with option to purchase agreements or financial contracts using certificates of participation. The director of general administration shall ensure that the clustering of state facilities and the collocation and consolidation of state agencies take place where such configurations are economical and consistent with agency space needs. Agencies shall assist the department of general administration with facility collocation and consolidation efforts.

State agencies may enter into agreements with the department of general administration and the state treasurer's office to develop requests to the legislature for acquisition of properties and

- 1 facilities through financial contracts. The agreements may include 2 charges for services rendered.
  - (1) Department of general administration:
- 4 (a) Enter into a financing contract in the amount of \$8,804,000 5 plus financing expenses and required reserves pursuant to chapter 39.94 6 RCW, to purchase an existing office building and associated land in 7 Yakima for use by the department of social and health services.
  - (b) Enter into a financing contract in the amount of \$2,874,100 plus financing expenses and required reserves pursuant to chapter 39.94 RCW, to purchase and renovate the old federal building and associated land in Olympia for use by the secretary of state.
- (c) Enter into a financing contract in the amount of \$6,990,000 plus financing expenses and required reserves pursuant to chapter 39.94 RCW, to buy out the lease and make improvements to the old Thurston county courthouse for use by the office of attorney general. The department of general administration shall advise and assist the office of attorney general on space and functional planning to improve the efficient use of the facility.

- 20 Enter into a long-term lease for a headquarters office in Thurston 21 County for approximately 46,000 square feet.
  - (3) Department of corrections:
  - (a) Enter into a long-term ground lease for ((17 acres in the Tacoma tide flats property from the Puyallup Nation)) approximately 12 acres with a purchase option for development of the 400-bed Tacoma prerelease facility for approximately \$360,000 per annum. ((Prior to entering into the lease, the department shall obtain written confirmation from the city of Tacoma and Pierce county that the prerelease facility planned for the site meets all land use, environmental protection, and community notification requirements that would apply to the facility if the land was not owned by the Puyallup nation.))
  - (b) Enter into a financing contract on behalf of the department of corrections in the amount of \$14,736,900 plus financing expenses and required reserves pursuant to chapter 39.94 RCW to construct a 400-bed Tacoma prerelease facility. The department of corrections shall comply with all land use, environmental protection, and community notification statutes, regulations, and ordinances in the construction and operation of this facility.

- (c) Lease-develop with the option to purchase or lease-purchase 1 2 approximately 100 work release beds in facilities throughout the state 3 for \$5,000,000.
- 4 (d) Enter into a financing contract on behalf of the department of corrections in the amount of \$396,369 plus financing expenses and required reserves pursuant to chapter 39.94 RCW to construct a dairy 6 barn at the Monroe farm. 7
  - (e) Enter into a financing contract on behalf of the department of corrections in the amount of \$2,100,000 plus financing expenses and required reserves pursuant to chapter 39.94 RCW to purchase or construct a correctional industries transportation services warehouse.

- 13 (a) Enter into a financing contract on behalf of Whatcom Community College in the amount of \$800,000 plus financing expenses and required 14 15 reserves pursuant to chapter 39.94 RCW to develop a childcare center 16 costing \$2,410,000. The balance of project cost will be a combination 17 of local capital funds and nonstate funds provided through private gifts or contributions. 18
  - (b) Enter into a financing contract on behalf of Pierce College in the amount of \$750,000 plus financing expenses and required reserves pursuant to chapter 39.94 RCW to develop a new classroom building on the Lakewood campus costing \$1,816,665. The balance of project cost will be provided through a combination of local capital funds and existing minor works appropriation to replace relocatable classrooms that are at the end of their useful lives.
- 26 (c) Enter into a financing contract in behalf of Bellingham 27 Technical College in the amount of \$350,000 plus financing expenses and required reserves pursuant to chapter 39.94 RCW for construction of a 28 29 new classroom addition to the diesel/heavy equipment instructional shop 30 costing \$411,309.
- 31 (d) Enter into a financing contract on behalf of Green River Community College in the amount of \$1,526,150 plus financing expenses 32 33 and reserves pursuant to chapter 39.94 RCW for remodel of the Lindbloom 34 student center building.
- 35 (e) Enter into a financing contract on behalf of Edmonds Community College in the amount of \$2,787,950 plus financing expenses and 36 37 required reserves pursuant to chapter 39.94 RCW to develop a 10,000 square foot music building on the college campus. 38

- (f) Enter into a financing contract on behalf of Highline Community College in the amount of \$2,070,613 plus financing and required reserves pursuant to chapter 39.94 RCW for the purchase of the Federal Way Center, currently being leased by the college.
- 5 (g) Enter into a financial contract on behalf of Green River 6 Community College in the amount of \$100,000 plus financing and required 7 reserves pursuant to chapter 39.94 RCW to purchase approximately 1.5 8 acres of land adjacent to the westside parking lot.
- 9 (h) Enter into a financial contract on behalf of South Puget Sound 10 Community College in the amount of \$619,210 plus financing and required 11 reserves pursuant to chapter 39.94 RCW to expand and redevelop the main 12 campus parking lot A.
- (i) Enter into a financial contract on behalf of South Puget Sound Community College in the amount of \$5,500,000 plus financing and required reserves pursuant to chapter 39.94 RCW to develop a \$6,500,000 student union facility.
- (j) Enter into a financial contract on behalf of Wenatchee Valley
  College in the amount of \$500,000 plus financing and required reserves
  pursuant to chapter 39.94 RCW to purchase two buildings and property
  contiguous to the college campus.

- Enter into a financing contract on behalf of state parks and recreation in the amount of \$2,012,000 plus financing expenses and required reserves pursuant to chapter 39.94 RCW, to construct cabin and lodge facilities at Cama Beach, develop new campsite electrical hookups, develop new recreational facilities, and expand campsites at Ocean Beach/Grayland. It is the intent of the legislature that debt service on all projects financed under this authority be paid from operating revenues.
- (6) Washington state patrol:
- Enter into a financing contract for \$600,000 plus financing expenses and required reserves pursuant to chapter 39.94 RCW to purchase the Washington state patrol Port Angeles detachment office.
- NEW SECTION. Sec. 6. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the
