- 1 AN ACT Relating to minimum salaries for full-time certificated
- 2 instructional staff; and amending RCW 28A.400.200.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 28A.400.200 and 1997 c 141 s 2 are each amended to 5 read as follows:
- 6 (1) Every school district board of directors shall fix, alter, 7 allow, and order paid salaries and compensation for all district 8 employees in conformance with this section.
- 9 (2)(a) Salaries for certificated instructional staff shall not be
 10 less than the salary provided in the appropriations act in the state11 wide salary allocation schedule for an employee with a baccalaureate
- 12 degree and zero years of service: PROVIDED, That the minimum salary
- 13 for full-time certificated instructional staff shall be twenty-nine
- 14 thousand five hundred dollars per year; and
- 15 (b) Salaries for certificated instructional staff with a masters
- 16 degree shall not be less than the salary provided in the appropriations
- 17 act in the state-wide salary allocation schedule for an employee with
- 18 a masters degree and zero years of service;

(3)(a) The actual average salary paid to basic education and special education certificated instructional staff shall not exceed the district's average basic education and special education program certificated instructional staff salary used for the state basic education allocations for that school year as determined pursuant to RCW 28A.150.410.

- 7 (b) Fringe benefit contributions for basic education and special 8 education certificated instructional staff shall be included as salary under (a) of this subsection only to the extent that the district's 9 10 actual average benefit contribution exceeds the amount of the insurance benefits allocation provided per certificated instructional staff unit 11 in the state operating appropriations act in effect at the time the 12 13 compensation is payable. For purposes of this section, fringe benefits 14 shall not include payment for unused leave for illness or injury under 28A.400.210; employer contributions for old age survivors 15 insurance, workers' compensation, unemployment compensation, and 16 17 retirement benefits under the Washington state retirement system; or employer contributions for health benefits in excess of the insurance 18 19 benefits allocation provided per certificated instructional staff unit 20 in the state operating appropriations act in effect at the time the compensation is payable. A school district may not use state funds to 21 provide employer contributions for such excess health benefits. 22
 - (c) Salary and benefits for certificated instructional staff in programs other than basic education and special education shall be consistent with the salary and benefits paid to certificated instructional staff in the basic education and special education programs.
- (4) Salaries and benefits for certificated instructional staff may 28 29 exceed the limitations in subsection (3) of this section only by 30 separate contract for additional time, additional responsibilities, or 31 incentives. Supplemental contracts shall not cause the state to incur any present or future funding obligation. Supplemental contracts shall 32 be subject to the collective bargaining provisions of chapter 41.59 RCW 33 34 and the provisions of RCW 28A.405.240, shall not exceed one year, and if not renewed shall not constitute adverse change in accordance with 35 RCW 28A.405.300 through 28A.405.380. No district may enter into a 36 37 supplemental contract under this subsection for the provision of services which are a part of the basic education program required by 38 39 Article IX, section 3 of the state Constitution.
