- 1 AN ACT Relating to sales and use tax relief for disaster victims;
- 2 adding new sections to chapter 82.08 RCW; and adding new sections to
- 3 chapter 82.12 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.08 RCW 6 to read as follows:
- 7 The tax levied by RCW 82.08.020 shall not apply to charges made for
- 8 labor and services rendered with respect to repairing damaged
- 9 residential buildings or constructing new residential buildings to
- 10 replace residential buildings destroyed by inclement weather, if the
- 11 buildings are located in a county that the governor has declared to be
- 12 in a disaster area as a result of the inclement weather, or to sales of
- 13 tangible personal property which becomes an ingredient or component of
- 14 such residential buildings during the course of such repair or
- 15 construction, but only if the buyer provides the seller with an
- 16 exemption certificate in a form and manner prescribed by the department
- 17 by rule.

- 1 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.08 RCW
- 2 to read as follows:
- 3 The tax levied by RCW 82.08.020 shall not apply to sales of
- 4 tangible personal property to a resident of a county that the governor
- 5 has declared to be in a disaster area as a result of inclement weather,
- 6 if the property replaces household goods, personal effects, or private
- 7 automobiles, lost or destroyed in the inclement weather, but only if
- 8 the buyer provides the seller with an exemption certificate in a form
- 9 and manner prescribed by the department by rule.
- 10 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 82.12 RCW
- 11 to read as follows:
- 12 The provisions of this chapter shall not apply in respect to the
- 13 use of tangible personal property which becomes an ingredient or
- 14 component of residential buildings during the course of repairing
- 15 residential buildings or constructing new residential buildings to
- 16 replace residential buildings damaged or destroyed by inclement
- 17 weather, if the buildings are located in a county that the governor has
- 18 declared to be in a disaster area as a result of the inclement weather.
- 19 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 82.12 RCW
- 20 to read as follows:
- 21 The provisions of this chapter shall not apply in respect to the
- 22 use of tangible personal property by a resident of a county that the
- 23 governor has declared to be in a disaster area as a result of inclement
- 24 weather, if the property replaces household goods, personal effects, or
- 25 private automobiles, lost or destroyed due to the inclement weather.
