## SUBSTITUTE SENATE BILL 5430

- 1 AN ACT Relating to the women's health advisory committee; adding
- 2 new sections to chapter 43.70 RCW; and making appropriations.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Until recently, little attention has been NEW SECTION. Sec. 1. 5 given to the detection, treatment, and prevention of disease as specifically related to the unique needs and experiences of women. The 6 purpose of establishing the women's health advisory committee is to provide input to the department in order to achieve equity in policy 8 considerations and decisions affecting women's health, including the 9 10 administration, funding, and delivery of medical care and health carerelated services, and additional opportunities for basic and applied 11 12 research directly affecting women's health.
- 13 <u>NEW SECTION.</u> **Sec. 2.** The women's health advisory committee is
- 14 created. The governor shall appoint the ten members of the committee.
- 15 Committee members shall serve for a term of two years which may be
- 16 renewed. The committee shall include one member from each major caucus
- 17 of the house of representatives and the senate, two representatives
- 18 from the department of health, one representative from the department

- 1 of social and health services, two representatives from state-wide
- 2 women's health advocacy organizations, and one representative from the
- 3 University of Washington school of public health.
- 4 The committee shall elect one of its members as chair. In any
- 5 situation requiring a vote, the chair shall cast the deciding vote.
- 6 The committee shall meet no less than twice per calendar year at dates
- 7 specified by the chair or a majority of the members.
- 8 The members of the committee shall be compensated in accordance
- 9 with RCW 43.03.220 and shall be reimbursed for travel expenses incurred
- 10 in carrying out the duties of the committee in accordance with RCW
- 11 43.03.050 and 43.03.060.
- 12 The department shall provide administrative and clerical assistance
- 13 to the committee.
- 14 <u>NEW SECTION.</u> **Sec. 3.** The women's health advisory committee shall
- 15 advise the department with regard to:
- 16 (1) Strategic planning to improve the department's public health
- 17 services and programs targeting women;
- 18 (2) Analysis of departmental policies regarding specific issues
- 19 related to women's health;
- 20 (3) Coordination of pilot projects and planning projects funded by
- 21 the state that are related to women's health;
- 22 (4) Dispersing information to the public regarding women's health,
- 23 data, strategies, and programs that address women's health issues,
- 24 including pregnancy, breast and cervical cancers, AIDS, osteoporosis,
- 25 and menopause, as well as issues that impact women's health, including
- 26 substance abuse, domestic violence, housing, teenage pregnancy, and
- 27 sexual assault;
- 28 (5) The identification of public and private sources of funding for
- 29 initiatives in women's health; and
- 30 (6) Ways to encourage innovative responses by public and private
- 31 entities that seek to address women's health issues.
- 32 <u>NEW SECTION.</u> **Sec. 4.** Sections 1 through 3 of this act are each
- 33 added to chapter 43.70 RCW.
- NEW SECTION. Sec. 5. (1) The sum of ten thousand dollars, or as
- 35 much thereof as may be necessary, is appropriated for the fiscal year
