- 1 **Sec. 2.** RCW 81.60.070 and 1992 c 7 s 60 are each amended to read 2 as follows:
- 3 Every person who, in such manner as might, if not discovered,
- 4 endanger the safety of any engine, motor, car or train, or any person
- 5 thereon, shall in any manner interfere or tamper with or obstruct any
- 6 switch, frog, rail, roadbed, sleeper, viaduct, bridge, trestle,
- 7 culvert, embankment, structure, or appliance pertaining to or connected
- 8 with any railway, or any train, engine, motor, or car on such railway,
- 9 and every person who shall discharge any firearm or throw any dangerous
- 10 missile at any train, engine, motor, or car on any railway, shall be
- 11 punished by imprisonment in a state correctional facility for not more
- 12 than ((twenty-five)) ten years.
- 13 **Sec. 3.** RCW 9.40.120 and 1971 ex.s. c 302 s 4 are each amended to
- 14 read as follows:
- 15 Every person who possesses, manufactures, or disposes of an
- 16 incendiary device knowing it to be such is guilty of a felony, and upon
- 17 conviction, shall be punished by imprisonment in a state prison for a
- 18 term of not more than ((twenty-five)) ten years.
- 19 <u>NEW SECTION.</u> **Sec. 4.** The code reviser shall alphabetize the
- 20 offenses within each seriousness level in RCW 9.94A.320, including any
- 21 offenses added in the 1999 legislative session.
- 22 <u>NEW SECTION.</u> **Sec. 5.** The amendments made by this act shall apply
- 23 to offenses committed on or after July 1, 1999.
- 24 <u>NEW SECTION.</u> **Sec. 6.** This act is necessary for the immediate
- 25 preservation of the public peace, health, or safety, or support of the
- 26 state government and its existing public institutions, and takes effect
- 27 July 1, 1999.
