SUBSTITUTE SENATE BILL 5792

- 1 AN ACT Relating to the recommendations of the state board of
- 2 education based on its review of its statutory authority; amending RCW
- 3 28A.205.010, 28A.205.020, 28A.205.040, 28A.225.160, 28A.300.040, and
- 4 28A.305.130; creating a new section; and repealing RCW 28A.410.010.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. During 1997 and 1998, a committee of the
- 7 state board of education reviewed all board rules and related
- 8 authorizing statutes. Based on the findings and recommendations
- 9 resulting from the review, the state board prepared a report to the
- 10 legislature requesting action be taken. It is the intent of this act
- 11 to implement recommendations of the state board of education.
- 12 **Sec. 2.** RCW 28A.205.010 and 1993 c 211 s 1 are each amended to
- 13 read as follows:
- 14 (1) As used in this chapter, unless the context thereof shall
- 15 clearly indicate to the contrary:
- 16 "Education center" means any private school operated on a profit or
- 17 nonprofit basis which does the following:

- 1 (a) Is devoted to the teaching of basic academic skills, including 2 specific attention to improvement of student motivation for achieving, 3 and employment orientation.
- (b) Operates on a clinical, client centered basis. This shall include, but not be limited to, performing diagnosis of individual educational abilities, determination and setting of individual goals, prescribing and providing individual courses of instruction therefor, and evaluation of each individual client's progress in his or her educational program.
- (c) Conducts courses of instruction by professionally trained personnel certificated by the state board of education according to rules ((and regulations promulgated)) adopted for the purposes of this chapter and providing, for certification purposes, that a year's teaching experience in an education center shall be deemed equal to a year's teaching experience in a common or private school.
- 16 (2) For purposes of this chapter, basic academic skills shall
 17 include the study of mathematics, speech, language, reading and
 18 composition, science, history, literature and political science or
 19 civics; it shall not include courses of a vocational training nature
 20 and shall not include courses deemed nonessential to the accrediting of
 21 the common schools or the approval of private schools under RCW
 22 28A.305.130.
 - (3) The state board of education shall certify an education center only upon application and (a) determination that such school comes within the definition thereof as set forth in subsection (1) ((above)) of this section and (b) demonstration on the basis of actual educational performance of such applicants' students which shows after consideration of their students' backgrounds, educational gains that are a direct result of the applicants' educational program. Such certification may be withdrawn if the board finds that a center fails to provide adequate instruction in basic academic skills. No education center certified by the state board of education pursuant to this section shall be deemed a common school under RCW 28A.150.020 or a private school for the purposes of RCW 28A.195.010 through 28A.195.050.
- 35 **Sec. 3.** RCW 28A.205.020 and 1997 c 265 s 7 are each amended to 36 read as follows:
- Only eligible common school dropouts shall be enrolled in a sertified education center for reimbursement by the superintendent of

public instruction as provided in RCW 28A.205.040. A person is not an eligible common school dropout if: (1) The person has completed high 2 school, (2) the person has not reached his or her twelfth birthday or 3 4 has passed his or her twentieth birthday, (3) the person shows proficiency beyond the high school level in a test approved by the 5 ((superintendent of public instruction)) state board of education to be 6 7 given as part of the initial diagnostic procedure, or (4) less than one 8 month has passed after the person has dropped out of any common school 9 and the education center has not received written verification from a 10 school official of the common school last attended in this state that the person is no longer in attendance at the school. A person is an 11 eligible common school dropout even if one month has not passed since 12 the person dropped out if the board of directors or its designee, of 13 14 that common school, requests the center to admit the person because the 15 person has dropped out or because the person is unable to attend a 16 particular common school because of disciplinary reasons, including suspension and/or expulsion. The fact that any person may be subject 17 to RCW 28A.225.010 through ((28A.225.150)) <u>28A.225.140</u>, 28A.200.010, 18 19 and 28A.200.020 shall not affect his or her qualifications as an eligible common school dropout under this chapter. 20

(1)(a) From funds appropriated for that purpose, the superintendent of public instruction shall pay <u>fees</u> to a certified ((clinic)) <u>center</u> on a monthly basis for each student enrolled in compliance with RCW 28A.205.020((, fees in accordance with the following conditions:

(1)(a) The fee for the initial diagnostic procedure shall be not more than fifty dollars per student, and hourly fees for each student shall be sixteen dollars if the class size is no greater than one, ten dollars if the class size is at least two and no greater than five, and five dollars if the class size is at least six: PROVIDED, That)). The superintendent shall set fees by rule.

(b) Revisions in such fees proposed by an education ((clinic)) center shall become effective after thirty days notice unless the superintendent finds such a revision is unreasonable in which case the revision shall not take effect((: PROVIDED FURTHER, That)). - (4)(a) The state board of education shall adopt rules to allow a 1 2 teacher certification candidate to fulfill, in part, teacher preparation program requirements through work experience 3 4 classified teacher's aide in a public school or private school meeting the requirements of RCW 28A.195.010. The rules shall include, but are 5 not limited to, limitations based upon the recency of the teacher 6 7 preparation candidate's teacher aide work experience, and limitations 8 based on the amount of work experience that may apply toward teacher 9 preparation program requirements under this chapter $((\cdot, \cdot))$:

In compliance with such rules as may be 25 established by the state board of education under this section, the teacher preparation programs of the higher education institution where 26 27 the candidate is enrolled shall make the final determination as to what teacher preparation program requirements may be fulfilled by teacher 28 29 aide work experience((-));
 - (5) Supervise the issuance of such certificates as provided for in subsection (1) ((above)) of this section and specify the types and kinds of certificates necessary for the several departments of the common schools by rule ((or regulation in accordance with RCW 28A.410.010.));

- (9) Make rules ((and regulations)) governing the establishment in any existing nonhigh school district of any secondary program or any new grades in grades nine through twelve. Before any such program or any new grades are established the district must obtain prior approval of the state board((\cdot, \cdot)):
- (((+8))) (10) Prepare such outline of study for the common schools as the board shall deem necessary, and prescribe such rules for the general government of the common schools, as shall seek to secure regularity of attendance, prevent truancy, secure efficiency, and promote the true interest of the common schools((-));
- (((+9+))) (11) Continuously reevaluate courses and adopt and enforce ((regulations)) rules within the common schools so as to meet the

The state board of education ((is given the authority to promulgate)) may adopt information and rules dealing with the prevention of child abuse for purposes of curriculum use in the common

NEW SECTION. Sec. 8. RCW 28A.410.010 (Certification--State board duty--Rules and regulations--Record check--Superintendent of public instruction as administrator) and 1992 c 159 s 3 & 1992 c 60 s 2 are each repealed.
