- 8 (iii) Violations of RCW 9A.44.040 or 9A.44.050 if the rape is 9 reported to a law enforcement agency within one year of its commission; 10 except that if the victim is under fourteen years of age when the rape is committed and the rape is reported to a law enforcement agency 11 within one year of its commission, the violation may be prosecuted up 12 to three years after the victim's eighteenth birthday or up to ten 13 years after the rape's commission, whichever is later. - 8 $((\frac{1}{j}))$ (i) No misdemeanor may be prosecuted more than one year 9 after its commission.
- 10 (2) The periods of limitation prescribed in subsection (1) of this 11 section do not run during any time when the person charged is not 12 usually and publicly resident within this state.
- 13 (3) If, before the end of a period of limitation prescribed in 14 subsection (1) of this section, an indictment has been found or a 15 complaint or an information has been filed, and the indictment, 16 complaint, or information is set aside, then the period of limitation 17 is extended by a period equal to the length of time from the finding or 18 filing to the setting aside.
