1 AN ACT Relating to fur and fur products from domestic dogs and 2 cats; reenacting and amending RCW 9.94A.320; adding a new section to 3 chapter 9.08 RCW; creating a new section; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. This act does not remove or decrease any of 6 the exemptions from statutes that now apply to procedures for injuries 7 or damage caused by dogs or cats, customary animal husbandry practices, 8 state game laws, or medical research otherwise authorized under federal 9 or state law.

10 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 9.08 RCW 11 to read as follows:

(1)(a) It is unlawful for any person to trap, take, shelter, tend, feed, or kill a domestic dog or cat for the direct or indirect purpose of dealing in the fur or pelt of, or products that include the fur or pelt of, a domestic dog or cat.

16 (b) The first conviction under this subsection is a gross 17 misdemeanor punishable under RCW 9A.20.021(2), and by a mandatory fine 18 of not less than five hundred dollars. A second or subsequent 1 conviction under this section is a class C felony punishable under RCW 2 9A.20.021(1)(c), and by a mandatory fine of not less than one thousand 3 dollars.

4 (2)(a) It is unlawful for any person to negligently buy, import,
5 sell, barter, or exchange for profit the fur or pelt of a domestic dog
6 or cat or products that include the fur or pelt of a domestic dog or
7 cat.

8 (b)(i) The first conviction under this subsection is a misdemeanor 9 punishable under RCW 9A.20.021(3), and by a mandatory fine of not less 10 than two hundred fifty dollars.

(ii) A second conviction under this subsection is a gross misdemeanor punishable under RCW 9A.20.021(2), and by a mandatory fine of not less than five hundred dollars.

(iii) A third or subsequent conviction under this section is a
class C felony punishable under RCW 9A.20.021(1)(c), and by a mandatory
fine of not less than one thousand dollars.

(3) The fines imposed under this section shall not be suspended ordeferred in whole or part.
