1 AN ACT Relating to aquatic nuisance species; amending RCW
2 77.12.020; and adding a new chapter to Title 75 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** (1) The aquatic nuisance species committee
5 is created for the purpose of fostering state, federal, tribal, and
6 private cooperation on aquatic nuisance species issues. The mission of
7 the committee is to minimize the unauthorized or accidental
8 introduction of nonnative aquatic species and give special emphasis to
9 preventing the introduction and spread of aquatic nuisance species.
10 The term "aquatic nuisance species" means a nonnative aquatic plant or
11 animal species that threatens the diversity or abundance of native
12 species, the ecological stability of infested waters, or commercial,
13 agricultural, or recreational activities dependent on such waters.

14 (2) The committee consists of representatives from each of the
15 following state agencies: Department of fish and wildlife, department
16 of ecology, department of agriculture, department of health, department
17 of natural resources, Puget Sound water quality action team, state
18 patrol, state noxious weed control board, and Washington sea grant
19 program. The committee shall encourage and solicit participation by:

1 Federally recognized tribes of Washington, federal agencies, Washington
2 conservation organizations, and representatives from industries that
3 may either be affected by the introduction of an aquatic nuisance
4 species or that may serve as a pathway for their introduction.

5 (3) The committee has the following duties:

6 (a) Periodically revise the state of Washington aquatic nuisance
7 species management plan, originally published in June 1998;

8 (b) Recommend to the fish and wildlife commission that an animal be
9 classified by the commission as an aquatic nuisance species;

10 (c) Recommend to the state noxious weed control board that a plant
11 be classified under the process designated by RCW 17.10.080 as an
12 aquatic noxious weed;

13 (d) Coordinate education, research, regulatory authorities,
14 monitoring and control programs, and participate in regional and
15 national efforts regarding aquatic nuisance species;

16 (e) Consult with representatives from industries and other
17 activities that may serve as a pathway for the introduction of aquatic
18 nuisance species to develop practical strategies that will minimize the
19 risk of new introductions; and

20 (f) Prepare a biennial report to the legislature with the first
21 report due by December 1, 2001, making recommendations for better
22 accomplishing the purposes of this chapter, and listing the
23 accomplishments of this chapter to date.

24 (4) The committee shall accomplish its duties through the authority
25 and cooperation of its member agencies. Implementation of all plans
26 and programs developed by the committee shall be through the member
27 agencies and other cooperating organizations.

28 **Sec. 2.** RCW 77.12.020 and 1994 c 264 s 53 are each amended to read
29 as follows:

30 (1) The director shall investigate the habits and distribution of
31 the various species of wildlife native to or adaptable to the habitats
32 of the state. The commission shall determine whether a species should
33 be managed by the department and, if so, classify it under this
34 section.

35 (2) The commission may classify by rule wild animals as game
36 animals and game animals as fur-bearing animals.

1 (3) The commission may classify by rule wild birds as game birds or
2 predatory birds. All wild birds not otherwise classified are protected
3 wildlife.

4 (4) In addition to those species listed in RCW 77.08.020, the
5 commission may classify by rule as game fish other species of the class
6 Osteichthyes that are commonly found in fresh water except those
7 classified as food fish by the director.

8 (5) The director may recommend to the commission that a species of
9 wildlife should not be hunted or fished. The commission may designate
10 species of wildlife as protected.

11 (6) If the director determines that a species of wildlife is
12 seriously threatened with extinction in the state of Washington, the
13 director may request its designation as an endangered species. The
14 commission may designate an endangered species.

15 (7) If the director determines that a species of the animal
16 kingdom, not native to Washington, is dangerous to the environment or
17 wildlife of the state, the director may request its designation as
18 deleterious exotic wildlife. The commission may designate deleterious
19 exotic wildlife.

20 (8) The commission may classify aquatic nuisance species either (a)
21 if the director determines that an aquatic animal species that is not
22 native to Washington threatens the diversity or abundance of native
23 species, the ecological stability of infested waters, or commercial,
24 agricultural, or recreational activities dependent on such waters, then
25 the director may request its classification as an aquatic nuisance
26 species; or (b) upon recommendation of the aquatic nuisance species
27 committee, created in section 1 of this act.

28 NEW SECTION. Sec. 3. Section 1 of this act constitutes a new
29 chapter in Title 75 RCW.
