- 1 AN ACT Relating to funding the municipal research council; amending
- 2 RCW 66.08.190 and 43.110.030; adding a new section to chapter 43.110
- 3 RCW; providing an effective date; and declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 43.110 RCW 6 to read as follows:
- 7 The city and town research services account is created in the state
- 8 treasury. Moneys in the account shall consist of amounts transferred
- 9 under RCW 66.08.190(2) and any other transfers or appropriations to the
- 10 account. Moneys in the account may be spent only after an
- 11 appropriation. Expenditures from the account may be used only for city
- 12 and town research.
- 13 Unobligated moneys remaining in the account at the end of the
- 14 fiscal biennium shall be distributed by the treasurer to the
- 15 incorporated cities and towns of the state under RCW 66.08.190(1)(b).
- 16 The treasurer may disburse amounts appropriated to the municipal
- 17 research council from the city and town research services account by
- 18 warrant or check to the contracting parties on invoices or vouchers
- 19 certified by the chair of the municipal research council or his or her

- 1 designee. Payments to public agencies may be made in advance of actual
- 2 work contracted for, at the discretion of the council.
- 3 **Sec. 2.** RCW 66.08.190 and 1995 c 159 s 1 are each amended to read 4 as follows:
- 5 <u>(1)</u> When excess funds are distributed, all moneys subject to distribution shall be disbursed as follows:
- 7 $((\frac{1}{1}))$ (a) Three-tenths of one percent to border areas under RCW 8 66.08.195; and
- 9 ((\(\frac{(2)}{2}\))) (\(\begin{aligned} \begin{aligned} \be
- (2) Beginning with the first quarter of fiscal year 2001, and each quarter thereafter, prior to disbursing the forty percent distribution to incorporated cities and towns under subsection (1)(b) of this section, the treasurer shall deduct from that distribution an amount equal to one-fourth of that fiscal year's appropriations for the municipal research council for deposit into the city and town research services account under section 1 of this act.
- 20 (3) The governor may notify and direct the state treasurer to withhold the revenues to which the counties and cities are entitled 22 under this section if the counties or cities are found to be in 23 noncompliance pursuant to RCW 36.70A.340.
- 24 **Sec. 3.** RCW 43.110.030 and 1997 c 437 s 2 are each amended to read 25 as follows:
- The municipal research council shall contract for the provision of 26 27 municipal research and services to cities, towns, and counties. 28 Contracts for municipal research and services shall be made with state 29 agencies, educational institutions, or private consulting firms, that in the judgment of council members are qualified to provide such 30 research and services. Contracts for staff support may be made with 31 32 state agencies, educational institutions, or private consulting firms 33 that in the judgment of the council members are qualified to provide 34 such support.
- Municipal research and services shall consist of: (1) Studying and researching city, town, and county government and issues relating to city, town, and county government; (2) acquiring, preparing, and

distributing publications related to city, town, and county government 1 2 and issues relating to city, town, and county government; (3) providing educational conferences relating to city, town, and county government 3 4 and issues relating to city, town, and county government; and (4) furnishing legal, technical, consultative, and field services to 5 cities, towns, and counties concerning planning, public health, utility 6 7 services, fire protection, law enforcement, public works, and other 8 issues relating to city, town, and county government. Requests for 9 legal services by county officials shall be sent to the office of the 10 county prosecuting attorney. Responses by the municipal research council to county requests for legal services shall be provided to the 11 12 requesting official and the county prosecuting attorney. 13

The activities, programs, and services of the municipal research council shall be carried on, and all expenditures shall be made, in cooperation with the cities and towns of the state acting through the board of directors of the association of Washington cities, which is recognized as their official agency or instrumentality, and in cooperation with counties of the state acting through the Washington state association of counties. Services to cities and towns shall be based upon the moneys appropriated to the municipal research council ((under RCW 82.44.160)) from the city and town research services account under section 1 of this act. Services to counties shall be based upon the moneys appropriated to the municipal research council from the county research services account under RCW 43.110.050.
