18 (b) Enter into a financing contract on behalf of Highline Community
19 College in the amount of \$2,070,613 plus financing expenses and
20 required reserves pursuant to chapter 39.94 RCW for the purchase of the
21 Federal Way Center, currently being leased by the college.

22 (c) Enter into a financial contract on behalf of Green River
23 Community College in the amount of \$100,000 plus financing expenses and
24 required reserves pursuant to chapter 39.94 RCW to purchase
25 approximately 1.5 acres of land adjacent to the westside parking lot.

26 (d) Enter into a financing contract on behalf of Grays Harbor

19 (k) Enter into a financing contract on behalf of Yakima Valley
20 Community College in the amount of \$375,000 plus financing expenses and
21 required reserves pursuant to chapter 39.94 RCW for a 2,700 gross
22 square foot addition and remodeling to the existing student union
23 building costing \$1,400,000. Prior to commencing, the college shall
24 prepare and present a business plan describing the financing of the
25 complete project to the state board for community and technical
26 colleges, the office of financial management, and the legislative
27 fiscal committees.

28 (l) Enter into a financing contract on behalf of Peninsula
29 Community College in the amount of \$2,500,000 plus financing expenses

29 (t) Enter into a financing contract on behalf of Bates Technical
30 College in the amount of \$5,300,000 plus financing expenses and
31 required reserves pursuant to chapter 39.94 RCW for the purchase of a
32 9.41 acre site with an approximately 46,125 square foot broadcasting
33 facility situated on 19th Street in Tacoma.

34 (u) Enter into a financing contract on behalf of Renton Technical
35 College in the amount \$1,000,000 plus financing expenses and required
36 reserves pursuant to chapter 39.94 RCW for the purchase of
37 approximately 10 acres within the district boundary to support a future
38 relocation of apprenticeship programs off the main campus.

1 (5) Central Washington University: Enter into a financing contract
2 on behalf of Central Washington University in the amount of \$5,700,000
3 plus financing expenses and required reserves pursuant to chapter 39.94
4 RCW for the Central Washington University/Edmonds Community College
5 center.

6 (6) University of Washington:

7 (a) Enter into a financing contract on behalf of the University of
8 Washington in the amount of \$7,500,000 plus financing expenses and
9 required reserves pursuant to chapter 39.94 RCW to finance real
10 property improvements to the Sand Point building.

11 (b) Enter into a financing contract on behalf of the University of
12 Washington in the amount of \$7,500,000 plus financing expenses and
13 required reserves pursuant to chapter 39.94 RCW to finance primate
14 center tenant improvements.

15 (c) Enter into a financing contract on behalf of the University of
16 Washington in the amount of \$4,500,000 plus financing expenses and
17 required reserves pursuant to chapter 39.94 RCW for renovation of Sand
18 Point building 29 as office and storage space.

19 (d) Enter into a financing contract on behalf of the University of
20 Washington in the amount of \$12,000,000 plus financing expenses and
21 required reserves pursuant to chapter 39.94 RCW for renovation of Husky
22 Den, the food service in the Husky Union building, and the renovation
23 of the McMahon Hall food service.

24 (e) Enter into a financing contract on behalf of the University of
25 Washington in the amount of \$5,700,000 plus financing expenses and
26 required reserves pursuant to chapter 39.94 RCW for installation of
27 Ethernet wiring and electrical upgrades in Lander Hall and McCarty
28 Hall.

29 (7) Washington state convention and trade center: Enter into one
30 or more financing contracts not exceeding an aggregate total amount of
31 (~~(\$27,500,000)~~) \$32,100,000 plus financing expenses and reserves
32 pursuant to chapter 39.94 RCW, for funding unanticipated costs in
33 excess of the \$111,700,000 principal amount of the financing contract
34 authorized in section 802(10)(b), chapter 16, Laws of 1995 2nd sp.
35 sess., for the construction of the expansion of the Washington state
36 convention and trade center as authorized under chapter 386, Laws of
37 1995. The balance of the expansion project funds shall be provided
38 from interest earnings and public or private funds. The financing
39 contract or contracts representing all or part of the amount authorized

1 by this section shall not be executed without prior written approval of
2 the office of financial management based upon its determination that
3 such financing contract or contracts are reasonably necessary for the
4 expansion project.

5 (8) Department of health: Provides for authority to request the
6 department of general administration to procure a replacement leased
7 facility with an option to purchase for the department of health's
8 Thurston county offices. The development of the facility shall comply
9 with the department of general administration's specifications for
10 lease to own facilities for state office buildings.

11 NEW SECTION. Sec. 31. A new section is added to 1999 c 379 to
12 read as follows:

13 The director of the office of financial management is authorized to
14 transfer up to \$65,000,000 from the public works assistance account--
15 state to the state building construction account--state, when, in his
16 or her judgment there is a need to offset currently planned bond sales
17 levels to maintain a positive statutory debt capacity. In the event
18 that this transfer is not completed in full by October 1, 2000, the
19 public works board is authorized to prepare a list of additional
20 projects for this biennium. This list shall not exceed \$15,000,000 in
21 expenditures from the public works assistance account--state.

22 NEW SECTION. Sec. 32. This act is necessary for the immediate
23 preservation of the public peace, health, or safety, or support of the
24 state government and its existing public institutions, and takes effect
25 immediately.
