- 38 for investment choices in the future. All agency strategic plans shall

As the state's fiscal obligations pursuant to the 16 listing or proposed listing become clearer over time, it may be necessary to revisit funding decisions reflected in this act in order 17 18 to shift resources to meet those obligations. The department of 19 transportation, the transportation improvement board, and the county road administration board shall report to the legislature on December 20 1, 1999, and December 1, 2000, on capital project delay impacts, 21 22 including impact on costs and project delivery, due to the endangered 23 species act listing or proposed listing.

PERFORMANCE BASED BUDGETING. (1) The department of licensing, the department of transportation, the Washington state patrol, and the 6 Washington traffic safety commission, in cooperation with the office of financial management, the senate transportation committee, and the house of representatives transportation committee will continue the implementation of performance based budgeting. The performance based 10 budgeting process will provide a measurable link between agency 11 12 objectives, service levels, and budget. The agencies shall:

- 13 (a) Continue to develop, enhance, validate, and test indicators of 14 performance, stated in achieving the agencies' goals; and
- 15 (b) Refine performance based budgeting and investment levels in the 16 following programs:
- 17 (i) Department of transportation: Maintenance program M, 18 preservation program P, traffic operations program Q, and marine 19 program X;
- 20 Driver's services and vehicle (ii) Department of licensing: 21 services;
- 22 (iii) Washington state patrol: Field operations bureau; and
- 23 (iv) Washington traffic safety commission; and
- 24 (c) Submit and implement a plan to provide program managers with 25 the training and technical assistance necessary to extend the practices 26 of performance measurement and performance based budgeting throughout 27 agency programs.
- (2)(a) The agencies shall input monthly their financial information 28 29 and quarterly program performance measurements into the transportation 30 executive information system and will utilize the transportation executive information system investment system in the development of 31 32 their agency policy request budgets.
- (b) The department of licensing and the Washington state patrol 33 34 shall submit budgets to the legislature at the subprogram level.
- 35 (3) Transportation agencies shall comply with the requirements of 36 chapter 43.88 RCW when developing the 2001-03 biennial budget requests.
