- 1 AN ACT Relating to retention of records pertaining to sexually
- 2 violent offenses; amending RCW 40.14.060, 40.14.070, and 42.17.310; and
- 3 adding a new section to chapter 10.97 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 40.14.060 and 1982 c 36 s 5 are each amended to read 6 as follows:
- 7 (1) Any destruction of official public records shall be pursuant to
- 8 a schedule approved under RCW 40.14.050. Official public records shall
- 9 not be destroyed unless:
- 10 (a) Except as provided under RCW 40.14.070(2)(b), the records are
- 11 six or more years old;
- 12 (b) The department of origin of the records has made a satisfactory
- 13 showing to the state records committee that the retention of the
- 14 records for a minimum of six years is both unnecessary and
- 15 uneconomical, particularly if lesser federal retention periods for
- 16 records generated by the state under federal programs have been
- 17 established; or
- 18 (c) The originals of official public records less than six years
- 19 old have been copied or reproduced by any photographic or other process

1 approved by the state archivist which accurately reproduces or forms a 2 durable medium for so reproducing the original.

(2) Any lesser term of retention than six years must have the additional approval of the director of financial management, the state auditor and the attorney general, except when records have federal retention guidelines the state records committee may adjust the retention period accordingly. An automatic reduction of retention periods from seven to six years for official public records on record retention schedules existing on June 10, 1982, shall not be made, but the same shall be reviewed individually by the state records committee for approval or disapproval of the change to a retention period of six years.

Recommendations for the destruction or disposition of office files and memoranda shall be submitted to the records committee upon approved forms prepared by the records officer of the agency concerned and the archivist. The committee shall determine the period of time that any office file or memorandum shall be preserved and may authorize the division of archives and records management to arrange for its destruction or disposition.

**Sec. 2.** RCW 40.14.070 and 1995 c 301 s 71 are each amended to read 21 as follows:

(1)(a) County, municipal, and other local government agencies may request authority to destroy noncurrent public records having no further administrative or legal value by submitting to the division of archives and records management lists of such records on forms prepared by the division. The archivist, a representative appointed by the state auditor, and a representative appointed by the attorney general shall constitute a committee, known as the local records committee, which shall review such lists and which may veto the destruction of any or all items contained therein.

(b) A local government agency, as an alternative to submitting lists, may elect to establish a records control program based on recurring disposition schedules recommended by the agency to the local records committee. The schedules are to be submitted on forms provided by the division of archives and records management to the local records committee, which may either veto, approve, or amend the schedule. Approval of such schedule or amended schedule shall be by unanimous vote of the local records committee. Upon such approval, the schedule

- 2 the records listed thereon, after the required retention period, on a
- 3 recurring basis until the schedule is either amended or revised by the
- 4 committee.
- 5 (2)(a) Except as otherwise provided by law, no public records shall 6 be destroyed until approved for destruction by the local records
- 7 committee. Official public records shall not be destroyed unless:
- 8  $((\frac{1}{1}))$  (i) The records are six or more years old;
- 9  $((\frac{(2)}{2}))$  (ii) The department of origin of the records has made a
- 10 satisfactory showing to the state records committee that the retention
- 11 of the records for a minimum of six years is both unnecessary and
- 12 uneconomical, particularly where lesser federal retention periods for
- 13 records generated by the state under federal programs have been
- 14 established; or
- 15 (((3))) (iii) The originals of official public records less than
- 16 six years old have been copied or reproduced by any photographic,
- 17 photostatic, microfilm, miniature photographic, or other process
- 18 approved by the state archivist which accurately reproduces or forms a
- 19 durable medium for so reproducing the original.
- 20 An automatic reduction of retention periods from seven to six years
- 21 for official public records on record retention schedules existing on
- 22 June 10, 1982, shall not be made, but the same shall be reviewed
- 23 individually by the local records committee for approval or disapproval
- 24 of the change to a retention period of six years.
- 25 The state archivist may furnish appropriate information,
- 26 suggestions, and guidelines to local government agencies for their
- 27 assistance in the preparation of lists and schedules or any other
- 28 matter relating to the retention, preservation, or destruction of
- 29 records under this chapter. The local records committee may adopt
- 30 appropriate regulations establishing procedures to be followed in such
- 31 matters.
- Records of county, municipal, or other local government agencies,
- 33 designated by the archivist as of primarily historical interest, may be
- 34 transferred to a recognized depository agency.
- 35 (b) Records of investigative reports prepared by any state, county,
- 36 <u>municipal</u>, or other law enforcement agency pertaining to sex offenders
- 37 contained in chapter 9A.44 RCW or sexually violent offenses as defined
- 38 in RCW 71.09.020 that are not required in the current operation of the
- 39 law enforcement agency or for pending judicial proceedings shall,

- 1 following the expiration of the applicable schedule of the law
- 2 <u>enforcement agency's retention of the records</u>, be transferred to the
- 3 <u>Washington association of sheriffs and police chiefs for permanent</u>
- 4 <u>electronic retention and retrieval</u>. <u>Upon electronic retention of any</u>
- 5 document, the association shall be permitted to destroy the paper copy
- 6 of the document.
- 7 (c) Any record transferred to the Washington association of
- 8 sheriffs and police chiefs pursuant to (b) of this subsection shall be
- 9 deemed to no longer constitute a public record pursuant to RCW
- 10 <u>42.17.020</u> and shall be exempt from public disclosure. Such records
- 11 shall be disseminated only to criminal justice agencies as defined in
- 12 RCW 10.97.030 for the purpose of determining if a sex offender met the
- 13 criteria of a sexually violent predator as defined in chapter 71.09
- 14 RCW.
- 15 **Sec. 3.** RCW 42.17.310 and 1998 c 69 s 1 are each amended to read 16 as follows:
- 17 (1) The following are exempt from public inspection and copying:
- 18 (a) Personal information in any files maintained for students in
- 19 public schools, patients or clients of public institutions or public
- 20 health agencies, or welfare recipients.
- 21 (b) Personal information in files maintained for employees,
- 22 appointees, or elected officials of any public agency to the extent
- 23 that disclosure would violate their right to privacy.
- 24 (c) Information required of any taxpayer in connection with the
- 25 assessment or collection of any tax if the disclosure of the
- 26 information to other persons would (i) be prohibited to such persons by
- 27 RCW 84.08.210, 82.32.330, 84.40.020, or 84.40.340 or (ii) violate the
- 28 taxpayer's right to privacy or result in unfair competitive
- 29 disadvantage to the taxpayer.
- 30 (d) Specific intelligence information and specific investigative
- 31 records compiled by investigative, law enforcement, and penology
- 32 agencies, and state agencies vested with the responsibility to
- 33 discipline members of any profession, the nondisclosure of which is
- 34 essential to effective law enforcement or for the protection of any
- 35 person's right to privacy.
- 36 (e) Information revealing the identity of persons who are witnesses
- 37 to or victims of crime or who file complaints with investigative, law
- 38 enforcement, or penology agencies, other than the public disclosure

- commission, if disclosure would endanger any person's life, physical safety, or property. If at the time a complaint is filed the complainant, victim or witness indicates a desire for disclosure or nondisclosure, such desire shall govern. However, all complaints filed with the public disclosure commission about any elected official or candidate for public office must be made in writing and signed by the complainant under oath.
- 8 (f) Test questions, scoring keys, and other examination data used 9 to administer a license, employment, or academic examination.
- (g) Except as provided by chapter 8.26 RCW, the contents of real estate appraisals, made for or by any agency relative to the acquisition or sale of property, until the project or prospective sale is abandoned or until such time as all of the property has been acquired or the property to which the sale appraisal relates is sold, but in no event shall disclosure be denied for more than three years after the appraisal.
- (h) Valuable formulae, designs, drawings, and research data obtained by any agency within five years of the request for disclosure when disclosure would produce private gain and public loss.

- (i) Preliminary drafts, notes, recommendations, and intra-agency memorandums in which opinions are expressed or policies formulated or recommended except that a specific record shall not be exempt when publicly cited by an agency in connection with any agency action.
- (j) Records which are relevant to a controversy to which an agency is a party but which records would not be available to another party under the rules of pretrial discovery for causes pending in the superior courts.
- (k) Records, maps, or other information identifying the location of archaeological sites in order to avoid the looting or depredation of such sites.
- 31 (1) Any library record, the primary purpose of which is to maintain 32 control of library materials, or to gain access to information, which 33 discloses or could be used to disclose the identity of a library user.
- (m) Financial information supplied by or on behalf of a person, firm, or corporation for the purpose of qualifying to submit a bid or proposal for (i) a ferry system construction or repair contract as required by RCW 47.60.680 through 47.60.750 or (ii) highway construction or improvement as required by RCW 47.28.070.

- (n) Railroad company contracts filed prior to July 28, 1991, with the utilities and transportation commission under RCW 81.34.070, except that the summaries of the contracts are open to public inspection and copying as otherwise provided by this chapter.
  - (o) Financial and commercial information and records supplied by private persons pertaining to export services provided pursuant to chapter 43.163 RCW and chapter 53.31 RCW, and by persons pertaining to export projects pursuant to RCW 43.23.035.
- 9 (p) Financial disclosures filed by private vocational schools under 10 chapters 28B.85 and 28C.10 RCW.
- (q) Records filed with the utilities and transportation commission or attorney general under RCW 80.04.095 that a court has determined are confidential under RCW 80.04.095.
- (r) Financial and commercial information and records supplied by businesses or individuals during application for loans or program services provided by chapters 43.163, 43.160, 43.330, and 43.168 RCW, or during application for economic development loans or program services provided by any local agency.
- (s) Membership lists or lists of members or owners of interests of units in timeshare projects, subdivisions, camping resorts, condominiums, land developments, or common-interest communities affiliated with such projects, regulated by the department of licensing, in the files or possession of the department.
- (t) All applications for public employment, including the names of applicants, resumes, and other related materials submitted with respect to an applicant.
- (u) The residential addresses and residential telephone numbers of employees or volunteers of a public agency which are held by the agency in personnel records, employment or volunteer rosters, or mailing lists of employees or volunteers.
- (v) The residential addresses and residential telephone numbers of the customers of a public utility contained in the records or lists held by the public utility of which they are customers, except that this information may be released to the division of child support or the agency or firm providing child support enforcement for another state under Title IV-D of the federal social security act, for the establishment, enforcement, or modification of a support order.
- 38 (w)(i) The federal social security number of individuals governed 39 under chapter 18.130 RCW maintained in the files of the department of

- 26 (aa) Financial and commercial information supplied to the state
- 27 investment board by any person when the information relates to the
- 28 investment of public trust or retirement funds and when disclosure
- 29 would result in loss to such funds or in private loss to the providers
- 30 of this information.
- 31 (bb) Financial and valuable trade information under RCW 51.36.120.
- 32 (cc) Client records maintained by an agency that is a domestic
- 33 violence program as defined in RCW 70.123.020 or 70.123.075 or a rape
- 34 crisis center as defined in RCW 70.125.030.
- 35 (dd) Information that identifies a person who, while an agency
- 36 employee: (i) Seeks advice, under an informal process established by
- 37 the employing agency, in order to ascertain his or her rights in
- 38 connection with a possible unfair practice under chapter 49.60 RCW

- 1 against the person; and (ii) requests his or her identity or any 2 identifying information not be disclosed.
- 3 (ee) Investigative records compiled by an employing agency 4 conducting a current investigation of a possible unfair practice under 5 chapter 49.60 RCW or of a possible violation of other federal, state, 6 or local laws prohibiting discrimination in employment.
- 7 (ff) Business related information protected from public inspection 8 and copying under RCW 15.86.110.
- 9 (gg) Financial, commercial, operations, and technical and research 10 information and data submitted to or obtained by the clean Washington 11 center in applications for, or delivery of, program services under 12 chapter 70.95H RCW.
- (hh) Information and documents created specifically for, and collected and maintained by a quality improvement committee pursuant to RCW 43.70.510, regardless of which agency is in possession of the information and documents.
- 17 (ii) Personal information in files maintained in a data base 18 created under RCW 43.07.360.
- (jj) Financial and commercial information requested by the public stadium authority from any person or organization that leases or uses the stadium and exhibition center as defined in RCW 36.102.010.
- (kk) Names of individuals residing in emergency or transitional housing that are furnished to the department of revenue or a county assessor in order to substantiate a claim for property tax exemption under RCW 84.36.043.
- (11) The names, residential addresses, residential telephone numbers, and other individually identifiable records held by an agency in relation to a vanpool, carpool, or other ride-sharing program or service. However, these records may be disclosed to other persons who apply for ride-matching services and who need that information in order to identify potential riders or drivers with whom to share rides.
- (mm) Proprietary financial and commercial information that the 32 33 submitting entity, with review by the department of health, specifically identifies at the time it is submitted and that is 34 35 provided to or obtained by the department of health in connection with an application for, or the supervision of, an antitrust exemption 36 sought by the submitting entity under RCW 43.72.310. If a request for 37 such information is received, the submitting entity must be notified of 38 39 the request. Within ten business days of receipt of the notice, the

- 1 submitting entity shall provide a written statement of the continuing
- 2 need for confidentiality, which shall be provided to the requester.
- 3 Upon receipt of such notice, the department of health shall continue to
- 4 treat information designated under this section as exempt from

- 18 defined in RCW 71.09.020, which have been transferred to the Washington
- 19 <u>association of sheriffs and police chiefs for permanent electronic</u>
- 20 retention and retrieval pursuant to RCW 40.14.070(2)(b).
- 21 (2) Except for information described in subsection (1)(c)(i) of
- 22 this section and confidential income data exempted from public
- 23 inspection pursuant to RCW 84.40.020, the exemptions of this section
- 24 are inapplicable to the extent that information, the disclosure of
- 25 which would violate personal privacy or vital governmental interests,
- 26 can be deleted from the specific records sought. No exemption may be
- 27 construed to permit the nondisclosure of statistical information not
- 28 descriptive of any readily identifiable person or persons.
- 29 (3) Inspection or copying of any specific records exempt under the
- 30 provisions of this section may be permitted if the superior court in
- 31 the county in which the record is maintained finds, after a hearing
- or one county in which one record is married rands, dreef a neuring
- 32 with notice thereof to every person in interest and the agency, that
- 33 the exemption of such records is clearly unnecessary to protect any
- 34 individual's right of privacy or any vital governmental function.
- 35 (4) Agency responses refusing, in whole or in part, inspection of
- 36 any public record shall include a statement of the specific exemption
- 37 authorizing the withholding of the record (or part) and a brief
- 38 explanation of how the exemption applies to the record withheld.

- 1 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 10.97 RCW
- 2 to read as follows:
- 3 Nothing in RCW 40.14.060, 40.14.070, or 42.17.310 precludes
- 4 dissemination of criminal history record information, including
- 5 nonconviction data, for the purposes of this chapter.
