1 AN ACT Relating to deadlines for local reports to the secretary of  
2 transportation; and amending RCW 35.21.260 and 36.75.260.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 35.21.260 and 1984 c 7 s 19 are each amended to read  
5 as follows:

6 The governing authority of each city and town on or before  
7 ((March)) May 31st of each year shall submit such records and reports  
8 regarding street operations in the city or town to the secretary of  
9 transportation on forms furnished by him as are necessary to enable him  
10 to compile an annual report thereon.

11 **Sec. 2.** RCW 36.75.260 and 1984 c 7 s 31 are each amended to read  
12 as follows:

13 Each county legislative authority shall on or before ((March)) May  
14 31st of each year submit such records and reports to the secretary of  
15 transportation, on forms furnished by the department, as are necessary  
16 to enable the secretary to compile an annual report on county highway  
17 operations.
