- 15 (c) To purchase lottery tickets or shares authorized under chapter
- 16 67.70 RCW.
- 17 (2)(a) The department shall notify, in writing, all recipients of
- 18 electronic benefit cards that any violation of subsection (1) of this

- 1 (1) Any licensee authorized under this chapter is prohibited from 2 allowing the use of public assistance electronic benefit cards to 3 purchase lottery tickets or shares authorized under this chapter.
- 4 (2) Any licensee authorized under this chapter shall report to the 5 department of social and health services any known violations of 6 section 1 of this act.
