- 11 (1) "Contractor" means any person, firm, or corporation who or
- 12 which, in the pursuit of an independent business undertakes to, or
- 13 offers to undertake, or submits a bid to, construct, alter, repair, add
- 14 to, subtract from, improve, move, wreck or demolish, for another, any
- 15 building, highway, road, railroad, excavation or other structure,
- 16 project, development, or improvement attached to real estate or to do
- 17 any part thereof including the installation of carpeting or other floor
- 18 covering, the erection of scaffolding or other structures or works in
- 19 connection therewith or who installs or repairs roofing or siding; or,

- 1 who, to do similar work upon his or her own property, employs members
- 2 of more than one trade upon a single job or project or under a single
- 3 building permit except as otherwise provided herein. "Contractor'
- 4 includes any person, firm, ((or)) corporation, or other entity covered
- 5 by this subsection, whether or not registered as required under this

- 19 (1) An applicant for registration as a contractor shall submit an
- 20 application under oath upon a form to be prescribed by the director and
- 21 which shall include the following information pertaining to the

- 23 (a) Employer social security number.
- 24 (b) <u>Unified business identifier number, if required by the</u>
- 25 <u>department of revenue</u>.
- 26 (c) Evidence of workers' compensation coverage for the applicant's

- 9 (((g))) (h) The name and address of each partner if the applicant is a firm or partnership, or the name and address of the owner if the applicant is an individual proprietorship, or the name and address of the corporate officers and statutory agent, if any, if the applicant is a corporation or the name and address of all members of other business entities. The information contained in such application is a matter of public record and open to public inspection.
- 16 (2) The department may verify the workers' compensation coverage 17 information provided by the applicant under subsection $(1)((\frac{b}{b}))$ (c) 18 of this section, including but not limited to information regarding the 19 coverage of an individual employee of the applicant. If coverage is 20 provided under the laws of another state, the department may notify the 21 other state that the applicant is employing employees in Washington.
 - (3)(a) The department shall deny an application for registration if: (i) The applicant has been previously ((registered)) performing work subject to this chapter as a sole proprietor, partnership, ((er)) corporation, or other entity and the department has notice that the applicant has an unsatisfied final judgment against him or her in an action based on this chapter ((that was incurred during a previous registration under this chapter)) or the applicant owes the department money for penalties assessed or fees due under this chapter as a result of a final judgment; (ii) the applicant was a principal or officer of a partnership, corporation, or other entity that either has an unsatisfied final judgment against it in an action that was incurred for work performed subject to this chapter or owes the department money for penalties assessed or fees due under this chapter as a result of a final judgment; or (iii) the applicant does not have a valid unified business identifier number, if required by the department of revenue.
 - (b) The department shall suspend an active registration if (i) the department has notice that the registrant is a sole proprietor or a principal or officer of a registered contractor that has an unsatisfied

- final judgment against it for work within the scope of this chapter; or

 the applicant does not maintain a valid unified business

 identifier number, if required by the department of revenue.
- 4 (4) The department shall not deny an application or suspend a
 5 registration because of an unsatisfied final judgment if the
 6 applicant's or registrant's unsatisfied final judgment was determined
 7 by the director to be the result of the fraud or negligence of another
 8 party.
- 9 **Sec. 3.** RCW 18.27.040 and 1997 c 314 s 5 are each amended to read 10 as follows:
- (1) Each applicant shall file with the department a surety bond 11 12 issued by a surety insurer who meets the requirements of chapter 48.28 13 RCW in the sum of ((six)) twelve thousand dollars if the applicant is a general contractor and ((four)) six thousand dollars if the applicant 14 is a specialty contractor. If no valid bond is already on file with 15 16 the department at the time the application is filed, a bond must accompany the registration application. The bond shall have the state 17 18 of Washington named as obligee with good and sufficient surety in a form to be approved by the department. The bond shall be continuous 19 and may be canceled by the surety upon the surety giving written notice 20 to the director ((of its intent to cancel the bond)). A cancellation 21 or revocation of the bond or withdrawal of the surety from the bond 22 23 automatically suspends the registration issued to the registrant until 24 a new bond or reinstatement notice has been filed and approved as 25 provided in this section. The bond shall be conditioned that the applicant will pay all persons performing labor, including employee 26 benefits, for the contractor, will pay all taxes and contributions due 27 to the state of Washington, and will pay all persons furnishing labor 28 29 or material or renting or supplying equipment to the contractor and 30 will pay all amounts that may be adjudged against the contractor by reason of breach of contract including negligent or improper work in 31 the conduct of the contracting business. A change in the name of a 32 33 business or a change in the type of business entity shall not impair a 34 bond for the purposes of this section so long as one of the original applicants for such bond maintains partial ownership in the business 35 36 covered by the bond.
- 37 (2) ((Any contractor registered as of July 1, 1997, who maintains 38 such registration in accordance with this chapter shall be in

compliance with this chapter until the next annual renewal of the 1 contractor's certificate of registration. At that time)) At the time 2 of initial registration or renewal, the contractor shall provide a 3 4 bond((, cash deposit,)) or other security deposit as required by this 5 chapter and comply with all of the other provisions of this chapter before the department shall issue or renew the contractor's certificate 6 7 Any contractor registered as of July 1, 2001, who of registration. 8 maintains that registration in accordance with this chapter is in 9 compliance with this chapter until the next renewal of the contractor's 10 certificate of registration.

(3) Any person, firm, or corporation having a claim against the contractor for any of the items referred to in this section may bring suit upon the bond or deposit in the superior court of the county in which the work was done or of any county in which jurisdiction of the contractor may be had. The surety issuing the bond shall be named as a party to any suit upon the bond. Action upon the bond or deposit ((shall be commenced by filing the summons and complaint with the clerk of the appropriate superior court within one year from the date of expiration of the certificate of registration in force at the time)) brought by a residential homeowner for breach of contract by a party to the construction contract shall be commenced by filing the summons and complaint with the clerk of the appropriate superior court within two years from the date the claimed contract work was substantially completed or abandoned. Action upon the bond or deposit brought by any other authorized party shall be commenced by filing the summons and complaint with the clerk of the appropriate superior court within one year from the date the claimed labor was performed and benefits accrued, taxes and contributions owing the state of Washington became due, materials and equipment were furnished, or the claimed contract work was substantially completed or abandoned. Service of process in an action against the contractor, the contractor's bond, or the deposit shall be exclusively by service upon the department. Three copies of the summons and complaint and a fee ((of ten)) adopted by rule of not <u>less than twenty</u> dollars to cover the ((handling)) costs shall be served by registered or certified mail, or other delivery service requiring notice of receipt, upon the department at the time suit is started and the department shall maintain a record, available for public inspection, of all suits so commenced. Service is not complete until the department receives the ((ten-dollar)) fee and three copies

- of the summons and complaint. The service shall constitute service on the registrant and the surety for suit upon the bond or deposit and the department shall transmit the summons and complaint or a copy thereof to the registrant at the address listed in the registrant's application and to the surety within ((forty-eight hours)) two days after it shall have been received.
- 7 (4) The surety upon the bond shall not be liable in an aggregate 8 amount in excess of the amount named in the bond nor for any monetary 9 penalty assessed pursuant to this chapter for an infraction. 10 liability of the surety shall not cumulate where the bond has been renewed, continued, reinstated, reissued or otherwise extended. 11 surety upon the bond may, upon notice to the department and the 12 parties, tender to the clerk of the court having jurisdiction of the 13 action an amount equal to the claims thereunder or the amount of the 14 15 bond less the amount of judgments, if any, previously satisfied 16 therefrom and to the extent of such tender the surety upon the bond 17 shall be exonerated but if the actions commenced and pending at any one time exceed the amount of the bond then unimpaired, claims shall be 18 19 satisfied from the bond in the following order:
- 20 (a) Employee labor and claims of laborers, including employee 21 benefits;
- (b) Claims for breach of contract by a party to the construction contract;
 - (c) Registered or licensed subcontractors, material, and equipment;
 - (d) Taxes and contributions due the state of Washington;

- (e) Any court costs, interest, and attorney's fees plaintiff may be entitled to recover. The surety is not liable for any amount in excess of the penal limit of its bond.
- A payment made by the surety in good faith exonerates the bond to 30 the extent of any payment made by the surety.
- 31 (5) The total amount paid from a bond or deposit required of a
 32 general contractor by this section to claimants other than residential
 33 homeowners must not exceed one-half of the bond amount. The total
 34 amount paid from a bond or deposit required of a specialty contractor
 35 by this section to claimants other than residential homeowners must not
 36 exceed one-half of the bond amount or four thousand dollars, whichever
 37 is greater.
- 38 <u>(6) The prevailing party in an action filed under this section</u> 39 against the contractor and contractor's bond or deposit, for breach of

- 1 contract by a party to a construction contract, is entitled to costs,
- 2 interest, and reasonable attorneys' fees. The surety upon the bond is
- 3 <u>not liable in an aggregate amount in excess of the amount named in the</u>
- 4 bond nor for any monetary penalty assessed pursuant to this chapter for
- 5 an infraction.
- 6 (7) If a final judgment impairs the liability of the surety upon
- 7 the bond so furnished that there ((shall not be)) is not in effect a
- 8 bond ((undertaking)) in the full amount prescribed in this section,
- 9 ((the department shall suspend)) the registration of the contractor <u>is</u>
- 10 <u>automatically suspended</u> until the bond liability in the required amount
- 11 unimpaired by unsatisfied judgment claims is furnished. ((If the bond
- 12 becomes fully impaired, a new bond must be furnished at the rates
- 13 prescribed by this section.
- 14 (6))) (8) In lieu of the surety bond required by this section the
- 15 contractor may file with the department a deposit consisting of cash or
- 16 other security acceptable to the department.
- 17 $((\frac{7}{1}))$ Any person having filed and served a summons and

complaint as required by this section having an unsatisfied final

- 19 judgment against the registrant for any items referred to in this
- 20 section may execute upon the security held by the department by serving
- 21 a certified copy of the unsatisfied final judgment by registered or
- 22 certified mail upon the department within one year of the date of entry
- 23 of such judgment. Upon the receipt of service of such certified copy
- 24 the department shall pay or order paid from the deposit, through the
- 25 registry of the superior court which rendered judgment, towards the

- 28 department shall have no liability for payment in excess of the amount

- 3 (1) At the time of registration and subsequent reregistration, the 4 applicant shall furnish insurance or financial responsibility in the 5 form of an assigned account in the amount of ((twenty)) fifty thousand dollars for injury or damages to property, and ((fifty)) one hundred 6 7 thousand dollars for injury or damage including death to any one person, and ((one)) two hundred thousand dollars for injury or damage 8 9 including death to more than one person ((or financial responsibility 10 to satisfy these amounts)).
- (2) ((Failure to maintain insurance or financial responsibility 11 12 relative to the contractor's activities shall be cause to suspend or 13 deny the contractor his or her or their registration.)) An expiration, cancellation, or revocation of the insurance policy or withdrawal of 14 the insurer from the insurance policy automatically suspends the 15 registration issued to the registrant until a new insurance policy or 16 reinstatement notice has been filed and approved as provided in this 17 18 section.

The assigned account shall be held by the department to satisfy any execution on a judgment issued against the contractor for damage to property or injury or death to any person occurring in the contractor's contracting operations, according to the provisions of the assigned account agreement. The department shall have no liability for payment in excess of the amount of the assigned account.
- (b) The assigned account filed with the director as proof of financial responsibility shall be canceled at the expiration of three years after:
- 31 (i) The contractor's registration has expired or been revoked; or
- (ii) The contractor has furnished proof of insurance as required by subsection (1) of this section;
- 34 if, in either case, no legal action has been instituted against the 35 contractor or on the account at the expiration of the three-year

If a final decision of a court in favor 25 of the department is not appealed within the time allowed by law, then the amount of the unappealed assessment, or such amount of the 26 27 assessment as is found due by the final decision of the court, is
- 29 (3) The director or the director's designee may file with the clerk of any county within the state, a warrant in the amount of the notice 30 of assessment, plus interest, penalties, and a filing fee of twenty 31 32 The clerk of the county in which the warrant is filed shall immediately designate a superior court cause number for the warrant, 33 34 and the clerk shall cause to be entered in the judgment docket under the superior court cause number assigned to the warrant, the name of 35 36 the unregistered contractor mentioned in the warrant, the amount of payment, penalty, fine due on it, or filing fee, and the date when the 37 38 warrant was filed. The aggregate amount of the warrant as docketed

shall become a lien upon the title to, and interest in, all real and 1 2 personal property of the unregistered contractor against whom the warrant is issued, the same as a judgment in a civil case docketed in 3 4 the office of the clerk. The sheriff shall proceed upon the warrant in 5 all respects and with like effect as prescribed by law with respect to execution or other process issued against rights or property upon 6 7 judgment in a court of competent jurisdiction. The warrant so docketed 8 is sufficient to support the issuance of writs of garnishment in favor 9 of the state in a manner provided by law in case of judgment, wholly or partially unsatisfied. The clerk of the court is entitled to a filing 10 fee which will be added to the amount of the warrant. A copy of the 11 warrant shall be mailed to the unregistered contractor within three 12 13 days of filing with the clerk.

(4) The director or the director's designee may issue to any person, firm, corporation, other entity, municipal corporation, political subdivision of the state, a public corporation, or any agency of the state, a notice and order to withhold and deliver property of any kind whatsoever when he or she has reason to believe that there is in the possession of the person, firm, corporation, other entity, municipal corporation, political subdivision of the state, public corporation, or agency of the state, property that is or will become due, owing, or belonging to an unregistered contractor upon whom a notice of assessment has been served by the department for payments, penalties, or fines due to the department. The effect of a notice and order is continuous from the date the notice and order is first made until the liability out of which the notice and order arose is satisfied or becomes unenforceable because of lapse of time. department shall release the notice and order when the liability out of which the notice and order arose is satisfied or becomes unenforceable by reason of lapse of time and shall notify the person against whom the notice and order was made that the notice and order has been released.

The notice and order to withhold and deliver must be served by the sheriff of the county or by the sheriff's deputy, by certified mail, return receipt requested, or by an authorized representative of the director.
