- (4) In addition to any other costs that may be imposed by the court, the court shall require a defendant to reimburse the actual costs incurred by a law enforcement agency or emergency personnel, as a result of responding to the traffic disruption prohibited under this section.

- In line 1 of the title, after "pedestrians;" strike the remainder of the title and insert "amending RCW 46.63.020; adding a new section to chapter 46.61 RCW; and prescribing penalties."
 - <u>EFFECT:</u> Requires that the traffic disruption be unlawful as well as intentional for criminal penalties to apply.

Requires courts to require defendants to reimburse law enforcement and EMS personnel to recover costs incurred as a result of responding to the disrupted traffic.
