Brief Summary of Bill

 Distribution of samples of tobacco products to members of the public is prohibited.

Background:

A marketing technique used by cigarette makers is the distribution of free samples. The business of sampling is regulated by the Liquor Control Board. Upon payment of an annual fee, a sampler may distribute tobacco samples in authorized areas. These areas include: areas where children under the age of 18 are denied admission; in a store or concession to which a retailer's license has been issued; or at or adjacent to a production,

repair, or outdoor construction site or facility. Samplers are prohibited from distributing samples within 500 feet of a playground, school, or other facility being used primarily by persons under 18 years of age.

Summary of Bill:

Distribution of samples of tobacco products to members of the public is prohibited. Various provisions of the laws regulating this practice are deleted or repealed.

Appropriation: None.

Fiscal Note: Not Requested.

Effective Date: The bill takes effect 90 days after adjournment of session in which bill is passed.

Testimony For: Providing free tobacco samples to the public results in addiction and greater health care costs. This practice should be banned.
