1 AN ACT Relating to trafficking persons; reenacting and amending RCW  
2 9.94A.515 and 9.94A.515; adding new sections to chapter 9A.40 RCW;  
3 prescribing penalties; providing an effective date; and providing an  
4 expiration date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** A new section is added to chapter 9A.40 RCW  
7 to read as follows:

8 (1) A person is guilty of sex trafficking in the first degree when  
9 such person knowingly (a) in or affecting interstate commerce,  
10 recruits, entices, harbors, transports, provides, or obtains by any  
11 means another person under the age of fourteen; or (b) benefits,  
12 financially or by receiving anything of value, from participation in a  
13 venture which has engaged in an act described in (a) of this  
14 subsection,  
15 knowing that force, fraud, or coercion will be used to cause such  
16 person to engage in a commercial sex act.

17 (2) A person is guilty of sex trafficking in the second degree when  
18 such person knowingly (a) in or affecting interstate commerce,  
19 recruits, entices, harbors, transports, provides, or obtains by any

1 means another person who is at least fourteen years old but less than  
2 eighteen years old; or (b) benefits, financially or by receiving  
3 anything of value, from participation in a venture which has engaged in  
4 an act described in (a) of this subsection,  
5 knowing that force, fraud, or coercion will be used to cause such  
6 person to engage in a commercial sex act.

7 (3) As used in this section:

8 (a) "Commercial sex act" means any sex act, on account of which  
9 anything of value is given to or received by any person.

10 (b) "Venture" means any group of two or more individuals associated  
11 in fact, whether or not a legal entity.

12 (4) Sex trafficking in the first and second degree is a class A  
13 felony.

14 NEW SECTION. **Sec. 2.** A new section is added to chapter 9A.40 RCW  
15 to read as follows:

16 (1) A person is guilty of trafficking in the second degree when  
17 such person knowingly (a) recruits, harbors, transports, provides, or  
18 obtains by any means, another person; or (b) benefits, financially or  
19 by receiving anything of value, from participation in a venture which  
20 has engaged in an act described in (a) of this subsection,  
21 knowing that force, fraud, or coercion will be used to cause such  
22 person to engage in forced labor, services, peonage, or involuntary  
23 servitude.

24 (2) A person is guilty of trafficking in the first degree if in the  
25 process of violating subsection (1) of this section the offense: (a)  
26 Results in death; (b) involves committing or attempting to commit  
27 kidnapping; or (c) involved a finding of sexual motivation as defined  
28 under RCW 9.94A.030.

29 (3) Trafficking in the first and second degree is a class A felony.
