- AN ACT Relating to certificates of approval for authorized representatives of beer and wine manufacturers and distributors; and amending RCW 66.04.010, 66.24.206, 66.24.270, 66.28.010, 66.28.030, 66.28.040, 66.28.042, 66.28.043, 66.28.150, 66.28.155, 66.28.160,
- 5 66.28.170, 66.28.180, and 19.126.020.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 **Sec. 1.** RCW 66.04.010 and 2000 c 142 s 1 are each amended to read 8 as follows:
- 9 In this title, unless the context otherwise requires:
- 10 (1) "Alcohol" is that substance known as ethyl alcohol, hydrated oxide of ethyl, or spirit of wine, which is commonly produced by the 11 fermentation or distillation of grain, starch, molasses, or sugar, or 12 13 substances including all dilutions and mixtures of this The term "alcohol" does not include alcohol in the 14 15 possession of a manufacturer or distiller of alcohol fuel, as described in RCW 66.12.130, which is intended to be denatured and used as a fuel 16 for use in motor vehicles, farm implements, and machines or implements 17 of husbandry. 18
 - (2) <u>"Authorized representative" means a person who:</u>

1 (a) Is required to have a federal basic permit issued pursuant to 2 the federal alcohol administration act, 27 U.S.C. Sec. 204;

- (b) Has its business located in the United States outside of the state of Washington;
- (c) Acquires ownership of beer or wine for transportation into and resale in the state of Washington; and which beer or wine is produced anywhere outside Washington by a brewery or winery which does not hold a certificate of approval issued by the board; and
- (d) Is appointed by the brewery or winery referenced in (c) of this subsection as its exclusive authorized representative for marketing and selling its products within the United States in accordance with a written agreement between the authorized representative and such brewery or winery pursuant to this title.
- (3) "Beer" means any malt beverage or malt liquor as these terms are defined in this chapter.
- ((+3)) (4) "Beer distributor" means a person who buys beer from a brewer or brewery located either within or beyond the boundaries of the state, beer importers, or foreign produced beer from a source outside the state of Washington, for the purpose of selling the same pursuant to this title, or who represents such brewer or brewery as agent.
- ((4))) (5) "Beer importer" means a person or business within Washington who purchases beer from a United States brewery holding a certificate of approval (B5) or foreign produced beer from a source outside the state of Washington for the purpose of selling the same pursuant to this title.
- (((5))) <u>(6)</u> "Brewer" <u>or "brewery"</u> means any person engaged in the business of manufacturing beer and malt liquor. Brewer includes a brand owner of malt beverages who holds a brewer's notice with the federal bureau of alcohol, tobacco, and firearms at a location outside the state and whose malt beverage is contract-produced by a licensed in-state brewery, and who may exercise within the state, under a domestic brewery license, only the privileges of storing, selling to licensed beer distributors, and exporting beer from the state.
- ((+6))) (7) "Board" means the liquor control board, constituted under this title.
- 36 (((7))) <u>(8)</u> "Club" means an organization of persons, incorporated 37 or unincorporated, operated solely for fraternal, benevolent, 38 educational, athletic or social purposes, and not for pecuniary gain.

 $((\frac{8}{}))$ "Consume" includes the putting of liquor to any use, 2 whether by drinking or otherwise.

- $((\frac{9}{}))$ <u>(10)</u> "Dentist" means a practitioner of dentistry duly and regularly licensed and engaged in the practice of his profession within the state pursuant to chapter 18.32 RCW.
- $((\frac{10}{10}))$ <u>(11)</u> "Distiller" means a person engaged in the business of distilling spirits.
- 8 (((11))) <u>(12)</u> "Domestic brewery" means a place where beer and malt 9 liquor are manufactured or produced by a brewer within the state.
- $((\frac{(12)}{(13)}))$ "Domestic winery" means a place where wines are 11 manufactured or produced within the state of Washington.
 - $((\frac{13}{13}))$ $\underline{(14)}$ "Druggist" means any person who holds a valid certificate and is a registered pharmacist and is duly and regularly engaged in carrying on the business of pharmaceutical chemistry pursuant to chapter 18.64 RCW.
 - $((\frac{14}{1}))$ (15) "Drug store" means a place whose principal business is, the sale of drugs, medicines and pharmaceutical preparations and maintains a regular prescription department and employs a registered pharmacist during all hours the drug store is open.
 - $((\frac{15}{15}))$ (16) "Employee" means any person employed by the board, including a vendor, as hereinafter in this section defined.
 - $((\frac{16}{16}))$ <u>(17)</u> "Fund" means 'liquor revolving fund.'
 - (((17))) (18) "Hotel" means every building or other structure kept, used, maintained, advertised or held out to the public to be a place where food is served and sleeping accommodations are offered for pay to transient guests, in which twenty or more rooms are used for the sleeping accommodation of such transient guests and having one or more dining rooms where meals are served to such transient guests, such sleeping accommodations and dining rooms being conducted in the same building and buildings, in connection therewith, and such structure or structures being provided, in the judgment of the board, with adequate and sanitary kitchen and dining room equipment and capacity, for preparing, cooking and serving suitable food for its guests: PROVIDED FURTHER, That in cities and towns of less than five thousand population, the board shall have authority to waive the provisions requiring twenty or more rooms.
 - $((\frac{18}{18}))$ <u>(19)</u> "Importer" means a person who buys distilled spirits

from a distillery outside the state of Washington and imports such spirituous liquor into the state for sale to the board or for export.

- $((\frac{19}{19}))$ (20) "Imprisonment" means confinement in the county jail.
- 3 $((\frac{20}{20}))$ (21) "Liquor" includes the four varieties of liquor herein 4 5 defined (alcohol, spirits, wine and beer), and all fermented, spirituous, vinous, or malt liquor, or combinations thereof, and mixed 6 7 liquor, a part of which is fermented, spirituous, vinous or malt liquor, or otherwise intoxicating; and every liquid or solid or 8 semisolid or other substance, patented or not, containing alcohol, 9 10 spirits, wine or beer, and all drinks or drinkable liquids and all preparations or mixtures capable of human consumption, and any liquid, 11 12 semisolid, solid, or other substance, which contains more than one 13 percent of alcohol by weight shall be conclusively deemed to be 14 intoxicating. Liquor does not include confections or food products that contain one percent or less of alcohol by weight. 15
- 16 $((\frac{21}{21}))$ (22) "Manufacturer" means a person engaged in the 17 preparation of liquor for sale, in any form whatsoever.
 - $((\frac{22}{2}))$ (23) "Malt beverage" or "malt liquor" means any beverage such as beer, ale, lager beer, stout, and porter obtained by the alcoholic fermentation of an infusion or decoction of pure hops, or pure extract of hops and pure barley malt or other wholesome grain or cereal in pure water containing not more than eight percent of alcohol by weight, and not less than one-half of one percent of alcohol by volume. For the purposes of this title, any such beverage containing more than eight percent of alcohol by weight shall be referred to as "strong beer."
- 27 $((\frac{23}{23}))$ (24) "Package" means any container or receptacle used for holding liquor. 28
- $((\frac{24}{2}))$ (25) "Permit" means a permit for the purchase of liquor 29 30 under this title.
- 31 $((\frac{25}{25}))$ <u>(26)</u> "Person" means an individual, copartnership, 32 association, or corporation.
- $((\frac{26}{1}))$ <u>(27)</u> "Physician" means a medical practitioner duly and 33 34 regularly licensed and engaged in the practice of his profession within 35 the state pursuant to chapter 18.71 RCW.
- $((\frac{27}{1}))$ (28) "Prescription" means a memorandum signed by a 36 37 physician and given by him to a patient for the obtaining of liquor 38 pursuant to this title for medicinal purposes.

 $((\frac{28}{28}))$ "Public place" includes streets and alleys of incorporated cities and towns; state or county or township highways or roads; buildings and grounds used for school purposes; public dance halls and grounds adjacent thereto; those parts of establishments where beer may be sold under this title, soft drink establishments, public buildings, public meeting halls, lobbies, halls and dining rooms of hotels, restaurants, theatres, stores, garages and filling stations which are open to and are generally used by the public and to which the public is permitted to have unrestricted access; railroad trains, stages, and other public conveyances of all kinds and character, and the depots and waiting rooms used in conjunction therewith which are open to unrestricted use and access by the public; publicly owned bathing beaches, parks, and/or playgrounds; and all other places of like or similar nature to which the general public has unrestricted right of access, and which are generally used by the public.

 $((\frac{29}{10}))$ "Regulations" means regulations made by the board under the powers conferred by this title.

(((30))) (31) "Restaurant" means any establishment provided with special space and accommodations where, in consideration of payment, food, without lodgings, is habitually furnished to the public, not including drug stores and soda fountains.

((\(\frac{31}\))) (32) "Sale" and "sell" include exchange, barter, and traffic; and also include the selling or supplying or distributing, by any means whatsoever, of liquor, or of any liquid known or described as beer or by any name whatever commonly used to describe malt or brewed liquor or of wine, by any person to any person; and also include a sale or selling within the state to a foreign consignee or his agent in the state. "Sale" and "sell" shall not include the giving, at no charge, of a reasonable amount of liquor by a person not licensed by the board to a person not licensed by the board, for personal use only. "Sale" and "sell" also does not include a raffle authorized under RCW 9.46.0315: PROVIDED, That the nonprofit organization conducting the raffle has obtained the appropriate permit from the board.

 $((\frac{32}{32}))$ "Soda fountain" means a place especially equipped with apparatus for the purpose of dispensing soft drinks, whether mixed or otherwise.

(((33))) (34) "Spirits" means any beverage which contains alcohol

obtained by distillation, including wines exceeding twenty-four percent of alcohol by volume.

- (((35))) (36) "Tavern" means any establishment with special space and accommodation for sale by the glass and for consumption on the premises, of beer, as herein defined.
- 8 $((\frac{36}{36}))$ "Vendor" means a person employed by the board as a store manager under this title.
- 10 (((37))) (38) "Winery" means a business conducted by any person for the manufacture of wine for sale, other than a domestic winery.
 - (((38))) (39) "Wine" means any alcoholic beverage obtained by fermentation of fruits (grapes, berries, apples, et cetera) or other agricultural product containing sugar, to which any saccharine substances may have been added before, during or after fermentation, and containing not more than twenty-four percent of alcohol by volume, including sweet wines fortified with wine spirits, such as port, sherry, muscatel and angelica, not exceeding twenty-four percent of alcohol by volume and not less than one-half of one percent of alcohol by volume. For purposes of this title, any beverage containing no more than fourteen percent of alcohol by volume when bottled or packaged by the manufacturer shall be referred to as "table wine," and any beverage containing alcohol in an amount more than fourteen percent by volume when bottled or packaged by the manufacturer shall be referred to as "fortified wine." However, "fortified wine" shall not include: (a) Wines that are both sealed or capped by cork closure and aged two years or more; and (b) wines that contain more than fourteen percent alcohol by volume solely as a result of the natural fermentation process and that have not been produced with the addition of wine spirits, brandy, or alcohol.
 - This subsection shall not be interpreted to require that any wine be labeled with the designation "table wine" or "fortified wine."
 - (((39))) (40) "Wine distributor" means a person who buys wine from a vintner or winery located either within or beyond the boundaries of the state for the purpose of selling the same not in violation of this title, or who represents such vintner or winery as agent.
- (((40))) (41) "Wine importer" means a person or business within Washington who purchases wine from a United States winery holding a

certificate of approval (W7) or foreign produced wine from a source outside the state of Washington for the purpose of selling the same

3 pursuant to this title.

Sec. 2. RCW 66.24.206 and 1997 c 321 s 7 are each amended to read as follows:

- (1)(a) A United States winery or manufacturer of wine((τ)) located outside the state of Washington((τ)) must hold a certificate of approval (((W7))) to allow sales and shipment of the certificate of approval holder's wine to licensed Washington wine distributors or importers.
- 11 (b) Authorized representatives must hold a certificate of approval 12 to allow sales and shipment of United States produced wine to licensed 13 Washington wine distributors or importers.
 - (c) Authorized representatives must also hold a certificate of approval to allow sales and shipments of foreign produced wine to licensed Washington wine distributors or importers.
 - (2) The certificate of approval shall not be granted unless and until such winery or manufacturer of wine or authorized representative shall have made a written agreement with the board to furnish to the board, on or before the twentieth day of each month, a report under oath, on a form to be prescribed by the board, showing the quantity of wine sold or delivered to each licensed wine distributor or importer, during the preceding month, and shall further have agreed with the board, that such wineries ((or)), manufacturers, or authorized representatives, and all general sales corporations or agencies maintained by them, and all of their trade representatives, shall and will faithfully comply with all laws of the state of Washington pertaining to the sale of intoxicating liquors and all rules and regulations of the Washington state liquor control board. A violation of the terms of this agreement will cause the board to take action to suspend or revoke such certificate.
 - (3) The fee for the certificate of approval, issued pursuant to the provisions of this title, shall be one hundred dollars per year, per each privilege outlined in subsection (1)(a), (b), and (c) of this section, which sum shall accompany the application for such certificate.

- (1) Every person, firm or corporation, holding a license to manufacture malt liquors or strong beer within the state of Washington, shall, on or before the twentieth day of each month, furnish to the Washington state liquor control board, on a form to be prescribed by the board, a statement showing the quantity of malt liquors and strong beer sold for resale during the preceding calendar month to each beer distributor within the state of Washington.
- (2) (a) A United States brewery or manufacturer of beer or strong beer, located outside the state of Washington, must hold a certificate of approval ((B5)) to allow sales and shipment of the certificate of approval holder's beer or strong beer to licensed Washington beer distributors or importers.
- (b) Authorized representatives must hold a certificate of approval to allow sales and shipment of United States produced beer or strong beer to licensed Washington beer distributors or importers.
 - (c) Authorized representatives must also hold a certificate of approval to allow sales and shipments of foreign produced beer or strong beer to licensed Washington beer distributors or importers.
- (3) The certificate of approval shall not be granted unless and until such brewer or manufacturer of beer or strong beer or authorized representative shall have made a written agreement with the board to furnish to the board, on or before the twentieth day of each month, a report under oath, on a form to be prescribed by the board, showing the quantity of beer and strong beer sold or delivered to each licensed beer distributor or importer during the preceding month, and shall further have agreed with the board, that such brewer or manufacturer of beer or strong beer or authorized representative and all general sales corporations or agencies maintained by them, and all of their trade representatives, corporations, and agencies, shall and will faithfully comply with all laws of the state of Washington pertaining to the sale of intoxicating liquors and all rules and regulations of the Washington state liquor control board. A violation of the terms of this agreement will cause the board to take action to suspend or revoke such certificate.
- $((\frac{3}{3}))$ ($(\frac{4}{3})$) The fee for the certificate of approval, issued pursuant to the provisions of this title, shall be one hundred dollars

- 4 **Sec. 4.** RCW 66.28.010 and 2002 c 109 s 1 are each amended to read 5 as follows:
 - (1)(a) No manufacturer, importer, ((or)) distributor, or authorized representative, or person financially interested, directly indirectly, in such business; whether resident or nonresident, shall have any financial interest, direct or indirect, in any licensed retail business, unless the retail business is owned by a corporation in which a manufacturer or importer has no direct stock ownership and there are no interlocking officers and directors, the retail license is held by a corporation that is not owned directly or indirectly by a manufacturer or importer, the sales of liquor are incidental to the primary activity of operating the property as a hotel, alcoholic beverages produced by the manufacturer or importer or subsidiaries are not sold at the licensed premises, and the board reviews the ownership and proposed method of operation of all involved entities and determines that there will not be an unacceptable level of control or undue influence over the operation or the retail licensee; nor shall any manufacturer, importer, ((or)) distributor, or authorized representative own any of the property upon which such licensed persons conduct their business; nor shall any such licensed person, under any arrangement whatsoever, conduct his or her business upon property in which any manufacturer, importer, ((or)) distributor, or authorized representative has any interest unless title to that property is owned by a corporation in which a manufacturer has no direct stock ownership and there are no interlocking officers or directors, the retail license is held by a corporation that is not owned directly or indirectly by the manufacturer, the sales of liquor are incidental to the primary activity of operating the property either as a hotel or as an amphitheater offering live musical and similar live entertainment activities to the public, alcoholic beverages produced by the manufacturer or any of its subsidiaries are not sold at the licensed premises, and the board reviews the ownership and proposed method of operation of all involved entities and determines that there will not be an unacceptable level of control or undue influence over the

operation of the retail licensee. Except as provided in subsection (3) 1 2 of this section, no manufacturer, importer, ((or)) distributor, or authorized representative shall advance moneys or moneys' worth to a 3 licensed person under an arrangement, nor shall such licensed person 4 receive, under an arrangement, an advance of moneys or moneys' worth. 5 "Person" as used in this section only shall not include those state or 6 7 federally chartered banks, state or federally chartered savings and loan associations, state or federally chartered mutual savings banks, 8 or institutional investors which are not controlled directly or 9 indirectly by a manufacturer, importer, ((or)) distributor, or 10 authorized representative as long as the bank, savings and loan 11 12 association, or institutional investor does not influence or attempt to 13 influence the purchasing practices of the retailer with respect to 14 alcoholic beverages. Except as otherwise provided in this section, no importer, ((or)) distributor, or authorized 15 manufacturer, representative shall be eligible to receive or hold a retail license 16 17 under this title, nor shall such manufacturer, importer, ((or)) distributor, or authorized representative sell at retail any liquor as 18 herein defined. A corporation granted an exemption under this 19 subsection may use debt instruments issued in connection with financing 20 21 construction or operations of its facilities.

- (b) Nothing in this section shall prohibit a licensed domestic brewery or microbrewery from being licensed as a retailer pursuant to chapter 66.24 RCW for the purpose of selling beer or wine at retail on the brewery premises and nothing in this section shall prohibit a domestic winery from being licensed as a retailer pursuant to chapter 66.24 RCW for the purpose of selling beer or wine at retail on the winery premises. Such beer and wine so sold at retail shall be subject to the taxes imposed by RCW 66.24.290 and 66.24.210 and to reporting and bonding requirements as prescribed by regulations adopted by the board pursuant to chapter 34.05 RCW, and beer and wine that is not produced by the brewery or winery shall be purchased from a licensed beer or wine distributor.
- (c) Nothing in this section shall prohibit a licensed distiller, domestic brewery, microbrewery, domestic winery, or a lessee of a licensed domestic brewer, microbrewery, or domestic winery, from being licensed as a spirits, beer, and wine restaurant pursuant to chapter 66.24 RCW for the purpose of selling liquor at a spirits, beer, and

wine restaurant premises on the property on which the primary manufacturing facility of the licensed distiller, domestic brewer, microbrewery, or domestic winery is located or on contiguous property owned or leased by the licensed distiller, domestic brewer, microbrewery, or domestic winery as prescribed by rules adopted by the board pursuant to chapter 34.05 RCW.

- (2) Financial interest, direct or indirect, as used in this section, shall include any interest, whether by stock ownership, mortgage, lien, or through interlocking directors, or otherwise. Pursuant to rules promulgated by the board in accordance with chapter 34.05 RCW manufacturers, distributors, and importers may perform, and retailers may accept the service of building, rotating and restocking case displays and stock room inventories; rotating and rearranging can and bottle displays of their own products; provide point of sale material and brand signs; price case goods of their own brands; and perform such similar normal business services as the board may by regulation prescribe.
- (3)(a) This section does not prohibit a manufacturer, importer, or distributor from providing services to a special occasion licensee for:
 (i) Installation of draft beer dispensing equipment or advertising,
 (ii) advertising, pouring, or dispensing of beer or wine at a beer or wine tasting exhibition or judging event, or (iii) a special occasion licensee from receiving any such services as may be provided by a manufacturer, importer, or distributor. Nothing in this section shall prohibit a retail licensee, or any person financially interested, directly or indirectly, in such a retail licensee from having a financial interest, direct or indirect, in a business which provides, for a compensation commensurate in value to the services provided, bottling, canning or other services to a manufacturer, so long as the retail licensee or person interested therein has no direct financial interest in or control of said manufacturer.
- (b) A person holding contractual rights to payment from selling a liquor distributor's business and transferring the license shall not be deemed to have a financial interest under this section if the person (i) lacks any ownership in or control of the distributor, (ii) is not employed by the distributor, and (iii) does not influence or attempt to influence liquor purchases by retail liquor licensees from the distributor.

- (3) Beer and wine suppliers' price filings, contracts, and memoranda.
- (a) Every <u>domestic</u> brewery, <u>microbrewery</u>, and <u>domestic</u> winery offering beer and/or wine for sale within the state shall file with the board at its office in Olympia a copy of every written contract and a memorandum of every oral agreement which such brewery or winery may have with any beer or wine distributor, which contracts or memoranda shall contain a schedule of prices charged to distributors for all items and all terms of sale, including all regular and special discounts; all advertising, sales and trade allowances, and incentive programs; and all commissions, bonuses or gifts, and any and all other discounts or allowances. Whenever changed or modified, such revised contracts or memoranda shall forthwith be filed with the board as provided for by rule. The provisions of this section also apply to certificate of approval holders, beer and/or wine importers, and beer and/or wine distributors.

Each price schedule shall be made on a form prepared and furnished by the board, or a reasonable facsimile thereof, and shall set forth all brands, types, packages, and containers of beer or wine offered for sale by such licensed brewery or winery; all additional information required may be filed as a supplement to the price schedule forms.

(b) Prices filed by a <u>domestic</u> brewery ((or)), <u>microbrewery</u>, domestic winery, or certificate of approval holder shall be uniform prices to all distributors on a statewide basis less bona fide allowances for freight differentials. Quantity discounts price shall filed prohibited. No be that is acquisition/production cost plus ten percent of that cost, except that acquisition cost plus ten percent of acquisition cost does not apply to sales of beer or wine between a beer or wine importer who sells beer or wine to another beer or wine importer or to a beer or wine distributor, or to a beer or wine distributor who sells beer or wine to another beer or wine distributor. - (3) "Supplier" means any malt beverage manufacturer or importer who enters into or is a party to any agreement of distributorship with a wholesale distributor. "Supplier" does not include: (a) Any domestic ((brewer)) brewery or ((microbrewer)) microbrewery licensed under RCW 66.24.240 and producing less than fifty thousand barrels of malt liquor annually; ((or)) (b) any brewer or manufacturer of malt liquor producing less than fifty thousand barrels of malt liquor annually and holding a certificate of approval issued under RCW 66.24.270; or (c) any authorized representative of malt liquor manufacturers who holds an appointment from one or more malt liquor manufacturers which, in the aggregate, produce less than fifty thousand barrels of malt liquor.
- (4) "Malt beverage manufacturer" means every brewer, fermenter, processor, bottler, or packager of malt beverages located within or outside this state, or any other person, whether located within or outside this state, who enters into an agreement of distributorship for the resale of malt beverages in this state with any wholesale distributor doing business in the state of Washington.
- (5) "Importer" means any distributor importing beer into this state for sale to retailer accounts or for sale to other ((wholesalers)) distributors designated as "subjobbers" for resale.
- (6) "Authorized representative" has the same meaning as "authorized representative" as defined in RCW 66.04.010.
 - (7) "Person" means any natural person, corporation, partnership,
