## SENATE BILL 5359

State of Washington 58th Legislature 2003 Regular Session

AN ACT Relating to establishing the Washington state economic development commission to replace the governor's small business improvement council; adding a new section to chapter 43.175 RCW; and repealing RCW 43.175.010, 43.175.020, and 43.175.901.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 43.175 RCW 7 to read as follows:

8 (1) The Washington state economic development commission is 9 established to oversee the economic development strategies and policies 10 of the department of community, trade, and economic development.

(2) The Washington state economic development commission shall 11 12 consist of at least nine and no more than fifteen members appointed by 13 the governor, subject to confirmation of the senate. The governor 14 shall select the chair. The members serve at the pleasure of the 15 governor for four-year terms. The members shall represent the broad 16 geographic diversity of the state and reflect the state's various 17 business and labor sectors. Members of the commission shall serve statewide interests while preserving their diverse perspectives, and 18

shall be recognized leaders in their fields with demonstrated
experience in disciplines related to economic development.

3 (3) The Washington state economic development commission shall4 perform the following duties:

5 (a) Review and periodically update the state's economic development 6 strategy and performance measures, and perform an annual evaluation of 7 the strategy;

8 (b) Provide policy advice to the department of community, trade,9 and economic development;

10 (c) Assist the department of community, trade, and economic 11 development with the procurement and deployment of private funds for 12 business development, recruitment, and promotion; and

13 (d) Provide planning and strategic and programmatic guidance to the 14 department of community, trade, and economic development, with specific 15 emphasis on the following:

(i) Development of strategies that promote business retention,expansion, and creation within the state;

18 (ii) Development of marketing strategies for the global marketplace 19 that promote products and services of the state; and

(iii) Development of strategies to enhance relationships and
cooperation between local governments, economic development councils,
state agencies, and the legislature.

(4) Members of the Washington state economic development commission
shall be reimbursed for travel expenses as provided in RCW 43.03.050
and 43.03.060.

(5) Staffing for the Washington state economic development commission shall be provided by the department of community, trade, and economic development or other state agencies as appropriate, and within existing resources and operations.

30 (6) Creation of the Washington state economic development 31 commission shall not be construed to modify any authority or budgetary 32 responsibility of the governor or the department of community, trade, 33 and economic development.

34 <u>NEW SECTION.</u> Sec. 2. The following acts or parts of acts are each 35 repealed:
